Titre : Evolution de la diversité génétique dans des populations domestiquées de truites arc-en-ciel **Mots clés :** Aquaculture, domestication, sélection, consanguinité, dominance, variabilité génétique

Résumé : L'amélioration génétique de populations de truites arc-en-ciel a permis d'accroître l'efficacité de la production, mais a contribué à une forte diminution de la variabilité génétique. Cette perte de diversité génétique peut causer de la dépression de consanguinité mais aussi mettre en péril le progrès génétique à long terme et l'adaptation des populations aux changements environnementaux. Les niveaux de consanguinité observés (via des indicateurs génomigues) au sein de nos populations de truites françaises, nous interrogent sur les causes et les impacts de tels niveaux de consanguinité. Ces interrogations font l'objet des travaux de thèse présentés. Au-delà des effets de la sélection et de la dérive génétique liée à la faible taille des populations en élevage, la perte de diversité génétique au sein des populations de truite arc-en-ciel s'explique aussi par des déséguilibres de contribution des mères à la génération suivante associés à une surmortalité embryonnaire observée de la fécondation à l'éclosion dans les descendances de certaines mères. L'étude des effets locaux de la consanguinité sur les performances de taille, reproduction et survie de la truite, montre que localisée dans certaines parties du génome, la consanguinité peut avoir des effets notables, sans que l'on observe forcément un effet à l'échelle de tout le génome. Si, ces effets locaux peuvent être négatifs, ils sont toutefois

positifs dans certaines zones du génome. Le principal phénomène observé est un impact négatif de la consanguinité récente, expliqué par l'accumulation d'allèles récessifs dont les effets sont défavorables, en lien direct avec l'estimation d'effets de dominance importants sur les caractères de reproduction et de survie. Cependant la consanguinité, en particulier accumulée dans des générations passées, engendre aussi des effets positifs. Ainsi neuf régions d'homozygotie forte ont été identifiées sous sélection positive commune à trois lignées de truites françaises et une population américaine. Les gènes annotés dans ces régions sont liés à la domestication (fonctions de croissance, reproduction, comportement et immunité) ainsi qu'à la fitness naturelle en lien avec la survie des individus (embryogenèse, organisation cellulaire). C'est pourquoi, comprendre l'impact et le rôle de la diversité génétique locale est essentiel, afin de mieux la gérer dans les programmes de sélection. L'utilisation d'indicateurs génomigues de la consanguinité permettra aux sélectionneurs de mieux maîtriser les compromis entre valeurs génétiques des reproducteurs et effets indésirables de la consanguinité de leur progéniture. Cela permettra aussi d'exploiter les effets d'hétérosis, et ainsi améliorer durablement les performances des cheptels de production.

Title : Evolution of genetic diversity in farmed rainbow trout populations **Keywords :** Aquaculture, domestication, selection, inbreeding, dominance, genetic variability

Abstract: Genetic improvement of rainbow trout populations has increased production efficiency, but has contributed to a sharp decrease in genetic variability. This loss of genetic diversity may induced inbreeding depression but also compromised long-term genetic progress and population adaptation to environmental changes. The inbreeding levels observed (through genomic indicators) in our French trout populations, question us on the causes and impacts of such inbreeding levels. These questions are the subject of the thesis work presented. In addition to the effects of selection and genetic drift due to the small size of breeding populations, the loss of genetic diversity in rainbow trout populations may also be explained by imbalanced contribution of mothers to the next generation associated with excess of embryonic mortality observed from fertilization to hatching in the offspring of some mothers. The study of the local effects of inbreeding on the size, reproduction and survival performance of trout, shows that localized in certain regions of the genome, inbreeding may have significant effects, without necessarily observing a genome-wide effect. While these local effects may be negative, they may also be positive in some genomic regions. The main

phenomenon observed is a negative impact of recent inbreeding, explained by the accumulation of recessive alleles with unfavorable effects, directly related to the estimation of important dominance effects on reproduction and survival traits. However, inbreeding, especially accumulated in past generations, also generates positive effects. Thus, nine regions of strong homozygosity have been identified under positive selection common to three French trout lines and one American population. Genes annotated in these regions are related to domestication (growth, reproduction, behavior and immunity functions) as well as to natural fitness related to individual survival (embryogenesis, cell organization). Therefore, understanding the impact and role of local genetic diversity is essential in order to better manage it in breeding programs. The use of genomic indicators of inbreeding will allow breeders to better control the trade-offs between genetic values of the breeding stock and the undesirable effects of inbreeding on their progeny. This will also allow to exploit heterosis effects, and thus improve the performance of production stocks in a sustainable way.

Chapitre 1

Introduction Générale

1.1. Les populations de truite arc-en-ciel sauvages et domestiquées 1.1.1. Intérêt pour l'étude de la truite arc-en-ciel

La truite arc-en-ciel (TAC), *Oncorhynchus mykiss*, est une espèce d'eau douce, originaire de la péninsule du Kamtchatka en Russie et d'Amérique du Nord (de l'Alaska jusqu'au Mexique ; Guyomard & Vandeputte, 2010). Elle est présente dans la quasi-totalité des cours d'eau nord-américains (Okazaki, 1984 ; Smith & Stearley, 1989). Selon la localisation des rivières et les conditions environnementales rencontrées (distance à la mer, présence d'obstacles à la migration ou de lacs à l'intérieur d'un bassin versant), les populations de TAC peuvent être de forme résidente des lacs et des cours d'eau ou de forme anadrome (allant à la mer) (McPhail, 2007), voire constituées d'une proportion variable d'individus anadromes (Kendall et al., 2015). La TAC est actuellement élevée dans tous les continents sauf l'Antarctique (Figure 1). La truite arc-en-ciel fait partie des quinze espèces de poissons qui dominent la production mondiale piscicole continentale, marine et côtière (FAO, 2022). De plus, la TAC est la principale espèce de poisson élevée en eau douce froide dans le monde avec 739 500 tonnes produites en 2020 (en eau douce) (FAO, 2022). La production de TAC peut également se faire dans des élevages en mer, mais 77% de la production mondiale totale de TAC en 2020 (959 600 tonnes) provenait d'élevages continentaux en eau douce (FAO, 2022).

La France se classe 8^{ème} parmi les principaux pays producteurs de TAC (élevage en eau douce et/ou en mer), le premier étant l'Iran (191 820 tonnes produite en 2020) suivi de la Turquie (144 283 tonnes), de la Norvège (96 131 tonnes), et du Chili (87 724 tonnes) (*https://www.fao.org/fishery/statistics-query/en/aquaculture/aquaculture_quantity*). Alors qu'en Iran, en Turquie ou en France la TAC est principalement élevée en eau douce, en Norvège et au Chili la production de TAC se fait principalement en mer. En France, il s'agit de la principale espèce piscicole élevée, et représente à elle seule 78% de la production (Agreste, 2020 ; FAO, 2022).

La perte de diversité génétique fait partie des nombreux enjeux auxquels l'aquaculture doit faire face, car elle met en péril sa résilience face aux changements globaux (FAO, 2022). Chez la TAC, les premiers programmes de sélection commerciale ne débutèrent que dans les années 1970 en Europe du Nord. En France, ils se sont mis en place au début des années 1990 (Haffray, 2019). Aujourd'hui, quatre entreprises de sélection françaises (les Sources de l'Avance filiale du groupe Aqualande, Milin Nevez filiale de Bretagne Truite, Viviers de Sarrance et Les Fils de Charles Murgat) exportent à travers le monde des œufs et alevins améliorés. La perte de diversité génétique observée dans les populations françaises domestiquées, qu'elles soient des lignées commerciales sélectionnées ou des lignées expérimentales (D'Ambrosio et al., 2019) nous interroge sur les moyens à mettre en œuvre rapidement pour préserver leur diversité génétique et garantir leur adaptation et amélioration génétique à long terme face aux changements globaux.

Par ailleurs, la TAC est un excellent modèle amplement étudié pour conduire de multiples recherches (cancérologie, toxicologie, immunologie, physiologie, nutrition, biologie du développement), en raison de sa facilité d'élevage, sa fécondation externe ainsi que sa grande taille qui facilite notamment l'étude de phases précoces du développement ou certaines opérations chirurgicales (Thorgaard et al., 2002). En génétique, la truite est également intéressante du fait de l'originalité de son génome, et de la possibilité de produire des animaux au génome complètement homozygote (haploïde doublé) ou avec plusieurs jeux de chromosomes (polyploïdes) (Fraslin, 2018). En France, il existe des lignées expérimentales utilisées dans diverses études pour améliorer les connaissances biologiques actuelles, notamment sur les caractères de santé (Fraslin et al., 2018) et d'adaptation (Lagarde et al., 2023) ou bien encore quantifier les différences génétiques associées aux mécanismes épigénétiques (Lallias et al., 2021).

1.1.2. Expansion de la truite arc-en-ciel dans le monde

La truite arc-en-ciel (TAC), *O. mykiss*, appartient à la famille des salmonidés (*Salmonidae*) et à la sous-famille des *Salmoninae*. La sous-famille des *Salmoninae* regroupe trois principaux genres : *Salvelinus* (les ombles), *Salmo* (regroupant les saumons et truites d'Atlantique) et *Oncorhynchus* (regroupant les saumons et les truites du Pacifique). Initialement appelée *Salmo gairdneri*, pour les TAC d'Amérique du Nord, son appellation scientifique a été changée pour *Oncorhynchus mykiss* sur la base d'informations moléculaires (Okazaki, 1984 ; Smith & Stearley, 1989). L'espèce était à l'origine rattachée au genre *Salmo* en raison de sa ressemblance physiologique avec le saumon de l'Atlantique. Or, il a été démontré qu'en réalité la TAC était génétiquement plus proche du saumon du Pacifique que du saumon de l'Atlantique (Guyomard et Vandeputte, 2010).

Les premières traces de domestication de la TAC remontent aux années 1870 au nord de la Californie. Elle aurait été domestiquée à partir de la population sauvage présente dans le bassin de la rivière McCloud (Hershberger, 1992 ; Gall & Crandell, 1992). Les souches de TAC actuellement domestiquées dériveraient principalement de populations prélevées dans ce bassin (Dollar & Katz, 1964 ; Thorgaard, 1983). Dans les années qui suivirent sa domestication, la TAC fut exportée à travers le monde (Teletchea, 2018). Selon Bean (1895), la France a été l'un des premiers pays à l'introduire, via une cargaison expédiée à l'aquarium du Trocadéro à Paris. Cette introduction aurait été suivie par de nombreuses autres, d'origines légèrement différentes (Guyomard et Vandeputte, 2010). Au même moment, des cargaisons d'œufs ont également été expédiées au Japon et en Allemagne (von Behr, 1882 ; Stanković et al., 2015). Ainsi, que dans d'autres pays d'Europe quelques années plus tard à la fin du XIXème siècle (Royaume-Uni, Suisse, Belgique, Italie, Portugal, Irlande) (Baird, 1886 ; Mather, 1886 ; McDonald, 1893 ; Ravenel, 1899). En parallèle, des transferts de TAC intra-Europe ont eu lieu, principalement à partir des écloseries allemandes vers l'Autriche, la Bulgarie, le Danemark, la Pologne, la Suède, la Suisse, la Russie, la Slovaquie, la Slovénie, la République tchèque, etc. (Crawford & Muir, 2008). Des transferts vers d'autres parties du monde ont également rapidement suivi, depuis la Grande-Bretagne vers le Sri Lanka (Jinadasa et al., 2005), la Nouvelle-Zélande (Scott et al., 1978), l'Argentine (Riva Rossi et al., 2004) et la Chine (Zhao et al., 2008). Au début du XXème siècle, de nouveaux transferts de TAC depuis les Etats-Unis eurent lieu vers l'Autriche, les Pays-Bas, la République tchèque, la Slovaquie, la Slovaquie, la Pologne et la Bosnie (Ehrenbaum, 1926 ; Leach, 1924 ; O'Malley, 1927).

Dans tous ces pays, la TAC a été introduite en milieu naturel et s'est naturalisée dans de nombreuses régions du monde (Stanković et al., 2015). Une population non endémique est considérée comme naturalisée si elle prospère dans un état de vie libre, sans soutien et indépendamment d'interventions humaines continues (Copp et al., 2005). Les populations naturalisées restent rares en France ; la seule bien répertoriée se trouve dans le réservoir artificiel des Bouilloses, dans les Pyrénées où elle a été introduite en 1958 (Dumas, 1976 ; Baran et al., 1995).

Cette naturalisation de la TAC peut engendrer des impacts généralement négatifs sur la faune piscicole indigène, particulièrement pour les autres salmonidés ; la TAC devient alors une espèce invasive (Cambray, 2003 ; Stanković et al., 2015). Par exemple, cette naturalisation a posé problème en Croatie où la prédation de la TAC sur les populations endémiques de vairons a conduit à l'extinction de certaines populations (Stanković et al., 2015). Des observations contradictoires ont été menées quant aux risques de compétition entre TAC et truite fario (*Salmo trutta* forme *fario*) indigène en Europe. Honsing-Erleburg (2005) décrit une compétition forte entre les deux espèces en Autriche, avec une inversion totale des effectifs en faveur de la TAC 10 ans après son introduction. C'est pourquoi certains pays comme la Norvège ou l'Autriche, ont classé la TAC dans la liste noire des espèces invasives (Stanković et al., 2015). Cependant une autre étude montre qu'au contraire c'est la truite fario qui parvient par compétition interspécifique à supplanter la TAC (Baran et al., 1995). De plus, il a été montré que la TAC

présente un faible risque pour le biote et les écosystèmes aquatiques indigènes en raison de son incapacité à établir des populations autonomes dans la majeure partie des environnements. Elle est ainsi parfois recommandée à l'introduction pour la pêche de loisir dans les rivières françaises pour soulager sensiblement la pression de pêche sur les truites fario indigènes (*https://peche-hautes-alpes.com/hautes-alpes-la-truite-arc-en-ciel-est-elle-un-danger-pour-notre-truite-*

fario/), expliqué par le fait que la TAC semble plus facile à pêcher que la truite fario (Dumas, 1976). De plus, cela est rendu possible par l'incapacité des hybrides issus du croisement entre la TAC et la truite fario à survivre dès les premiers stades de développement (Suzuki & Fukuda, 1971). Plus généralement, les possibilités d'hybridation de la TAC avec d'autres salmonidés sont assez faibles (Chevassus et al., 1975). Par ailleurs, les risques liés aux échappements dans le milieu naturel de TAC issues d'élevages de production sont maintenant également limités en France par le fait qu'une grande part de la production vient de l'élevage de TAC triploïdes stériles ou de populations monosexes femelles, plus intéressantes que les populations bisexuées pour la production (moindre mortalité, meilleure croissance et meilleure qualité du produit final). Le caractère invasif de la TAC est donc à mettre en regard avec le lieu de sa naturalisation, la faune présente ainsi que le type de truites introduites (diploïdes femelles ou triploïdes stériles).

1.1.3. La reproduction de la truite arc-en-ciel

Comme chez tous les poissons ovipares, la TAC se reproduit par fécondation externe et la rencontre des gamètes doit intervenir rapidement après leur émission dans l'eau. En milieu naturel, la femelle truite arc-en-ciel peut pondre de façon séquentielle, lui permettant de se reproduire avec plusieurs mâles. Généralement, les femelles pondent jusqu'à 2000 œufs par kilogramme de poids vif. Après l'ovulation, les œufs sont conservés dans la cavité abdominale des femelles, ils baignent dans le liquide cœlomique (milieu isotonique présentant des activités antiprotéase et antibactérienne) permettant de les conserver (Bobe et al., 2010). L'ovulation et la ponte des œufs peuvent intervenir à plusieurs jours d'intervalle. Toutefois, après 8 jours dans la cavité abdominale, la qualité des ovules diminue significativement. Après la ponte, sans intervalle de temps, la fécondation des œufs advient (Bobe et al., 2010).

Habituellement, la durée du cycle reproducteur est d'un an, même si cette période peut être réduite sous photopériode artificielle (Bobe et al., 2010). Les populations naturelles de TAC d'Amérique du Nord se reproduisent au printemps. Or, en Europe, la plupart des populations de TAC domestiquées ont une période de reproduction différente, qui s'étend du milieu de l'automne au début de l'hiver. Cela est probablement dû aux températures automnales plus clémentes en Europe qu'en Amérique du Nord, autorisant une ponte plus précoce car la gamétogenèse n'est pas bloquée (Bobe et al., 2010). Néanmoins, il existe également en Europe des lignées dont la reproduction se déroule au printemps, comme pour les populations naturelles d'Amérique du Nord.

L'âge de la puberté des TAC dépend avant tout de leur sexe et de leur croissance associée aux conditions d'élevage (alimentation et température), mais aussi de leur génétique (Breton et al., 2010). Les mâles atteignent généralement la puberté un an avant les femelles, c'est-à-dire à un ou deux ans contre deux ou trois ans pour les femelles. Les TAC sont des poissons gonochoriques, soit mâles, soit femelles qui gardent le même sexe tout au long de leur vie. Chez la truite arc-en-ciel, le sexe est gouverné par un système chromosomique simple (XX/XY) dont le déterminant majeur est connu (gène *sdY*, Yano et al., 2012). Cependant, des individus spontanément masculinisés sont fréquemment observés au sein des populations XX. Des travaux expérimentaux ont montré que le taux de masculinisation spontanée dépendait à la fois de facteurs génétiques et de la température d'alevinage (Quillet et al., 2002 ; Valdivia et al., 2014 ; Fraslin et al., 2020).

Par ailleurs, le sexe phénotypique (mâle ou femelle) peut être inversé par rapport au sexe génétique (XY ou XX) par traitement hormonal à la première alimentation des alevins. Ainsi, la masculinisation est possible grâce aux androgènes, ainsi que la féminisation grâce aux œstrogènes. En élevage, la masculinisation est recherchée afin de produire ce qu'on appelle des néo-mâles. Ce sont des individus avec un phénotype mâle mais un génotype femelle (XX). Ainsi, lorsqu'on les croise avec des femelles normales (génétique et phénotype), ces néo-males ne produisant que des gamètes « X », permettent d'obtenir des populations monosexes femelles (génotype + phénotype femelle). Actuellement, pour des raisons de facilité de gestion des élevages, mais également pour garantir une meilleure qualité de produit, due à une maturation sexuelle plus tardive, la production des TAC se fait en grande majorité en élevage mono-sexe femelles (90%).

En élevage, la TAC ne rencontre pas les conditions pour une reproduction naturelle, et les juvéniles sont donc obtenus par fécondation artificielle. Pour cela, les gamètes matures sont prélevés par massage abdominal sous légère anesthésie, puis une fécondation artificielle est

réalisée par l'éleveur (Bobe et al., 2010). Le processus de fécondation artificielle permet de réaliser facilement les plans d'accouplements souhaités, qu'ils soient hiérarchiques (chaque père est croisé avec une ou plusieurs femelles) ou factoriels (chaque père est croisé avec chacune des mères et inversement). Il est ainsi aisé d'accoupler les reproducteurs choisis et donc de gérer facilement le progrès génétique et la diversité génétique au sein des populations (Dupont-Nivet et al., 2006). En France, les accouplements des reproducteurs au sein des programmes de sélection se font sur le modèle de plans factoriels incomplets (cf. Chapitre 5). Lors des fécondations artificielles, la ponte de chacune des femelles est divisée en autant de lots que de mâles utilisés pour féconder les œufs, car plusieurs études ont mis en évidence une compétition spermatique entre les mâles. Cela se traduit par une contribution supérieure de certains mâles lorsque les laitances de plusieurs mâles sont mélangées (Parker, 1998 ; Kaspar et al., 2008). Cela permet donc de s'affranchir d'un mécanisme responsable d'une variance importante du succès reproductif sur la voie paternelle engendrant des tailles de famille variables susceptibles d'induire une perte de diversité génétique au cours des générations. De plus, dans le cadre des schémas de sélection de type PROSPER, Chevassus et al. (2004) ont suggérés de féconder et de regrouper ensemble les œufs des mères aux tailles d'œufs similaires. Et cela afin de s'affranchir de la variance du succès reproductif sur la voie maternelle due à une croissance initiale variable entre les alevins originaires d'œufs de tailles différentes.

Le moment précis de l'ovulation des femelles est peu prévisible. Or, un prélèvement trop tardif des ovules peut poser des problèmes de vieillissement post-ovulatoire excessif, entraînant une baisse de leur qualité, se traduisant par une chute de la fécondabilité, ainsi que l'apparition de graves défauts de développement (mortalité ou malformations embryonnaires). Chez la truite, une durée de cinq jours à 10-12°C entre l'ovulation et la fécondation permet d'obtenir une qualité ovocytaire maximale (Sakai, 1975 ; Springate et al., 1984). Sakai (1975) observe que les premiers jours après l'ovulation, le taux de fécondation est réduit, probablement dû à quelques œufs n'ayant pas fini leur maturation, ainsi que cela a été confirmé suite à l'examen d'ovules de poissons sacrifiés juste après ovulation (Wallace & Selman, 1978). Pour s'affranchir du problème du vieillissement post-ovulatoire, il est possible de synchroniser les pontes des femelles, grâce à une induction hormonale (Bobe et al., 2010). Cela est fait en élevage, et permet de connaitre le moment précis de l'ovulation des femelles, qui se fera simultanément. Cela permet également d'éviter la manipulation répétée des femelles afin de vérifier l'ovulation de chacune d'elles.

Après fécondation, le développement de l'embryon de TAC peut être divisé en quatre phases jusqu'au stade de l'alevin (Vernier, 1969) : la segmentation, la gastrulation, la période du bourgeon causal et la résorption de la vésicule vitelline. La durée des étapes du développement embryonnaire dépend de la température ambiante. C'est pourquoi, dans la littérature, les durées de développement sont généralement exprimées en degré - jours. De la fécondation à l'éclosion, on considère qu'il faut entre 290 et 370 degrés - jours selon la lignée (Bobe et al., 2010). Sachant que la plage de températures de développement embryonnaire normale se situe entre 4 et 13°C, il faudra entre minimum 22 jours et maximum 92 jours de la fécondation à l'éclosion. Ce n'est qu'après l'éclosion que les branchies et la bouche des alevins se développent, lors de la résorption de la vésicule vitelline (Bobe et al., 2010). Les alevins commencent alors une période de nourriture mixte (endogène et exogène), qui durera entre 42 et 63 degrés - jours (Escaffre & Bergot, 1984).

1.1.4. Le génome de la truite arc-en-ciel

Chez tous les vertébrés, on retrouve la trace de deux duplications complètes du génome (hypothèse 2R initialement proposé par Ohno, 1970) ayant eu lieu chez les Chordés il y a environ 450-500 millions d'années (Dehal & Boore, 2005). Chez les poissons téléostéens, une troisième duplication du génome entier est survenue (Ts3R). Et une 4^{ème} et dernière duplication complète du génome (Ss4R) a eu lieu chez les salmonidés il y a environ 96 millions d'années (Figure 2; Berthelot et al., 2014 ; Macqueen & Johnston, 2014).

La taille du génome de la truite arc-en-ciel est estimée a environ 2,4.10⁹ paires de bases (Hardie & Hebert, 2003 ; Gao et al., 2021). Le génome de la TAC est très plastique et un nombre variable de chromosomes est observé entre populations de TAC, avec un nombre de paires de chromosomes variant entre 29 et 32. Toutefois, toutes les truites arc-en-ciel possèdent 104 bras chromosomiques, c'est le polymorphisme robertsonien (fusion/cassure de chromosomes au niveau des centromères) qui fait varier le nombre de paires chromosomiques, comme la

cytogénétique a pu le mettre en évidence (Guyomard et Vandeputte, 2010). Le génome ancestral est supposé être à n=29 chromosomes haploïdes (Thorgaard, 1983). S'il existe d'autres espèces pour lesquelles on observe des variations inter-individuelles du nombre des chromosomes (Lukhtanov et al., 2011), ce phénomène est rare, et pour la majorité des espèces, le nombre et la structure des chromosomes ne varient pas.

Ces différences génomiques entre populations de TAC ont conduit à considérer deux génomes de références différents et donc construire deux assemblages distincts du génome de la TAC. Ces assemblages ont été réalisés sur la base du séquençage d'individus de deux lignées double haploïdes androgéniques (YY) américaines (Swanson et Arlee) (Gao et al., 2016, 2021) :

- Le premier génome de référence assemblé a été réalisé à partir d'un individu de la lignée Swanson, originaire de la péninsule de Kenai en Alaska (Omyk_1.0 : GCA_002163495.1, Gao et al., 2016). Cette lignée a n=29 paires de chromosomes et est considérée comme proche du génome ancestral de la TAC. Un premier assemblage avait été réalisé à l'INRA (AUL_PRJEB4421_v1, Berthelot et al., 2014) et un second assemblage plus précis à l'USDA (Omyk_2.0, Gao et al., 2016).
- Le second génome de référence, récemment assemblé par l'USDA (Omyk_1.1 : GCA_013265735.3, Gao et al., 2021) a été réalisé sur un individu de la lignée domestiquée Arlee originaire de la côte Nord de la Californie et est constitué de n=32 paires de chromosomes.

Les chromosomes omy4, omy14 et omy25 du génome de référence Swanson ont été scindés en deux pour constituer respectivement les chromosomes 30, 32 et 31 du génome de référence Arlee.

Palti et al. (2014) ont réalisé un arbre phylogénétique de diverses lignées de TAC, comparant notamment les lignées Swanson et Arlee, ainsi que des lignées isogéniques INRAE. On peut constater que les lignées françaises sont génétiquement plus proches de la lignée Arlee provenant de Californie. Cela est cohérent avec la connaissance de la diffusion de la TAC en Europe à partir de cet état américain, ainsi qu'avec les analyses de Guyomard et al. (2012) et D'Ambrosio et al. (2019) indiquant qu'au moins le chromosome omy25 du génome de référence Swanson correspondait à deux groupes de liaison distincts dans les populations de TAC françaises.

1.1.5. Les outils génomiques disponibles

Ces dix dernières années, la baisse importante des coûts de génotypage et séquençage a permis l'accès à des ressources génomiques importantes pour les espèces aquacoles, en particulier pour les salmonidés.

Deux puces de génotypages sont ainsi actuellement disponibles pour la TAC. La première, développée par l'USDA, est une puce moyenne densité (MD - 57K marqueurs SNPs) (Palti et al., 2014). La seconde est une puce haute densité (HD - 665K marqueurs SNPs) développée en 2020 à INRAE (Bernard et al., 2022) en collaboration avec l'USDA et le SYSAAF. La puce MD a servi à mes premiers travaux de thèse (Chapitres 2 et 3) et la puce HD à mes derniers travaux de thèse présentés au Chapitre 4. Avec ce second outil, j'ai pu caractériser finement le déséquilibre de liaison entre marqueurs à faible distance dans les populations de mon étude du Chapitre 4. Cette description est présentée comme première valorisation scientifique de la puce HD (Bernard et al., 2022 en Annexe 1).

A Retenir – 1.1. Les populations de truites arc-en-ciel sauvages et domestiquées

- La truite-arc-en-ciel, originaire de la côte Pacifique d'Amérique du Nord et de la péninsule du Kamtchatka en Russie, a été disséminée à travers le monde.
- La domestication de la truite arc-en-ciel est récente (fin du XIX^{ème} siècle).
- La truite arc-en-ciel fait partie des 15 espèces majeures de la production piscicole mondiale (FAO, 2022). L'Union Européenne est le second producteur mondial de TAC, juste derrière l'Iran.
- > Le nombre de chromosomes varie de 29 à 32 paires d'une population de TAC à l'autre.
- Deux génomes de référence sont à l'heure actuelle séquencés et assemblés à l'échelle des chromosomes : Swanson (n=29 chromosomes) et Arlee (n=32 chromosomes).
- Deux puces de génotypage sont disponibles : une puce moyenne densité (57K SNPs) et une puce haute densité (665K SNPs).

1.2. Diversité génétique et évolution des populations

1.2.1. Biodiversité et diversité génétique

En juin 1992, le Sommet de la Terre de Rio de Janeiro alerte les Etats et l'opinion publique sur les changements climatiques et les atteintes à la biodiversité, en s'efforçant de définir la notion de développement durable définie par l'ONU (rapport Brundtland de 1987) : « Le développement durable est un développement qui répond aux besoins du présent sans compromettre la capacité des générations futures à répondre à leurs propres besoins ». Cette conférence de Rio reconnait la préservation de la diversité biologique comme l'un des grands enjeux environnementaux de la planète. Elle met au chapitre 15 de l'Agenda 21 la préservation de la diversité biologique et l'utilisation durable des ressources biologiques en objectifs essentiels des actions à conduire tant au niveau international que national ou local. La biodiversité concerne non seulement la diversité des espèces vivantes, mais aussi de leurs caractéristiques génétiques (variabilité des gènes et des populations intra-espèces), ainsi que la diversité des écosystèmes. La diversité génétique décrit le niveau de la diversité intra spécifique par le nombre (variété) des allèles des gènes présents au sein d'une même espèce, c'est-à-dire par le niveau de polymorphisme des gènes observé dans l'espèce. Elle se distingue de la variabilité génétique, qui mesure le degré de variation du génotype (ensemble des caractéristiques génétiques) entre individus d'une même population (ou espèce) associé ou non à une variation de phénotype (caractère évalué). La diversité génétique représente le réservoir génétique d'une espèce, et peut être définie comme une mesure dérivée de la biodiversité permettant de l'étudier et de la gérer (Pereira et al., 2013).

Les différentes versions et associations alléliques des gènes apparaissent par mutation ou bien par réarrangements chromosomiques (recombinaisons). Actuellement, l'étude de la diversité génétique et du polymorphisme des gènes se fait essentiellement grâce à la détection de sites (= *loci*) polymorphes, et cela grâce à des marqueurs moléculaires. Les marqueurs moléculaires sont associés à des fragments d'ADN correspondant à un locus ou plusieurs *loci* polymorphes. Il y a quelques années, les marqueurs utilisés en routine étaient les microsatellites. Ce sont des motifs très courts (moins de 10 paires de base) hautement répétés (en tandem) et bien répartis le long du génome (chez les salmonidés, les microsatellites sont présents tous les 20-80 kb, Estoup et al., 1993). Le nombre de répétitions de microsatellites à un site donné varie d'un individu à l'autre, permettant d'accéder au polymorphisme de répétitions de chaque individu. Ces dernières années un autre type de marqueur s'est développé, les SNPs (Single Nucleotide Polymorphism). Ce sont des marqueurs basés sur le polymorphisme d'une base unique, ils sont nombreux et bien répartis le long du génome, en moyenne toutes les 64 paires de bases (Gao et al., 2018) et représentent donc une large partie de toutes les différences génétiques entre individus. Ces caractéristiques font des SNPs le type de marqueurs de prédilection aujourd'hui utilisé. A chaque site polymorphe au niveau de la population, un individu sera soit homozygote si ses deux allèles sont identiques, soit hétérozygote s'il possède deux versions différentes. La diversité génétique varie selon les régions du génome, les gènes considérés ainsi que d'une population à l'autre (Ellegren & Galtier, 2016).

Finalement, la diversité génétique peut être définie comme l'exact opposé de la consanguinité (Lefort-buson, 1988). La consanguinité est issue de l'accouplement d'individus apparentés, c'est-à-dire de deux individus ayant au moins un ancêtre commun. Les descendants sont donc homozygotes à plus de *loci* que ceux issus d'un accouplement d'individus non apparentés. Un individu ayant un génotype (= combinaison d'allèles à un locus) homozygote, du fait de sa consanguinité, peut aussi être appelé « autozygote ». Autrement dit, un génotype autozygote est composé d'allèles identiques (homozygotes) issu d'un même allèle ancestral (= IBD, identique par descendance). A l'échelle de la population, un niveau de consanguinité trop important conduit à une réduction du nombre de sites polymorphes. Toutefois, la consanguinité ne se transmet pas à la descendance (non héritable), si deux individus consanguins mais non apparentés se reproduisent, leurs descendants ne sont pas consanguins.

Il est reconnu que la diversité génétique offre aux espèces une plus grande capacité d'adaptation et de survie, surtout à des changements environnementaux conséquents (Barrett & Schluter, 2008). Un niveau important de diversité génétique contribue par exemple à la capacité de réponse immune à la diversité spatio-temporelle des pathogènes (cas du complexe majeur d'histocompatibilité dans la réponse immunitaire, Bed'Hom & Chazara, 2011), ainsi que contribuer à des mécanismes divers impliqués dans la survie ou la reproduction (Durland et al., 2021). Un large *pool* génétique est également le garant du maintien du progrès génétique à moyen et long terme en sélection. Cela permet d'avoir une probabilité plus importante que certains individus de la population aient des allèles mieux adaptés aux fluctuations de l'environnement et soient donc susceptibles de survivre et de transmettre à leur descendance des caractéristiques génétiques favorables. De plus, il a été observé dans un grand nombre d'espèces animales ou végétales que les individus consanguins présentent une moindre valeur sélective (ou *fitness*), avec un plus grand nombre de malformations, ainsi qu'une survie, une

croissance et une fertilité moins bonnes que les descendants de parents non apparentés. Ce phénomène est appelé dépression de consanguinité (Aulstad & Kittelsen, 1971 ; Kincaid, 1976 ; Su et al., 1996 ; Leroy, 2014 ; Doekes et al., 2019 ; Baes et al., 2019).

Une méta-analyse des effets de dépression de consanguinité menée par Doekes et al. (2021) sur sept espèces d'animaux de rente (bovin, porc, poulet, mouton, chèvre, cheval et lapin) démontre un niveau de dépression de consanguinité similaire (\approx - 0.28% sur la moyenne du caractère lorsque le coefficient de consanguinité F augmente de 0,01 point) pour divers types de caractères dans les populations animales (survie, reproduction, croissance, production et santé). Les diminutions de performances associées à l'augmentation de consanguinité induisent des pertes économiques plus ou moins importantes pour les sélectionneurs et/ou les producteurs (Leroy et al., 2014).

1.2.2. Evolution des populations et de leur diversité génétique

On définit l'évolution comme la modification des fréquences des allèles au sein d'une espèce ou d'une population. En l'absence de pression des forces évolutives, une population dite « idéale » (c'est-à-dire d'effectif infini, fermée (isolée), avec une reproduction panmictique, sans sélection ni mutation) conserve indéfiniment des fréquences alléliques stables ; elle est dite en équilibre de Hardy-Weinberg (Hardy, 1908 ; Weinberg, 1908). Toutefois, une population « réelle » est soumise à quatre forces évolutives (la dérive, la sélection, la mutation et la migration) qui influencent l'évolution de sa diversité génétique au cours des générations.

Parmi les forces évolutives, certaines peuvent jouer en faveur de la diversité génétique dans les populations. C'est le cas de la mutation, et dans certains cas de la migration. En revanche, dérive génétique, sélection et effet fondateur induisent des pertes de diversité à l'échelle des populations isolées.

Encart 1. Notion d'équilibre d'Hardy-Weinberg

Le modèle d'Hardy-Weinberg est un modèle central de la génétique des populations. La notion d'équilibre d'Hardy-Weinberg (HW) est conditionné à plusieurs hypothèses : La population doit être idéale, de taille infinie et constante, se reproduisant en générations discrètes (pas de chevauchement entre les générations) et en panmixie totale (les couples se forment au hasard). La population doit être non sélectionnée, sans migration, ni mutation. Ainsi sous équilibre d'Hardy-Weinberg, la diversité génétique de la population se maintient et tend vers un équilibre stable.

De cet équilibre d'HW, découle la loi de distribution des génotypes associée à l'allèle A de fréquence p et l'allèle a de fréquence q=1-p (permettant aux fréquences alléliques de rester constantes) : $p^2 + 2pq + q^2 = 1$

Le génotype *AA* sera de fréquence de p^2 ; le génotype *Aa* sera de fréquence 2pq ;et le génotype *aa* sera de fréquence q^2 dans la population.

1.2.2.1. Les forces évolutives

1.2.2.1.1 La mutation

L'apparition de nouvelles mutations permet d'ajouter différentes versions alléliques et donc d'augmenter la diversité génétique au sein d'une espèce ou population. Ce processus est à la base de la variabilité génétique observée dans les populations. Les mutations génétiques peuvent survenir aléatoirement au cours de la réplication de l'ADN lors des divisions cellulaires, mais elles peuvent également être produites lors d'une exposition à des agents mutagènes présents dans l'environnement (UV, agents chimiques, virus, etc). Il existe trois grands types de mutations : le remplacement (substitution), la suppression (délétion) ou l'ajout (insertion) d'une ou plusieurs paires de base (mutations ponctuelles ou tandem de paires de base).

Les remaniements chromosomiques sont des modifications des structures chromosomiques et sont considérés comme des mutations chromosomiques. Ces processus peuvent correspondre à des duplications, des délétions, des translocations (= échange de fragments d'ADN entre chromosomes), des variations du nombre de chromosomes (fusions, fissions), ou des inversions de segments d'ADN (= changement d'orientation des segments modifiant l'ordre des gènes). La polyploïdisation des génomes est également une forme de mutation (mutations génomiques).

Seules les mutations dans les cellules germinales peuvent être transmises aux descendants de l'individu et donc dans la population. Ces mutations peuvent avoir un effet neutre sur l'organisme, mais également des effets favorables ou défavorables.

1.2.2.1.2. La migration

La migration peut être définie comme une partie (plus ou moins importante) d'une population d'une espèce allant fonder une nouvelle population, ou faire simplement référence aux flux de gènes entre plusieurs populations pré-existantes. Si la migration concerne la création d'une nouvelle population, cette dernière peut être de diversité génétique réduite par rapport à la population initiale car seul un nombre limité de reproducteurs va engendrer les descendants de la nouvelle population ; ce phénomène est appelé effet fondateur (Mayr, 1954, 1963). Généralement, au sein de populations sauvages, c'est l'isolement géographique d'une partie de la population initiale qui peut induire la création d'une nouvelle population. Dans le cadre de la domestication, c'est l'intervention humaine, isolant certains individus d'une population sauvage, qui induit la création d'une nouvelle population.

A l'inverse, dans le cadre de flux de gènes entre deux populations, de nouveaux variants peuvent être introduits dans la population cible si la population migratrice est génétiquement suffisamment différente (différence ayant pu être induite par un isolement géographique), augmentant alors la diversité génétique de la population cible.

1.2.2.1.3. La dérive génétique

La dérive génétique est l'évolution d'une population ou d'une espèce causée par des événements aléatoires, impossibles à prévoir (Kimura, 1968). Dans une très grande population, dite de taille « infinie », fermée et non soumise à sélection, les fréquences alléliques sont relativement stables d'une génération à l'autre. Alors que dans une population de taille finie, les fréquences alléliques sont modifiées aléatoirement d'une génération à l'autre, par un effet

d'échantillonnage appelé « dérive génétique ». Elles augmentent ou diminuent alors de manière aléatoire, à la manière d'un tirage aléatoire sans remise des gènes d'une génération à l'autre. Au fil des générations, on observe la fixation ou la perte aléatoire de certains allèles, aboutissant au monomorphisme des variants dans une population de taille finie (Masel, 2011 ; De Meeûs, 2012). La dérive génétique concerne tous les allèles même si l'impact sur les allèles neutres (c'est-à-dire ne conférant ni avantage ni inconvénient) est plus important. Malgré tout, un allèle favorable peut disparaitre ou un allèle défavorable se fixer dans une population par dérive, ce qui est fréquent pour des populations de taille très faible. Plus la taille de la population est réduite, plus le phénomène de dérive est important. Une forte dérive peut rapidement conduire au déclin de la population et dans certains cas à son extinction, en raison d'un risque plus élevé de fixer au hasard des allèles délétères (Smith & Haigh, 1974). Ce mécanisme prend une part importante dans le processus du vortex d'extinction (Frankham et al., 2002).

1.2.2.1.4. La sélection

La sélection naturelle a été pour la première fois décrite par Charles Darwin, naturaliste anglais, dans *l'Origine des espèces* publié en novembre 1859, où il tente d'expliquer l'évolution des espèces ainsi que leur diversité en décodant les mécanismes sous-jacents à la sélection naturelle. Au sein des populations, la sélection naturelle favorise la survie et la reproduction des individus ayant la meilleure valeur sélective (encore appelée valeur adaptative ou *fitness* en anglais), c'est-à-dire les mieux adaptés à leur environnement. En biologie évolutive, la *fitness* est un concept central, mentionné pour la première fois par Herbert Spencer (1864), puis associé au terme de sélection naturelle par Darwin dans la 5^{ème} édition de *l'Origine des espèces* (1869). Dans le cas particulier de la sélection artificielle, ce sont les hommes qui choisissent d'avantager la reproduction de certains individus sur la base de spécificités phénotypiques intéressantes pour l'élevage et la production ou simplement pour des raisons esthétiques (critères de couleur, forme et taille).

Les individus se reproduisant le plus transmettent une part génétique de leurs aptitudes à un plus grand nombre de descendants, permettant sur le long terme l'adaptation de la population (East, 1918 ; Fisher, 1958). La valeur sélective d'un individu est une mesure de son succès reproducteur (Sober, 2001) ; elle dépend principalement de sa survie entre le stade zygote et le stade adulte, et de sa fertilité (nombre de descendants viables capables de se reproduire). Des verrous reproductifs, pouvant induire une variation du succès reproductif entre les individus d'une population, sont observés à différents stades du cycle de reproduction (maturation des gamètes, ponte, fécondation, développement embryonnaire, croissance des larves, recrutement de la population adulte reproductrice). Ainsi, le nombre de reproducteurs participant à la génération suivante est généralement inférieur au nombre de reproducteurs initial et à la taille de la population réelle. Cela peut conduire à une perte de diversité génétique au sein de la population (Hedgecock & Pudovkin, 2011). Ainsi, chez des espèces marines très fécondes, une très forte variance du succès reproductif individuel est observée, liée aux fortes variations environnementales subies en milieu marin, et impactant la contribution des reproducteurs à la génération suivante. Ce phénomène est appelé « Loterie » du Succès Reproductif ou « *Sweepstakes Reproductive Success* » (SRS) et a été proposé par Hedgecock et al. (1994). Les SRS correspondent à un important différentiel entre la taille réelle de la population (N) et le nombre efficace de reproducteurs pour la génération suivante (Hedgecock & Pudovkin, 2011).

Pour qu'il puisse y avoir sélection sur un caractère, trois conditions sont nécessaires et indispensables : le caractère doit être variable dans la population, héritable et il doit y avoir une corrélation entre le nombre attendu de descendants (*fitness*) et le caractère (Levins & Lewontin, 1985). Quelle que soit la nature de la sélection, naturelle ou artificielle, quatre types de sélection existent, et peuvent affecter les fréquences alléliques d'un locus ou plusieurs *loci* de diverses manières, laissant des signatures différentes dans le génome :

- a) La sélection directionnelle est liée à la présence de variants favorables dans la population. Cette forme de sélection est la plus intuitive. En effet, l'allèle conférant une meilleure *fitness* va inévitablement augmenter en fréquence dans la population. Cette forme de sélection favorise des variants allant dans le même sens et agit donc sur la valeur moyenne du caractère. Ce type de sélection peut être positive ou négative, c'est-à-dire sélectionner certains variants avantageux ou au contraire éliminer les variants délétères (sélection purifiante). La sélection artificielle est très généralement un processus de sélection directionnelle.
- b) La sélection stabilisante (ou optimisante) favorise les phénotypes intermédiaires en éliminant les phénotypes extrêmes et permet donc le maintien de caractères à des valeurs moyennes au cours des générations. Il en résulte que les variants aux effets les plus extrêmes sont éliminés de la population. Cette sélection agit en réduisant la variance du caractère sans changer sa valeur moyenne.

- c) La sélection disruptive (ou diversifiante) favorise au contraire les phénotypes (et les variants génétiques) extrêmes et élimine les intermédiaires. Ce type de sélection se produit lorsque les phénotypes extrêmes ont un avantage sur les intermédiaires (Levene, 1953; Marchinko et al., 2014). Par exemple, une population de prédateurs peut avoir deux types de proies, la sélection disruptive correspond au processus par lequel deux types d'individus deviendront majoritaires, chacun spécialisé sur l'une des deux proies. Les individus intermédiaires seront éliminés car trop généralistes.
- d) La sélection équilibrante (ou balançante) favorise les allèles en fréquences intermédiaires (Charlesworth, 2006). Cette sélection peut être expliquée par le mécanisme de surdominance, c'est-à-dire l'avantage à l'hétérozygote. L'exemple de surdominance le plus connu chez l'humain est lié à la maladie génétique de la drépanocytose, due à une mutation récessive qui induit une durée de vie limitée aux individus homozygotes pour cette mutation. Cependant, en parallèle, cette mutation confère une immunité au paludisme, due à la modification de la forme des cellules sanguines. C'est pourquoi, les individus hétérozygotes sont avantagés. Un second processus induisant une sélection équilibrante est la sélection fréquence-dépendante, c'est-à-dire l'avantage à l'allèle rare. Par exemple, le phénotype du camouflage est souvent dépendant de la fréquence de celui-ci dans la population. En effet, si la fréquence des individus avec un camouflage spécifique augmente dans la population, alors la probabilité que les prédateurs développent des stratégies de contournement de ce camouflage augmente, diminuant alors la valeur sélective de l'allèle et avantageant une autre stratégie, plus rare, de camouflage (Huneman, 2011).

Pour résumé, excepté, dans le cadre de la sélection équilibrante, la sélection conduit à une perte de diversité génétique *a minima* au niveau des *loci* sous sélection. En effet, lorsqu'une mutation favorable apparait dans le génome, sa fréquence dans la population augmente par sélection. Les allèles neutres, en déséquilibre de liaison avec la mutation favorable, sont eux aussi sélectionnés par effet d'entrainement. On parle d'effet auto-stop ou de « hitch-hiking » (Smith & Haigh, 1974). Le phénomène inverse peut également être observé lors de la purge d'allèles fortement délétères, on parle alors de sélection négative (Charlesworth et al., 1995). La région sous sélection subit une réduction de sa variance génétique, et laisse une empreinte spécifique dans le génome qu'on appelle balayage sélectif (ou « *selective sweep* ») (Figure 3). Seul le processus de recombinaison homologue peut rompre les associations d'allèles et en créer de nouvelles pour générer de la diversité génétique à l'échelle chromosomique.



Figure 3. Représentation schématique d'un balayage sélectif après l'apparition d'une mutation favorable dans la population. *La mutation favorable (vert) est en déséquilibre de liaison plus ou moins important avec différentes mutations neutres (jaunes). Au cours des générations, la mutation favorable augmente en fréquence jusqu'à fixation. La mutation neutre la plus proche (jaune, en fort déséquilibre de liaison) est alors elle aussi sélectionnée et augmente en fréquence dans la population, voire devient fixée. Deux allèles en fort déséquilibre de liaison auront moins de chances d'être « séparés » par un événement de recombinaison, que des allèles ayant un déséquilibre de liaison plus faible.*

1.2.2.2. Les théories de l'évolution

Afin de comprendre les mécanismes génétiques de l'évolution des populations ou des espèces, la génétique des populations a été initiée dans les années 1920 à 1930 (Fisher, 1919 ; Haldane, 1932 ; Wright, 1931). Ce n'est qu'avec la re-découverte des lois de Mendel (1822–1884) en 1900 par plusieurs biologistes (Hugo de Vries, Karl Correns, Erich von Tshermak), que Fisher (1919) relie les théories darwiniennes sur la sélection naturelle à la notion d'hérédité mendélienne (Mendel, 1865 ; Bateson & Mendel, 2013) et établit la base de la théorie de la synthèse moderne de la biologie évolutive.

Le terme théorie synthétique de l'évolution (ou néodarwinisme), a été introduit par Julian Huxley (1942). Cette théorie a été admise comme paradigme commun à l'ensemble de la biologie et a permis de démontrer que l'évolution des espèces et des populations est induite à la fois par la sélection naturelle et le hasard. Elle fut construite sur la base de deux théories générales acceptées : la théorie adaptationniste et la théorie neutraliste.

1.2.2.2.1. La théorie adaptationniste

Dans cette théorie, l'évolution des espèces et des populations est principalement due aux pressions de sélection, la dérive n'a alors que très peu d'impact sur l'évolution des populations. Par exemple, pour les adaptationnistes, la multitude de convergences évolutives parmi plusieurs espèces ne peut pas être due au hasard et doit probablement impliquer une pression de sélection commune sur certains caractères.

1.2.2.2.2. La théorie neutraliste

Dans cette théorie Kimura (1983) conjecture que l'évolution d'une population est principalement expliquée par sa taille efficace et son taux de mutation.

Sans renoncer au rôle de la sélection naturelle et des processus adaptatifs (mutations non neutres) dans l'évolution des populations, Kimura estime que la principale force évolutive est la dérive génétique car la plupart des mutations ne sont pas adaptatives, mais neutres et ne procurent donc ni avantage ni désavantage : il n'y a pas de pression de sélection.

1.2.2.3. La domestication

La domestication est un processus évolutif correspondant à l'adaptation génétique au fil des générations d'une population sauvage à la manipulation par l'Homme et à l'élevage en milieu captif (Darwin, 1859, 1868 ; Price, 1984). Ce processus est associé à la sélection des individus les plus adaptés aux besoins de l'Homme (alimentation, caractéristiques physiques). Cela peut conduire à une baisse importante de la diversité génétique au sein des espèces et populations due au goulot d'étranglement intrinsèque à la sélection d'un nombre limité d'individus sauvages pouvant survivre à la captivité. Néanmoins, la domestication permet de réduire la pression de sélection naturelle sur les populations, les animaux passant d'un milieu naturel sauvage à un milieu anthropisé, plus protecteur. Ainsi, lors de la domestication, l'Homme a éloigné les prédateurs, fourni de la nourriture, mais a privilégié les animaux les plus dociles et sociables (Price, 1999). C'est pourquoi, la domestication peut parfois permettre le développement dans la population de caractères qui seraient « mal adaptés » dans des conditions sauvages.

La domestication a entraîné des changements biologiques fondamentaux chez les animaux domestiques par rapport à leurs homologues sauvages (Darwin, 1859 ; Zeder, 2012 ; Larson & Fuller, 2014 ; Wright, 2015). Dans des populations domestiquées de poissons, des
modifications du comportement, de la reproduction, de la croissance et de l'immunité des individus ont pu être observées (Milla et al., 2021). Au niveau comportemental, la domestication réduit la réactivité des poissons pour échapper à des prédateurs (Pasquet, 2018).

Pour illustrer ces différences phénotypiques, une comparaison de la réponse immunitaire entre des populations sauvages et domestiquées a été réalisée dans plusieurs espèces de poissons. Chez le saumon d'Atlantique, aucune différence dans la réponse à *Aeromonas salmonicida* n'a été observée entre les souches sauvages et domestiques (Glover et al., 2009). Cependant, chez la perche, une réponse immunitaire plus élevée a été observée chez les poissons domestiqués par rapport à la population sauvage après diverses infections (Douxfils et al., 2011; Mandiki et al., 2011). De la même manière, Palińska-Żarska et al. (2021) montrent que les larves de perches eurasiennes issues de géniteurs domestiqués ont une plus forte expression des gènes liés à la fonction immunitaire, par rapport à des larves issues de géniteurs sauvages. Ainsi, il semble qu'à cause des plus fortes densités de poissons en élevage, les individus domestiqués soient indirectement plus sélectionnés pour la résistance aux virus, bactéries ou pathogènes que les individus des populations sauvages.

La domestication des animaux a commencé il y a plus de 15 000 ans avec la domestication du loup (Galibert et al., 2011). Cette dernière a précédé celle de plusieurs espèces animales terrestres (chèvre, mouton, porc, chat il y a environ 11 000 ans; etc.). La domestication des espèces aquatiques est bien plus tardive et a commencé par celle de la carpe il y a environ 2 000 ans. Cependant, la date et le lieu précis de la domestication de la carpe fait encore l'objet de débats : Chine néolithique ou Europe centrale à l'époque romaine (Balon, 1995; Balon, 2004). La plupart des espèces de poissons d'élevage ont été domestiquée très récemment au cours du siècle dernier (Teletchea & Fontaine, 2014). Pour rappel, la truite arc-en-ciel n'a été domestiquée que dans les années 1870 en Californie (cf. partie 1.1.2; Hershberger, 1992). En 1950, seulement 42 espèces de poissons étaient considérées comme domestiquées (FAO, 2003). Aujourd'hui, 313 espèces de poissons sont élevées dans le monde (Metian et al., 2020; FAO, 2022).

Les processus de domestication et de sélection artificielle peuvent induire des pertes importantes de diversité génétique au sein des populations ou des espèces domestiquées. Dans la partie suivante, je vous présente donc les conséquences d'une augmentation de la consanguinité et les mécanismes sous-jacents à la dépression de consanguinité.

1.2.3. Conséquences de l'augmentation de la consanguinité

L'augmentation de la consanguinité dans une population conduit à une perte d'hétérozygotie le long du génome. Cela augmente donc le risque de trouver des individus homozygotes pour des allèles délétères récessifs. L'expression de ces allèles délétères (fardeau génétique) est alors accrue et la *fitness* des individus consanguins est réduite, c'est ce qu'on appelle la dépression de consanguinité (Aulstad & Kittelsen, 1971; Charlesworth & Charlesworth, 1999). Si les *loci* à l'origine de la dépression de consanguinité interagissent de manière indépendante et additive, la valeur sélective va décliner de façon linéaire pour des consanguinités croissantes (Figure 4). La pente (négative) de cette droite quantifie l'importance de la dépression de consanguinité pour une unité d'accroissement de la consanguinité.



Figure 4. Illustration de l'effet de la dépression de consanguinité.

Plusieurs mécanismes génétiques ont été avancés (e.g. Charleswotrth & Charlesworth, 1999) pour expliquer le phénomène de dépression de consanguinité (Figure 5) :

- L'hypothèse de dominance partielle (expression des allèles récessifs délétères ; Davenport, 1908).
- 2- L'hypothèse de superdominance (ou *overdominance*) (supériorité de l'hétérozygote sur les deux types d'homozygotes ; East, 1908).
- 3- L'hypothèse de pseudo-overdominance (combinaisons des effets de plusieurs *loci* liés à effets récessifs délétères ; Jain & Allard, 1966).

Chez des espèces végétales allogames comme le maïs, le phénomène de superdominance (phénomène d'hétérosis ou de vigueur hybride) joue un rôle majeur dans la dépression de consanguinité (Birchler et al., 2003). Toutefois, chez le riz, espèce autogame, le phénomène pourrait être majoritairement expliqué par l'hypothèse de pseudo-overdominance, mais cela reste difficile à valider par rapport à l'hypothèse de superdominance (Luo et al., 2001). Hormis dans de rares cas, le rôle de la superdominance reste controversé. Les manifestations d'hétérosis seraient plus dues à des effets de dominance (addition des effets de gènes favorables) que de superdominance. Ainsi, chez les espèces animales, la dépression de consanguinité est principalement expliquée par le mécanisme de dominance partielle, caractérisé par l'accumulation d'allèles récessifs délétères (Caballero & Keightley, 1998 ; Fu & Ritland, 1994 ; Charlesworth & Willis, 2009 ; Ceballos et al., 2018).

Dans certains cas rares, ce sont les deux génotypes homozygotes qui sont les plus avantageux par rapport au génotype hétérozygote, c'est ce qu'on appelle la sous-dominance (Charlesworth & Willis, 2009).

Toutes les hypothèses sous-jacentes aux effets de la consanguinité, qu'ils soient positifs (sous-dominance) ou négatifs (dominance partielle, superdominance ou pseudooverdominance) impliquent des effets génétiques de dominance. Ainsi, Misztal et al. (1997) observent chez différents caractères évalués chez le bovin, que plus la variance de dominance était élevée, plus la dépression de consanguinité était forte.



Figure 5. Illustration des différents mécanismes impliqués dans les effets de la consanguinité. A - La dominance partielle ou la pseudo-overdominance, effet d'un allèle récessif délétère qui s'exprime à l'état homozygote (orange). B - Superdominance, avantage de l'hétérozygote (vert) par rapport aux deux homozygotes (orange). C - Sous-dominance, avantage des deux homozygotes (vert) par rapport à l'hétérozygote (orange).

A Retenir – 1.2. Diversité génétique et évolution des populations

- Le maintien de la diversité génétique au sein des populations animales est essentiel, non seulement pour limiter les phénomènes de dépression de consanguinité sur les performances de survie, reproduction, production et santé des animaux, mais aussi pour garantir un potentiel adaptatif et une amélioration génétique des populations domestiques à plus long terme.
- Les quatre forces évolutives (mutation, migration, dérive génétique et sélection) participent à l'évolution des populations ou des espèces, induisant des modifications génétiques et physiologiques.
- La domestication a eu de profondes conséquences sur la physiologie, le comportement et la diversité génétique des espèces élevées.
- Il est essentiel de mieux comprendre les mécanismes génétiques impliqués dans les processus de domestication et de sélection des populations ainsi que dans les phénomènes de dépression de consanguinité.
- Identifier *in fine* les régions génomiques impliquées dans ces processus doit permettre de mieux gérer la diversité génétique dans les populations sélectionnées.

1.3. Méthode d'évaluation de la diversité génétique et d'identification de signatures de sélection

1.3.1. Evaluation de la diversité génétique

Dans cette partie, je vais décrire les diverses méthodes permettant d'évaluer la diversité génétique au sein des populations animales. Par la suite, je détaillerai plus précisément la méthode basée sur les ROH (cf. partie 1.3.1.2.3.), car il s'agit de celle que j'ai utilisée dans ma thèse pour étudier la diversité génétique chez la TAC.

1.3.1.1. Indicateurs de diversité génétique

1.3.1.1.1. Hétérozygotie observée (Ho) et hétérozygotie attendue (He)

D'après la définition de la consanguinité, les individus consanguins présentent un niveau d'hétérozygotie plus bas que les individus non consanguins. Ainsi, une mesure classique en génétique des populations est la comparaison entre l'estimation de l'hétérozygotie observée (Ho) et attendue (He) c'est-à-dire attendue sous l'hypothèse d'HW.

L'hétérozygotie attendue (He), correspond à l'hétérozygotie moyenne attendue à un ou plusieurs *loci* sous l'hypothèse d'HW. On l'estime sur la base de l'indice de diversité de Nei (1973), qui est la probabilité, dans une population, de tirer pour un locus deux allèles différents:

$$h_e = 1 - \sum_{n=1}^N f_n^2$$

Avec f_n la fréquence allélique de l'allèle n.

Le taux d'individus hétérozygotes d'une population (He) sera la moyenne de toutes les valeurs *he*, *L* étant le nombre de *loci* considérés :

$$H_e = \frac{\sum h_e}{L}$$

L'hétérozygotie observée (Ho) est simplement calculée à partir des fréquences des hétérozygotes à chaque locus observé dans la population. C'est donc la moyenne sur les

L loci étudiés du nombre d'individus hétérozygotes ($n_{ind_{HET}}$) divisé par le nombre total d'individus (N) :

$$H_o = \frac{1}{L} \sum_{i=1}^{L} \left[\frac{n_ind_{HET}}{N} \right]$$

Les niveaux d'hétérozygotie observés dans les populations de TAC françaises (D'Ambrosio et al., 2019) sont similaires à ceux observés dans diverses espèces aquacoles (Villanueva et al., 2022), ainsi que des populations bovines (Signer-Hasler et al., 2017) ou porcines (Grossi et al., 2017).

Cette méthode est précise, mais nécessite un bon échantillonnage de la population, afin d'estimer des fréquences alléliques proche de la population réelle, au risque de fausser l'évaluation de la diversité génétique. Cette méthode est également très dépendante du choix des marqueurs.

1.3.1.1.2. Indices de fixation de Wright

Les indices de fixation de Wright (1965) (Fis, Fst et Fit) permettent d'évaluer la diversité génétique dans une population subdivisée en sous-populations et également d'estimer la différenciation génétique entre populations.

Le *Fis* mesure l'écart à la panmixie, c'est-à-dire la déviance de l'hétérozygotie observée par rapport à l'hétérozygotie attendue en cas de reproduction aléatoire. Cet écart à la panmixie est dû à l'augmentation de la consanguinité au sein de la population (ou d'une sous-population) (Nei & Chesser, 1983).

$$Fis = \frac{H_e - H_o}{H_e} = 1 - \frac{H_o}{H_e}$$

Les valeurs du *Fis* sont comprises entre -1 et +1. Un *Fis* négatif est associé à un excès d'hétérozygotes et un *Fis* positif à un déficit en hétérozygotes.

Le *Fst* mesure la différenciation génétique entre populations et sous-populations (Weir & Cockerham, 1984 ; Nei & Chesser, 1983).

$$Fst = 1 - \frac{H_o}{H_T}$$

Avec H_T , l'hétérozygotie attendue si tous les individus de toutes les populations s'accouplaient au hasard. Lorsque le Fst est proche de 0, cela signifie que les deux populations comparées sont génétiquement proches. A l'inverse lorsque le Fst est proche de 1, cela traduit une forte différenciation génétique entre les populations (suggérant peu ou aucun flux de gènes entre populations) (cf partie 1.3.3.2.).

Le *Fit* est un indicateur de la différenciation des individus par rapport à la population totale et permet de décrire l'écart à l'hétérozygotie entre les individus de plusieurs sous-populations d'une espèce. Le Fit permet donc d'évaluer la diversité génétique conservée dans les populations au niveau de l'espèce. On le calcule de la manière suivante (Nei & Chesser, 1983) :

$$Fit = 1 - \frac{H_e}{H_T}$$

1.3.1.1.3. La taille efficace (Ne)

La taille ou l'effectif efficace (Ne) est la taille d'une population idéale (sous équilibre d'HW), panmictique qui présenterait le même niveau de diversité ainsi qu'une évolution des fréquences alléliques identique que dans la population observée, et cela sous l'influence de la dérive seule (Wright, 1931). On peut estimer l'effectif efficace d'une population à l'aide : i) du nombre de reproducteurs (mâles et femelles) ii) de données génomiques comme le déséquilibre de liaison (DL) ou bien iii) de coefficients de consanguinité (évalués sur pedigree ou apparentement génomique).

i) A partir du nombre de reproducteurs (Fisher, 1930; Wright, 1931):

$$N_e = \frac{4N_f N_m}{N_f + N_m}$$

Avec N_f le nombre de femelles reproductices et N_m le nombre de mâles reproducteurs dans la population. Ici on suppose que chacun des reproducteurs de chaque sexe a une contribution

équilibrée. Dans le cas de déséquilibre de contribution connu, d'autres formules prennent en compte la possibilité d'avoir un nombre variable de gamètes apportées par chacun des individus pour constituer la génération suivante.

 A partir du déséquilibre de liaison (DL) entre marqueurs le long du génome (Sved, 1971) :

$$E(r^2) = \frac{1}{1 + 4N_ec}$$

Avec c, le taux de recombinaison et S la taille de l'échantillon. Le DL est mesuré par la corrélation au carré (r^2) entre les allèles positionnés aux différents *loci* (Hill, 1981). On en déduit ensuite la taille efficace de la population :

$$N_e \approx \frac{1 + \frac{1}{S} - E(r^2)}{4c \left[E(r^2) - \frac{1}{S}\right]}$$

iii) A l'aide de l'évolution du taux de consanguinité (Falconer & Mackay, 1996)

$$N_e = \frac{1}{2\Delta F}$$

Avec, ΔF le taux d'accroissement de la consanguinité d'une génération à l'autre :

$$\Delta F = \frac{F(g\acute{e}n\acute{e}ration n) - F(g\acute{e}n\acute{e}ration n - 1)}{(1 - F(g\acute{e}n\acute{e}ration n - 1)}$$

Les coefficients de consanguinité peuvent être estimés sur la base de diverses données (pedigree et génomique ; cf. partie 1.3.1.2.).

La FAO conseille de conserver un Ne minimal de 50 afin de limiter la dépression de consanguinité au sein des populations animales (FAO, 2013). Une baisse importante du Ne a été observée au sein des populations domestiquées de TAC françaises. Sur la base du DL, le Ne a été estimé entre 24 et 48 dans les générations récentes de truite arc-en-ciel (D'Ambrosio et al., 2019). Ces valeurs de Ne sont globalement cohérentes avec ceux d'autres espèces aquacoles où des Ne inférieures à 50 ont été estimées dans des populations ayant subies plusieurs générations de sélection (ormeau – Chen et al., 2017, poisson-chat – Garcia et al., 2018, saumon – Yáñez et al., 2014 ; Barria et al., 2018 ; Martinez et al., 2022 ; daurade - Villanueva

et al., 2022 ; bar - Šegvić-Bubić et al., 2016 ; Villanueva et al., 2022). Les tailles efficaces estimées dans les populations aquacoles domestiquées sont nettement inférieures à celles observées dans les populations bovines et porcines (Danchin-Burge, 2020 ; Ganteil et al., 2020), qui sont majoritairement comprises entre 70 et 90.

1.3.1.1.4. Les coefficients de consanguinité et de parenté

Les coefficients de consanguinité et de parenté des individus d'une population permettent d'en apprécier la diversité génétique. En effet, la probabilité entre deux individus qu'un allèle tiré au hasard chez l'un soit identique par descendance à un allèle au même locus tiré au hasard chez l'autre, est plus élevée lorsque l'apparentement augmente entre les individus, car cela est associé à une baisse de la diversité allélique au sein de la population.

Si l'on souhaite estimer les coefficients de consanguinité (ou de parenté), deux catégories d'informations sont utilisables : le pedigree et les informations génomiques (cf. partie 1.3.1.2.).

1.3.1.2. Calcul des coefficients de consanguinité

1.3.1.2.1. Sur la base du pedigree

Deux méthodes probabilistes permettent d'estimer les coefficients de consanguinité des individus d'une population à partir de l'information généalogique : la méthode des chemins (Wright, 1922) et la méthode tabulaire (Cruden, 1949). Le coefficient de consanguinité est la probabilité pour un individu de porter deux copies identiques d'un même allèle (hérité d'un ancêtre commun).

Le coefficient de consanguinité (F_k) d'un individu k estimé sur la base du pedigree, correspond également au coefficient de parenté (Φ_{ij}) de ses parents (*i* et *j*). A l'aide d'information généalogiques, le calcul les coefficients de consanguinité et de parenté par la méthode des chemins se fait de la manière suivante :

$$\Phi_{ij} = F_k = \sum_{anc\hat{e}tre} \left(\frac{1}{2}\right)^n (1+F_a)$$

Avec, pour chaque ancêtre commun identifié entre i et j, le nombre total d'individus n dans le pedigree jusqu'à l'ancêtre commun, et F_a le coefficient de consanguinité de chaque ancêtre commun.

Le calcul des coefficients de consanguinité et de parenté, par la méthode tabulaire se fait de la manière suivante :

$$\Phi_{ij} = F_k = \frac{1}{4}\Phi_{pp'} + \frac{1}{4}\Phi_{pm'} + \frac{1}{4}\Phi_{mp'} + \frac{1}{4}\Phi_{mm'}$$

Avec *m* et *p* les parents de *i* et *m*' et *p*' les parents de *j* (Φ_{pp} , est donc le coefficient de parenté entre *p* (père de *i*) et *p*' (père de *j*)).

L'utilisation du pedigree pour mesurer les coefficients de consanguinité est basée sur la théorie de l'identité par descendance (IBD) et considère que la consanguinité est répartie de manière homogène le long du génome. Cependant, on atteint vite les limites d'une estimation basée sur le pedigree étant donné que l'on mesure seulement la consanguinité théorique et attendue des individus et cela ne permet pas de différencier deux pleins-frères (car cette méthode ne prend pas en compte le déséquilibre de liaison et l'aléa de méiose). De plus, la fiabilité de la mesure des coefficients de consanguinité dépend de la fiabilité et de la profondeur des données généalogiques. Un pedigree incomplet ou faussé entraîne une sous-estimation des coefficients de consanguinité (Engelsma et al., 2011).

1.3.1.2.2. Sur la base de données génomiques

Plusieurs méthodes basées sur des informations génomiques ont été développées pour estimer les coefficients de consanguinité. La première est basée sur la méthode des moments et permet d'estimer le coefficient de consanguinité de chacun des individus (Ritland, 1996).

$$F_{k} = \frac{1}{L} \sum_{i=1}^{L} \left(\frac{s_{A,i} - p_{i}^{2}}{p_{i}} - \frac{s_{B,i} - q_{i}^{2}}{q_{i}} \right)$$

Avec, F_k le coefficient de consanguinité de l'individu k, basé sur *L loci*. Si l'individu est homozygote pour l'allèle A ou B du locus i, alors $s_{A,i}$ ou $s_{B,i}$ sont respectivement égaux à 1. Si le locus est hétérozygote alors $s_{A,i}$ et $s_{B,i}$ sont égaux à 0. La fréquence allélique de l'allèle A (allèle majoritaire) est p_i , et la fréquence de l'allèle B est q_i . Sur la base de la relation entre les individus, des matrices d'apparentements génomiques *G* peuvent être calculées (GRM, VanRaden, 2007) :

$$G = \frac{ZZ'}{\sum_{i=1}^{L} 2p_i q_i}$$

Avec *L* le nombre de locus considérés, p_i la fréquence dans la population de l'allèle majoritaire et q_i (=1- p_i) la fréquence de l'allèle minoritaire. La matrice **Z**' est la transposée de la matrice **Z**, qui est construite de la manière suivante : **Z** = **M** – **P**. **M** est une matrice de dimension N (= nombre d'individus) par L, spécifiant les allèles présents chez les individus génotypés. La matrice **P** est de dimension N par L contenant les fréquences alléliques dans la population de ces mêmes allèles ($P[n,l]=2p_i \times I_N$).

Plus l'apparentement entre les individus est élevé, plus le risque d'avoir de hauts niveaux de consanguinité dans la descendance l'est également. Cette méthode est basée sur les fréquences alléliques, ainsi le coefficient d'apparentement génomique estimé sera plus élevé si les individus partagent un allèle rare qu'un allèle commun. C'est pourquoi, cette méthode nécessite un bon échantillonnage de la population au risque de fausser l'estimation des coefficients de consanguinité.

Une dernière méthode basée sur les îlots de consanguinité (ou ROH) tend à devenir la méthode de référence dans l'estimation des coefficients de consanguinité. Etant donné que cet indicateur a été celui utilisé dans cette thèse, je vais maintenant détailler les raisons qui font des ROHs un indicateur de prédilection de la consanguinité ainsi que les calculs permettant de mesurer les coefficients de consanguinité à partir des ROHs.

1.3.1.2.3. Les ilots de consanguinité (ROH)

Les ROHs sont définis comme de longs segments homozygotes hérités d'un ancêtre commun et donc identiques par descendance (Figure 6 ; McQuillan et al., 2008).



Figure 6. Illustration des îlots de consanguinité (ROH). *Si l'on considère un ancêtre commun* avec deux chromosomes (1 bleu et 1 rouge), celui-ci transmettra l'un de ses chromosomes à ses descendants (+ recombinaison lors de la méiose). Lors d'un accouplement d'individus apparentés, on pourra retrouver des fragments des chromosomes de l'ancêtre commun à l'état homozygote chez l'individu consanguin, c'est ce qu'on appelle un ROH.

Une fois les ROHs identifiés pour chacun des individus, un coefficient de consanguinité peut être estimé pour chacun d'eux de la manière suivante :

$$F_{ROH,i} = \frac{\sum L_{ROH,i}}{L_{auto}}$$
 Avec, $\sum L_{ROH,i}$, la somme totale des ROHs présents dans le génome de l'individu i et L_{auto} , la taille totale du génome où il est possible de détecter un ROH.

Il a été démontré que les niveaux de consanguinité des individus sont variables le long du génome des animaux (Curik et al., 2017 ; D'Ambrosio et al., 2019). Ainsi, des individus avec le même niveau de consanguinité globale peuvent avoir une répartition de leur consanguinité différente et n'expriment donc probablement pas les mêmes effets de dépression de consanguinité. Il est donc essentiel de pouvoir localiser la consanguinité, ce que permettent les ROHs (Keller et al., 2011). Il est alors envisageable d'estimer le coefficient de consanguinité d'une région spécifique du génome en considérant les ROHs contenus seulement dans celle-ci (Figure 7).



Figure 7. Illustration du calcul d'un coefficient de consanguinité local (fenêtre noire). *Ici on ne considère que les ROHs présents dans la fenêtre étudiée, donc le ROH rouge et pas le bleu (d'après Doublet, 2020).*

Le calcul du coefficient de consanguinité se fait alors sur la base de la fenêtre considérée et non pas sur la taille totale du génome.

$$F_{ROH,region r,i} = \frac{\sum L_{ROH,region r,i}}{L_{REGION}}$$
Avec, $\sum L_{ROH,region r,i}$, la somme totale des ROHs
de l'individu i présent dans la région r, L_{REGION} ,
est la taille de la région étudiée.

Grâce à la taille des ROHs, il est également possible d'estimer l'âge des événements ayant engendré de la consanguinité. Plus un fragment homozygote est long, moins il a été cassé par recombinaisons successives et donc plus on estime son apparition récente. A l'opposé, les courts fragments ROHs correspondent à des événements anciens ayant engendré la consanguinité (Pryce et al., 2014 ; Doekes et al., 2019).

Plusieurs logiciels et méthodes associées permettent d'identifier les ROHs. Tout d'abord, le logiciel PLINK (Purcell et al., 2007 ; Chang et al., 2015) permet de facilement les détecter à l'aide d'une fenêtre coulissant le long du génome. Cependant, ce logiciel nécessite un paramétrage pertinent pour détecter les ROHs, paramétrage qui peut faire varier la taille et la position des ROHs. Ce paramétrage est également à ajuster en fonction des espèces et de la densité des génotypages (Purfield et al. 2012 ; Chang et al., 2015). Les paramètres initialement

demandés dans le logiciel sont : le nombre minimal de SNPs homozygotes dans un ROH, le nombre maximal de marqueurs hétérozygotes autorisés (en lien avec les possibles erreurs de génotypage), la taille minimale d'un ROH, la distance maximale entre deux marqueurs consécutifs et la densité de marqueurs dans un ROH. Une fois les paramètres correctement ajustés, cet outil donne de bons résultats dans l'estimation des coefficients de consanguinité (Forutan et al., 2018). Sur le même principe, une détection des ROHs peut être réalisée à l'aide du package R detectRUNS ; ce package permet également d'identifier des régions constituées seulement de marqueurs hétérozygotes (appelés ROHet).

Une autre méthode, probabiliste, a été proposée pour identifier les ROHs, basée sur un modèle de Chaines de Markov Cachées avec deux états possibles à chaque position : présence ou absence de ROH (Leutenegger et al., 2003 ; Druet & Gautier, 2017). Druet & Gautier (2017) ont également considéré l'âge d'apparition de la consanguinité, en classant les ROHs selon leur taille. Cette méthode peut être mise en place grâce au package R, RZooRoH, et présente de bons résultats dans l'estimation des coefficients de consanguinité. Une forte corrélation a été observée entre les coefficients de consanguinité calculés grâce aux ROHs détectés par le logiciel PLINK et ceux calculés à partir du package RZooRoH (Meyermans et al., 2020). La méthode basée sur le package RZooRoH est coûteuse en mémoire et en temps de calcul, par rapport à une détection de ROHs réalisée à l'aide du logiciel PLINK ou du package R detectRUNS.

Depuis la fin des années 2010, grâce à l'essor des outils génomiques, de nombreux généticiens ont cherché à estimer les coefficients de consanguinité réels (sur la base d'informations moléculaires) des individus de populations animales domestiquées. Chez la TAC, sur la base des ROHs, des coefficients de consanguinité entre 12,2 et 19,5% ont été estimés dans plusieurs populations françaises de truites domestiquées/sélectionnées (D'Ambrosio et al., 2019). Les populations commerciales de truites ont les niveaux moyens de consanguinité les plus élevés (F moyen compris entre 16,6% et 19,5%), alors qu'une population non-sélectionnée de truites arc-en-ciel a un F moyen d'environ 10%. Les estimations des coefficients de consanguinité estimés dans d'autres populations de truite arc-en-ciel sont basés uniquement sur le pedigree (Wang et al., 1999 ; 2002). Pante et al. (2001), à partir du pedigree, montra qu'après 6 générations de sélection, les niveaux de consanguinité des populations de truite arc-en-ciel se trouvaient entre 3 et 10%. Dans d'autres espèces piscicoles les coefficients

de consanguinité moyens sont, dans certains cas, comparables (saumon et turbot) aux F moyens des populations de truites françaises (Tableau 2), mais sont parfois bien plus bas (tilapia). Les premières études traitant des coefficients de consanguinité génomiques des espèces aquacoles sont très récentes par rapport aux études concernant les espèces animales terrestres.

Au sein des populations d'animaux terrestres sélectionnées, des niveaux de consanguinité, évalués par ROH soit plus faibles, similaires ou plus élevés à ceux des populations de truites françaises, ont pu être observés dans différentes espèces, races ou lignées (Tableau 2). Les niveaux de consanguinité au sein des populations domestiquées sont très variables et peuvent atteindre des niveaux élevés, et cela particulièrement dans les lignées sélectionnées (exemple : US Jersey ; lignées de porc italien ; poules pondeuses ; dindes) ou à faibles effectifs (exemple : races locales de porc, chèvre et poules). Il est donc essentiel de caractériser et comprendre les effets de la consanguinité pour la gérer au mieux dans les programmes de sélection.

1.3.2. Estimation des effets de la consanguinité sur les performances

A l'échelle d'un individu, la dépression de consanguinité se mesure en comparant la performance d'un individu consanguin (croisement plein-frère) $\overline{W_I}$ avec celle d'un individu issu d'un croisement aléatoire (Charlesworth & Charlesworth, 1999) :

$$\overline{W_R}: \ \delta = \frac{\overline{W_R} - \overline{W_I}}{\overline{W_R}}$$

Il est possible d'évaluer à l'échelle d'une population les effets de la dépression de consanguinité à partir des coefficients de consanguinité calculés pour chaque individu.

Pour cela, des modèles linéaires ou non-linéaires permettent de décrire l'effet de la consanguinité sur la valeur sélective ou les performances des individus au sein d'une population. Plusieurs études ont comparé les deux approches (linéaire et non-linéaire) et sont arrivées à la conclusion que pour des valeurs modérées de consanguinité (F < 0,20), les modèles linéaires étaient adaptés pour estimer les effets de la dépression de consanguinité (Carrillo & Slewerdt, 2010 ; Malhado et al., 2013). Classiquement, un modèle linéaire BLUP - modèle animal est utilisé avec en covariable le vecteur des coefficients de consanguinité (cf Encart 2). L'estimation des effets de la dépression de consanguinité peut se faire sur la base du niveau global de consanguinité, ou bien à l'aide d'estimations des niveaux de consanguinité locaux (Martikainen et al., 2018 ; Botero-Delgadillo et al., 2020 ; Doekes et al., 2020). Doekes et al. (2020) ont estimé l'effet de la consanguinité sur chacun des SNPs à l'aide d'une GWAS en associant une régression linéaire à chaque SNP. Pour cela, ils ont imputé pour chaque SNP l'information suivante : contenu ou non dans un ROH.

Au vu des mécanismes génétiques pouvant expliquer le phénomène de dépression de consanguinité (cf. partie 1.2.3), il est important de considérer les effets de dominance dans le modèle utilisé pour estimer les effets de la consanguinité (Toro & Varona, 2010 ; Vitezica et al., 2016). Il a aussi été montré que les phénomènes de dépression de consanguinité sont plus souvent observés suite à des événements récents d'apparition de consanguinité (Doekes et al., 2019 ; Makanjuola et al., 2020b), où les effets défavorables de la consanguinité n'ont pas encore pu être éliminés par la purge des allèles récessifs délétères au sein de la population (Kristensen & Sørensen, 2005).

Encart 2 : Modèles de la génétique quantitative

En génétique quantitative, on considère qu'un caractère quantitatif est expliqué par une multitude de gènes ayant tous de très faibles effets. Ainsi, pour comprendre et expliquer les effets génétiques d'un caractère, il est nécessaire de décrire un modèle génétique sous-jacent aux variations des phénotypes. Le modèle général permettant d'expliquer le phénotype d'un caractère quantitatif (y) se décrit simplement comme la combinaison linéaire et additive d'un effet génétique (g) (ou valeur génétique) et un effet de l'environnement (pe) (e, correspond aux effets résiduels) : $y_{ij} = g_i + pe_i + e_{ij}$

On peut décomposer la valeur génétique en trois composantes majeures : les effets additifs (a) et les effets génétiques non additifs de dominance (d) et d'épistasie (i) : g = a + d + i

Si l'on considère seulement les effets additifs, définis comme la somme des effets moyens des gènes, la valeur génétique additive d'un descendant sera en espérance : $g_i = E(a_i) = \frac{1}{2}a_m + \frac{1}{2}a_p$, le ¹/₂ traduisant le fait qu'un parent transmet en espérance la moitié de sa valeur génétique à ses descendants.

On définit la dominance comme la somme des effets d'interaction entre allèles de chaque gène impliqué dans l'expression du caractère et l'épistasie comme la somme des effets d'interaction entre allèles de *loci* différents. Il faut garder en mémoire que ces effets sont pour l'essentiel recréés à chaque génération car ils dépendent d'association particulière d'allèles (= recrée lors de l'accouplement).

Dans le but de simplifier les modèles génétiques, classiquement seul les effets additifs sont pris en compte. Toutefois, aujourd'hui des outils performants permettent de prendre en compte les effets non-additifs sans trop de difficultés. Notamment grâce au programme '*parallelef90*' développé par Vitezica et al. (2016) qui permet de construire la matrice de dominance simplement à partir des génotypes utilisés dans le modèle. L'idéal est donc de prendre en compte *a minima*, les effets additifs ainsi que les effets de dominance pour décrire les performances.

L'héritabilité (h^2) permet d'estimer ce que chaque parent transmet à sa descendance. C'est donc la part de la variance phénotypique (σ_y^2) expliquée par la variance génétique (σ_g^2) (Lush, 1937) : $h^2 = \frac{\sigma_g^2}{\sigma^2}$

De plus, si l'on considère que la variance génétique est principalement due à la variance génétique additive (on néglige la variance non-additive), on pourra écrire : $h^2 = \frac{\sigma_a^2}{\sigma_y^2}$ que l'on appelle héritabilité au sens strict.

De la même manière, on peut estimer la part des effets de dominance expliquant la variance phénotypique par le ratio : $d^2 = \frac{\sigma_d^2}{\sigma_y^2}$ Un d² fort est un indice concernant l'importance potentielle des effets de la consanguinité.



Figure 7. Illustration d'effets additifs (1) ou de dominance (2) pour locus bi-allélique (allèles A et B). Observation de la variation phénotypique en fonction du génotype.

Chez la TAC, des effets significatifs de dépression de consanguinité ont été observés sur le poids des femelles avec une réduction entre 1,7 et 5% du poids de la femelle pour une augmentation de 0,10 point du coefficient de consanguinité (Gjerde et al., 1983 ; Kincaid, 1983 ; Su et al., 1996 ; Pante et al., 2001). Des effets de dépression de consanguinité ont également été estimés sur des caractères de reproduction de la truite arc-en-ciel (Kincaid, 1983 ; Su et al., 1996), ainsi que sur la survie des descendants (Kincaid, 1983). Néanmoins, toutes ces estimations d'effets de dépression de consanguinité chez la truite arc-en-ciel sont soit basées sur la comparaison des performances d'un groupe d'individus consanguins (croisement plein-

frères) avec celles d'un groupe d'individus issus d'un croisement aléatoire, soit sur un modèle de régression linéaire basé sur des coefficients de consanguinité théoriques calculés à partir des pedigrees. Or, de nombreuses études ont montré que les estimations des effets de la dépression de consanguinité sur la base des informations généalogiques étaient moins précises que celles réalisées à partir de données génomiques (Forstmeier et al., 2012 ; Pryce et al., 2014 ; Kardos et al., 2016 ; Howard et al., 2017). C'est pourquoi réaliser, sur la base d'une information moléculaire, de nouvelles estimations des effets de la consanguinité chez la truite arc-en-ciel permettraient de préciser et d'améliorer les connaissances des effets de la consanguinité chez la truite arc-en-ciel.

1.3.3. Méthodes et outils d'identification de signatures de sélection

Le concept fondateur de la recherche de traces de sélection est l'idée formalisée par Lewontin & Krakauer (1973) que certaines différences entre populations sont le fruit d'une sélection positive susceptible d'avoir laissé des patrons de variation des fréquences alléliques localement distincts dans le génome de populations divergentes. La caractéristique clef de la sélection positive est qu'elle provoque une augmentation inhabituellement rapide de la fréquence des allèles autour du variant favorable, se produisant sur un temps suffisamment court pour que les recombinaisons ne cassent pas substantiellement l'haplotype dans lequel la mutation sélectionnée s'est produite. Une signature de la sélection positive est donc un allèle ayant un DL à longue distance inhabituel compte tenu de sa fréquence dans la population. Différentes méthodes et logiciels associés (Table 3) ont été développés pour révéler des signatures de sélection, et donc identifier des zones localement distinctes par rapport au reste du génome, soit au sein d'une unique population (intra-population), soit par différenciation entre populations (inter-population).

Dans le cadre d'une détection de signatures de sélection intra-population, les régions sous balayage sélectif auront une plus faible diversité génétique que la moyenne avec un excès d'allèles rares, et pourront présenter une concentration d'allèles potentiellement favorables impliqués dans des phénomènes d'adaptation, de sélection ou de domestication (Smith & Haigh, 1974). La recherche de signatures de sélection intra-population peut utiliser trois types d'informations génomiques : le spectre de fréquences alléliques, le déséquilibre de liaison ou la réduction de la diversité génétique (Vitti et al., 2013 ; Weigand & Leese, 2018 ; Saravanan et al., 2020). Pour détecter des signatures de sélection intra-population, il est nécessaire de partir de l'hypothèse d'une évolution neutre du génome (modèle neutre), c'est-à-dire une évolution du génome en l'absence de sélection. On cherche alors à identifier les régions du génome qui s'éloignent significativement de ce modèle nul, que l'on considérera donc sous sélection.

1.3.3.1.Signatures de sélection intra-population.

1.3.3.1.1. Exploitation du spectre de fréquences alléliques

Plusieurs méthodes de détection de signatures de sélection se basent sur les traces que la sélection laisse sur le spectre de fréquences alléliques.

Le D de Tajima (Tajima, 1989) permet d'estimer le polymorphisme par fenêtres génomiques. Le D de Tajima est calculé comme la différence entre deux mesures : le nombre moyen de séquences différentes deux à deux et le nombre total de sites polymorphes trouvés sur l'ensemble des séquences d'une population. Ainsi, un D négatif correspondra à un excès d'allèles rares associé à une réduction de la diversité génétique, et indiquant donc une trace de sélection. Un D positif correspondra à des événements de sélection équilibrante (le nombre moyen de différences entres séquences sera supérieur à la mesure de diversité basée sur le nombre de site polymorphes).

Une deuxième méthode est le H de Fay et Wu (2000), évalué comme la différence entre la mesure de la diversité basée sur le nombre moyen de différences entre séquences, et une mesure de la diversité sensible aux allèles dérivés à haute fréquences (*versus* la fréquence des allèles ancestraux). Par rapport au D de Tajima, cette méthode permet de différencier un événement de sélection positive et négative. Un H négatif correspondra à une région ayant un excès d'allèles dérivés à hautes fréquences, indiquant donc une trace de sélection positive.

Le rapport de vraisemblance composite (CLR) est une troisième approche qui permet d'évaluer l'asymétrie du spectre des fréquences alléliques parmi plusieurs *loci* (fenêtre génomique), tout en incorporant le taux de recombinaison local afin d'éliminer les faux positifs dus aux événements démographiques (Nielsen, 2005).

Malgré l'ancienneté de ces méthodes qui ont fait leurs preuves, les tests basés sur les fréquences alléliques sont grandement affectés par l'histoire démographiques des populations. Une variation importante de la taille de la population (goulots d'étranglement, expansion rapide de la population) peut artificiellement faire augmenter la fréquence des allèles rares, induisant une détection de signature de sélection artéfactuelle. De la même manière un « biais de recrutement » lié à l'étude d'un échantillon de la population, peut fausser les fréquences alléliques réelles de la population et donc l'identification de signatures de sélection.

1.3.3.1.2. Exploitation du déséquilibre de liaison

Pour ce type de méthodes, la notion de liaison génétique est sous-jacente. En effet, dans le cadre de signatures de sélection récente, la recombinaison génétique n'a pas le temps de casser les haplotypes sélectionnés. La diversité génétique est donc réduite dans l'entourage du locus sous sélection, entraînant la création de longs haplotypes à faible diversité génétique dans la population, c'est ce qu'on appelle un balayage sélectif (cf. partie 1.2.2.1.4. la sélection). Les méthodes basées sur le déséquilibre de liaison (DL) sont puissantes pour détecter des balayages sélectifs forts (c'est-à-dire, de longs haplotypes en forte fréquence) en cours d'établissement (non fixés).

La mesure EHH (= *Extended Haplotype Homozygosity*) permet d'évaluer le degré de DL entre un SNP focal et les SNPs situés à différentes distances physiques x du locus d'étude. L'EHH est définie comme la probabilité que deux chromosomes choisis au hasard et qui portent l'haplotype focal, soient identiques par descendance pour l'ensemble de l'intervalle entre le SNP focal et le point x (Sabeti et al., 2002). La décroissance DL, et donc l'échelle relative du DL à "courte" et "longue" distance, dépend des taux de recombinaison locaux. Notre test de sélection positive consiste à trouver un haplotype central avec une combinaison de fréquence élevée et d'EHH élevée, par rapport à d'autres haplotypes centraux au locus. Une statistique nommée iHS (*integrated Haplotype Score*) a été proposée par Voight et al (2006) pour comparer les profils EHH intégrés obtenus pour un SNP dans sa version ancestrale versus mutée. Les valeurs extrêmes de l'iHS sont des traces de sélection positive car un haplotype de base avec un EHH inhabituellement élevé et une fréquence élevée dans la population indique la présence d'une mutation qui s'est propagée à travers la population plus rapidement que prévu sous un modèle d'évolution neutre.

Un aspect attrayant de cette approche est que les divers haplotypes de base à un locus servent de contrôles internes les uns pour les autres, en ajustant toute irrégularité dans le taux de recombinaison local et donc en permettant de distinguer les traces de sélection des signaux démographiques.

Cette mesure nécessite le phasage des données de génotypage, c'est-à-dire la reconstruction des haplotypes pour chacun des individus. Cette étape est cruciale, car elle va conditionner la précision de la détection des signatures de sélection.

Une autre méthode basée sur le DL a été développée, le LDD (*Linkage Disequilibrium Decay*). Contrairement à la statistique EHH, cette méthode ne nécessite pas d'informations haplotypiques (phasage) mais s'appuie sur les mêmes principes que l'EHH.

1.3.3.1.3. Exploitation de la diversité génétique

Deux méthodes se focalisent sur l'identification de régions génomiques ayant subi une réduction du polymorphisme par rapport au reste du génome. Ces méthodes sont basées sur les ilots de consanguinité (ROH) (McQuillan et al., 2008) ou bien sur des groupements d'hétérozygotie (Rubin et al., 2010).

Dans le cadre de l'utilisation des ROHs, on recherche des régions où une partie importante de la population partage de longs segments homozygotes, ce qui correspond à une baisse de la diversité génétique de la population sur cette portion du génome.

Concernant les groupements de variants hétérozygotes, cela consiste à simplement compter le nombre d'hétérozygotes dans une fenêtre par rapport à la moyenne du nombre d'hétérozygotes dans le génome (Rubin et al., 2010), permettant d'identifier les régions en déficit ou bien au contraire en excès d'hétérozygotes.

1.3.3.2. Signatures de sélection inter-populations : différenciation entre deux populations

Les signatures de sélection détectées entre populations permettent d'identifier les points de divergence, c'est à-dire de forte différenciation entre deux populations (Zhao et al., 2015). On peut alors mettre en lumière des régions génomiques sélectionnées dans une population mais sous évolution neutre (= absence de sélection) au sein de l'autre population. Pour cela, il est possible d'utiliser soit simplement l'information des *loci* (SNPs), soit celle des haplotypes.

Deux méthodes existent pour différencier les populations en approche par locus : l'indice de fixation de Wright (Fst ; Wright, 1931) et le test FLK (Test de Lewontin-Krakauer ; Bonhomme et al., 2010). Un indice de fixation (Fst) localement extrême par rapport à la distribution des Fst le long du génome suggère la présence d'une sélection positive ou équilibrante dans l'une des deux populations. Tout comme les méthodes de détection intrapopulation basées sur les fréquences alléliques, cette méthode peut conduire à la détection de faux positifs du fait de la structure des populations (Nei & Maruyama, 1975). La statistique FLK correspond à un Fst implémenté d'une matrice de parenté entre les populations. Cet ajout permet de corriger le test pour la structure des populations. Ainsi, la statistique FLK tient compte des changements dynamiques de la taille effective des populations au fil du temps et réduit donc le risque de détecter des faux positifs par rapport à l'approche Fst.

Concernant les approches haplotypiques de détection des signatures de sélection, une première méthode est basée sur les EHH (cf. section 1.3.3.1.2.). La statistique XP-EHH (Cross Population EHH, Sabeti et al., 2007) compare les profils intégrés d'EHH de deux populations pour identifier les différences majeures. Cette méthode est utilisée pour détecter les balayages sélectifs dans lesquels un allèle a approché ou atteint la fixation dans une population tout en restant polymorphe dans l'autre. La seconde méthode est hapFLK (Fariello et al., 2013), qui est une extension haplotypique de la statistique FLK. Cette méthode, contrairement à la statistique XP-EHH, ne nécessite pas forcément le phasage des données.

En fonction des méthodes utilisées, plusieurs problèmes et biais peuvent apparaitre. En effet, il n'y a pas un seul modèle d'évolution neutre (évolution des génomes non soumis à la sélection) mais de multiples modèles d'évolution du génome dépendant de l'histoire des populations. Effectivement, une population peut ne pas être soumise à sélection mais subir différents événements démographiques (goulots d'étranglements, expansion rapide, etc.) agissant alors sur le profil du polymorphisme sur tout le génome, induisant la détection de faux positifs lors de l'identification des signatures de sélection. En parallèle, la sélection peut être forte sur le phénotype, mais agir sur une multitude de gènes à effet faible, la sélection ne laisse donc pas toujours les mêmes signatures dans le génome. C'est pourquoi, l'utilisation d'approches variées pour détecter des signatures de sélection permet d'identifier des traces de sélection ne pouvant pas être détectées par toutes les métriques.

A Retenir – 1.3. Méthodes d'évaluation de la diversité génétique et d'identification de signatures de sélection

Les ROHs permettent de calculer des coefficients de consanguinité individuels réels. Cette mesure génomique devient la méthode de référence pour estimer des coefficients de consanguinité.

Les populations commerciales de truite arc-en-ciel ont des niveaux de consanguinité globalement élevés et très variables le long des génomes.

- Les effets de dépression de consanguinité chez la truite arc-en-ciel n'ont jusqu'à présent jamais été estimés sur la base d'informations génomiques.
- La prise en compte des effets de dominance semble importante pour comprendre les mécanismes génétiques sous-jacents à la dépression de consanguinité.
- La sélection laisse des traces dans le génome : des signatures de sélection identifiables à l'aide d'approches et d'outils variés.
- Les régions génomiques sous sélection peuvent contenir des gènes d'intérêt liés à des phénomènes tels que la *fitness* des individus, la domestication ou la sélection des populations.

1.4. Questions soulevées

L'étude réalisée préalablement à mon projet de thèse (D'Ambrosio et al., 2019) concluait que les processus récents de domestication et de sélection avaient amené à réduire significativement la diversité génétique des populations domestiquées et sélectionnées de truite arc-en-ciel, amenant les populations sélectionnées à des niveaux élevés de consanguinité (~20%) et des effectifs efficaces inférieurs à 50. Ces résultats demandent à être investigués en profondeur car les plans d'accouplement actuellement réalisés sont des factoriels partiels faisant intervenir à chaque génération environ 70 à 100 reproducteurs de chaque sexe, soit des effectifs efficaces espérés compris entre 140 et 200 reproducteurs (Dupont-Nivet et al., 2006). De plus, dû aux niveaux importants de consanguinité dans les populations de truites, des phénomènes de dépression de consanguinité peuvent y être observés notamment sur des caractères de taille et de reproduction (Kincaid, 1976 ; Su et al., 1996 ; Rye & Mao, 1998 ; Pante et al., 2001 ; Wang et al., 1999, 2002 ; Naish et al., 2013 ; Waters et al., 2020).

Par ailleurs, les travaux préliminaires des localisations des ROHs par Jonathan D'Ambrosio (résultats non publiés) laisse supposer que les zones d'homozygotie partagées par de nombreux individus intra ou entre populations ne sont pas réparties aléatoirement le long du génome, mais correspondent à des zones potentiellement enrichies en gènes impliquées dans les processus de développement embryonnaire, immunité et reproduction.

Dans ce contexte, mon projet de thèse est d'étudier **l'évolution de la diversité génétique dans des populations domestiquées de truites arc-en-ciel**. La finalité de mes travaux est triple :

- 1- Comprendre les verrous reproductifs amenant à un fort accroissement de la consanguinité en élevage (même sans sélection artificielle)
- 2- Identifier les principales régions du génome qui contribuent à la dépression de consanguinité
- 3- Identifier les signatures de sélection liées à la domestication et à la sélection

Dans un premier temps, nous avons cherché à valider l'hypothèse émise dans l'étude de D'Ambrosio et al. (2019) afin d'expliquer la perte de diversité génétique dans des populations non-sélectionnées de truites arc-en-ciel. L'hypothèse concernait la présence de mécanismes lors du développement embryonnaire des descendants, induisant un déséquilibre de contribution parentale à la génération suivante. Ensuite nous avons essayé de comprendre les mécanismes impliqués dans la survie des alevins. Ainsi, pour cela, les questions suivantes ont été traitées dans le chapitre 2 : quels sont les verrous reproductifs conduisant à une perte de diversité génétique dans une population domestiquée de truite arc-en-ciel ? Peut-on identifier des effets de dépression de consanguinité sur la survie embryonnaire ? Quels sont les composantes génétiques de la survie précoce ? Quelles sont les caractéristiques maternelles associées à une meilleure survie des alevins ?

Nous savons qu'au sein des populations de truites arc-en-ciel françaises, les niveaux de consanguinité sont très variables le long du génome (D'Ambrosio et al., 2019). L'objectif du chapitre 3, était de caractériser les effets locaux de la consanguinité dans une population commerciale de truites. Trois questions importantes ont été traitées dans ce chapitre. La première question était de **quantifier les effets globaux de la consanguinité sur les performances de taille et de reproduction des truites**. La seconde question était **d'identifier les zones du génome associées à ces variations de performance : Des régions particulières sont-elles plus souvent impliquées ? Sont-elles liées à des événements récents d'accouplements entre reproducteurs apparentés ? La dernière question était de savoir si nos observations corroboraient l'hypothèse privilégiée pour expliquer le phénomène de dépression de consanguinité, à savoir le rôle majeur d'allèles récessifs à effet délétère.**

La dernière étape de ce projet consistait à identifier les signatures de sélection, positives ou équilibrantes, communes entre plusieurs populations de truites arc-en-ciel domestiquées. Cette étude est présentée dans le chapitre 4, nous avons pu répondre aux questions suivantes : **Existe-t-il des régions du génome des truites arc-en-ciel, très homozygotes, sous sélection positive conservées entre plusieurs populations domestiquées ? Ou bien des régions hétérozygotes, sous sélection é également partagées entre plusieurs populations domestiquées ? Ces régions sont-elles simplement en lien avec des fonctions essentielles dans la survie et la reproduction des truites ? Ou sont-elles fortement liées au processus de domestication des populations ?**

Pour finir, dans un 5^{ème} chapitre et à la lumière des connaissances acquises dans cette thèse, je proposerai des éléments de réflexion pour valoriser et gérer au mieux la diversité génétique à chaque étape d'un programme de sélection truiticole.

Chapitre 2

Etude du succès reproductif et de la survie embryonnaire dans une lignée domestiquée de truite arc-en-ciel

Une perte de diversité génétique non négligeable a été observée dans une lignée expérimentale de truites arc-en-ciel constituée par l'INRA et entretenue depuis le début des années 1980 sans sélection volontaire (D'Ambrosio et al., 2019). La forte variation du succès reproducteur généralement observée chez les poissons a été suggérée comme mécanisme premier susceptible d'expliquer cette baisse de diversité génétique. La valeur sélective (« fitness ») est un concept central de la biologie évolutive qui décrit le succès reproducteur d'un individu, succès qui dépend de sa fécondité propre et de la survie de sa descendance jusqu'à la maturité sexuelle. Ces deux composantes méritent de l'attention chez la truite arc-en-ciel en raison de leur impact sur l'équilibre ou le déséquilibre induit dans les contributions parentales à la génération suivante. En outre, la survie des individus est un caractère associé à la robustesse particulièrement important à considérer chez les poissons car elle quantifie la résistance globale d'un individu aux multiples facteurs de stress environnementaux

Par conséquent, dans ce chapitre nous avons étudié la variance des tailles de familles, ainsi que les facteurs biologiques ayant une incidence sur la survie précoce chez la truite arcen-ciel. Plus précisément, nous avons souhaité répondre aux questions suivantes : **Quels sont les verrous reproductifs conduisant à une perte de diversité génétique dans une population domestiquée de truite arc-en-ciel ? Peut-on identifier des effets de dépression de consanguinité sur la survie embryonnaire ? Quels sont les composantes génétiques de la survie précoce ? Quelles sont les caractéristiques maternelles associées à une meilleure survie des alevins ?** Pour cette étude nous avons réalisé une expérimentation à la Pisciculture Expérimentale INRAE des Monts d'Arrée (PEIMA) afin d'évaluer la présence d'un déséquilibre significatif de contribution parentale (15 mères et 9 pères) dans la cohorte des descendants (945 descendants). Nous avons évalué la survie à trois stades précoces : stade œillé, éclosion et à trois semaines après la première alimentation. Nous avons cherché à identifier les facteurs biologiques (consanguinité individuelle et parentale, phénotype maternel : taille/poids des femelles ; poids de la ponte, taille des œufs, nombre d'œufs dans la ponte) impactant la survie précoce.

Conclusion du Chapitre 2

Cette étude a permis de mettre en évidence un déséquilibre de contribution des mères à la génération suivante au sein d'une lignée domestiquée.

L'analyse génétique de la survie embryonnaire a révélé une très faible héritabilité mais d'importants effets maternels et de dominance. Malgré une variance de dominance élevée, la survie des alevins ne semble pas affectée par leur niveau de consanguinité, ni ceux de leurs parents. Notons toutefois que les niveaux de consanguinité observés étaient modérés dans cette étude (en moyenne 0.10).

La survie des alevins s'est révélée positivement corrélée avec la fécondité des mères (nombre d'œufs) et négativement corrélée avec le poids (après ponte) de la mère. En revanche, survie précoce et taille de l'œuf ne semblent pas corrélées.

En raison des forts effets de dominance observés sur la survie des alevins, l'exploitation des effets d'hétérosis par le croisement de géniteurs génétiquement divers pourrait être intéressant. De plus, la sélection des femelles les plus fécondes pourrait aider les éleveurs à éviter le déséquilibre de contribution maternelle à la génération suivante et ainsi préserver la diversité génétique dans les programmes de sélection.

Les différents résultats obtenus dans ce chapitre ont été présentés sous la forme d'un poster au congrès *European Aquaculture Society* (EAS) et d'une présentation orale aux *Journées Techniques du Sysaaf* en 2021. L'ensemble des résultats obtenus a fait l'objet d'un article « *Maternal and genetic effects on embryonic survival from fertilization to swim up stage and reproductive success in a farmed rainbow trout line* » soumis à la revue *Aquaculture Reports* en octobre 2022 et présenté dans ce chapitre.

Maternal and genetic effects on embryonic survival from fertilization to swim up stage and reproductive success in a farmed rainbow trout line

Highlights

- Dam contribution to the next generation is moderately unbalanced in farmed trout
- Maternal and non-additive genetic effects are the main factors explaining early survival
- Within the range studied, inbreeding is not a significant player in early survival
- Small females but high fecund females show better survival of their offspring
- Eggs of over-average size produce more abnormal alevins and lower early survival

Abstract

Reproductive success and offspring survival until sexual maturity are essential traits both for fish fitness and aquaculture development. Variation in offspring's survival among family results in unbalanced parental contributions to the next generation and may explain the loss of genetic diversity observed in some farmed populations. Therefore, we studied the variance in parental contributions to a progeny cohort, as well as the biological factors impacting offspring early survival in rainbow trout. The data consisted of 945 individual survival observations from fertilization to the juvenile stage from 135 full-sib families of the INRAE experimental synthetic line. Survival was assessed at eyed-egg stage, hatching, and 3 weeks after first feeding. We used a full-factorial mating design to partition phenotypic variance in early survival traits into maternal and additive genetic effects under threshold GBLUP models considering the inclusion of genomic information for 32,725 SNP. Average offspring survival proportions were 91.0% at the eyed-egg stage, 87.2% at hatching, and 84.4% three weeks after first feeding. Significant unbalanced dam contributions were observed at the eyed-egg and hatching stages. Low heritability was estimated for early survival traits (h²=0.20±0.12 and 0.13 ±0.09 for survival from egg-eyed stage and, respectively, hatching and first feeding), revealing that additive genetic variance was not significantly different from zero, while maternal effects explained a larger part ($c^2=0.37\pm0.16$ and 0.15 ± 0.07 , respectively) of the phenotypic variances. Phenotypically, offspring early survival was positively correlated with dam fecundity, while it was negatively correlated with dam post-spawning weight. Negative, but not significant association was observed between early survival and dam's average egg weight. If a study of genetic correlations confirms the phenotypic trends observed here, promoting high fecund females should help the breeders to increase offspring early survival and to maintain genetic diversity in breeding programs.

1. Introduction

In animal breeding, a major goal in the context of global environmental changes (climate change, acidification, eutrophication, water resources, etc.) is that animals should be robust against multiple environmental disturbances and stressors throughout their life-span. Therefore, there is a growing interest in selecting for robustness in farm species, as it allows promoting less-controlled and low-input systems where rearing conditions are more variable and unpredictable (Phocas et al., 2016). Survival is an ultimate robustness trait in fish breeding because it measures an individual's resistance to multiple mortality factors in a specific environment (Vehviläinen et al., 2008). Nevertheless, the first step to reach this ultimate goal is to ensure a high reproductive success through high fecundity of individuals linked to high survival of embryos and juveniles. In rainbow trout, little is precisely known about survival at embryo and larval stages, but juvenile fingerling survival is estimated at over 90% (Vehviläinen et al., 2010). Males are sexually mature at 1 or 2 years-old, while females attain maturity later at 2 or 3 years-old. In the wild, most fish only spawn once or twice in their lifetime (Christie et al., 2018), but females may reproduce once a year for 2 or 3 years in farming conditions. In good farming conditions, 2-year-old dams can produce 4,700 eggs on average, corresponding to around 2,300 eggs per kg of body weight (D'Ambrosio et al., 2020).

The contributions of genetic and maternal environmental effects to offspring survival can shift during development. Maternal components tend to be larger at early life (egg and alevin) stages because of the influence of maternal investment, such as egg quality, whereas additive genetic effects tend to be larger at later life (fry) stage, as shown in Atlantic salmon (Houde, 2015) and more generally in any animal species (Cheverud et al., 1983). Several studies in salmonids and carps have shown small sire effects but large dam effects on early survival (Herbinger et al. 1995; Fishback et al. 2002; Vandeputte et al. 2004; Houde et al., 2013). The genetic architecture of early survival traits was investigated under sire-dam genetic models in salmonids species (Kanis et al., 1976; Rye et al., 1990; Vehviläinen et al., 2008; Houde et al., 2015). All studies concluded that heritability of early survival was low to moderate, but impact of non-additive genetic factors and maternal environmental effects was important.

In fish breeding, high unbalanced progeny numbers between parents can be observed under mass spawning. Sperm competition under hatchery conditions using pools of sperm is a wellknown phenomenon explaining unbalanced sire contributions in salmonids (Gharrett and
Shirley, 1985; Gage et al., 2004) and carps (Kaspar et al., 2008). One of the consequences of the high variation in fish reproductive success and family size is the decrease in effective size and subsequent loss of genetic diversity in the next generation (Wedekind et al., 2007). Such phenomenon has been suggested as a likely factor to explain the observed loss of genetic diversity in a farmed rainbow trout line that was kept unselected since the early 1980s (D'Ambrosio et al., 2019). In order to identify the key factors that may explain variance in reproductive success and thus loss of genetic diversity in a domesticated population of rainbow trout (*Oncorhynchus mykiss*), we designed an experiment to determine maternal and genetic factors impacting offspring survival during embryonic and early larval development (from fertilization to three weeks after the first feeding). This topic has not been covered so much so far, and to our knowledge, no study had genotyped several hundreds of individuals to accurately follow parental contributions and assess genetic parameters of offspring survival. Two main issues are raised in this paper: how do the early larval stages affect the variance in family size in farmed trout? What are the main genetic and maternal biological factors explaining variation in reproductive success and alevin survival in farm conditions?

2. Materials and Methods

Experimentation was conducted at the INRAE experimental facility PEIMA (Sizun, France – Agreement number B29-277-02).

2.1. Population

The INRAE synthetic line was initially developed by inter-crossing several domesticated lines of rainbow trout to create a population with large genetic variability. The line was constituted from a mixture of French farmed populations with some new introductions from Denmark and the USA in the early 1980s and then closed to outside germplasm (D'Ambrosio et al., 2019). Since then, the population has been maintained without intentional selection using a full factorial mating design between randomly chosen parents. About 60 dams and 80 sires were used at 2 years of age to produce each progeny cohort. An incident in the experimental facility led to the production of the 2019 study cohort from parents bred at 3 years of age.

2.2. Experimental mating design

A full factorial mating plan was performed between 15 ovulated dams and 9 fluent sires of the INRAE rainbow trout synthetic line. The 3-year-old dams and sires were randomly divided into 3 groups of 5 females and 3 males, respectively. The groups of males were named Ma, Mb, and Mc, and males were labeled from 1 to 3 within their group name. In the same way, female groups were named Fa, Fb, and Fc, with a label from 1 to 5 for females within their group name. An ovulation checking was performed once a week, and brooders were maintained on average at 9°C during the spawning season, to limit the occurrence of overripe eggs, as stated by Sakai (1975) and Bry (1981). Oocytes from females of the same group were gently mixed before the fertilization process as routinely performed on the INRAE experimental facility. To avoid sperm competition (Pilastro et al., 2002; Wedell et al., 2002), the fertilization of 35 ova from each female group (i.e. 7 ova per female) was carried out male-by-male (Figure 1).



Figure 1. Experimental mating design between the 3 male and 3 female groups and distribution of fertilized eggs in 9 incubators (from A to I).

For each male, 1 mL of sperm was mixed with 1 mL of StorFish® (IMV, France), a dilution and preservation medium for salmonid milt. For each female group fertilization, 0.20 mL of sperm/StorFish mixture of one male was added to the group of 35 eggs. Each pool was then mixed with 15 mL of ActiFish solution (Supplementary Table A.1) to spread sperm over all the oocytes, and spring water was added 5 minutes later to activate oocyte fertilization. One hour after fertilization, all 105 eggs from a small factorial plan were grouped together in the same incubator until the eyed egg stage. The full mating design thus included 9 small factorial plans (each group of 5 females mated to each group of 3 males), generating 9 batches of 105 eggs placed in 9 egg incubators (named A to I) as described in Figure 1. The 9 batches were duplicated to assess the consistency of the quantification of parental contributions at the progeny eyed egg stage. Incubators were positioned in the hatching trough as in Supplementary Figure A.1 with duplicate batches facing each other.

To summarize figures in this experimental mating design, each sire could fertilize 105 eggs in each replicate, and each dam gave 63 eggs, and each pair may have up to seven offspring observed at the eyed egg stage (20 dpf at 12°C). Totally, 945 eggs per replicate were fertilized.

2.3. Dam phenotypes

Dam phenotypes were measured on the day of spawning. Among the 17 females collected, two females were discarded due to the presence of blood in the egg mass for the first one and of over-ripe eggs for the second one.

Female post-spawning weight (PW in g) and the fork length (FL in mm), spawn weight (SW) and the weight of the coelomic fluid (CF) were recorded. Two batches of 50 eggs were randomly collected from each egg mass to obtain the weight of 50 eggs and then, by dividing by 50, an average egg weight (EW) for each female. The ratio SW / EW allowed us to estimate the egg number in the spawn (EN). Then, the relative fecundity of each dam (RF) was calculated as EN/PW.

An additional 20 g sample of each egg mass was taken to get an accurate estimate of egg diameter (ED) and its coefficient of variation to assess spawn heterogeneity. To do so, a picture of the egg sample after 24h of hydration in spring water was obtained using the *VisEgg* system (Cardona et al., 2020), a dedicated shooting system consisting of a light tablet and digital SLR camera (canon EOS 1000D, resolution: 10.1 M pixels). Each picture was analyzed with *Visilog*

7.3 software (Thermo Scientific) to allow the automatic detection and measurement of each egg's diameter. In each 20 g sample of egg mass, there were, on average, 318 oocytes.

2.4. Offspring phenotypes

Standard husbandry practices were followed, with a daily bath with bronopol and daily dead eggs removal and counting. At the eyed egg stage, there were still 890 embryos in the first replicate and 858 in the second. All 890 embryos from the first duplicate of the experimental mating were sampled to be genotyped for parentage assignment. This first duplicate was only used to get the first estimate of parental contributions at the eyed egg stage. Due to the low number of eggs considered per mating pair, we were willing to assess the consistency of these early parental contributions by comparing estimates from two replicates. The second set of 858 embryos remained under observation from the eyed egg stage until the end of the experiment, three weeks after the first feeding (65 dpf at 12°C). All dead fry were collected each day, and the presence of malformation (spine, head or caudal fin) was recorded. In addition, fry that did not complete yolk sac absorption were considered malformed. All fry (dead or alive) were sampled for genotyping.

2.5. Genotypes and parentage assignment

Genotyping was performed at the INRAE Gentyane Genotyping Platform (Clermont-Ferrand, France). The 890 offspring of the first replicate were genotyped for parentage assignment using 96 SNP in KASPar technology. Dynamic Array[™] IFC 96*96 chips were used with Biomark[™] HD Reader to perform the competitive PCR and chip reading. The Fluidigm® SNP Genotyping Analysis software was used to analyze the genotyping results. The panel of 96 SNP was chosen among the SNP from the Axiom[™] Trout Genotyping array distributed throughout the whole genome and have a minor allele frequency (MAF) above 0.30 in the five French rainbow trout lines described in D'Ambrosio et al. (2019). This 96 SNP-panel is presented in Table A.2. The 24 parents and the 858 offspring from the second replicate were genotyped for 57,501 SNP using the Axiom[™] Trout Genotyping array (Palti et al., 2015). The quality control of genotyped SNP was performed as described by D'Ambrosio et al. (2019) to remove SNP with probe polymorphism and multiple locations on the trout genome. Only the 32,725 SNP with a call rate higher than 0.97, a test for the Hardy Weinberg equilibrium with a p-value >0.0001, and a MAF higher than 0.05 were retained for further analysis. All missing genotypes for the 32,725 SNP were imputed using FImpute software with default parameters (Sargolzaei et al., 2014).

We used the R package *APIS* (Griot et al., 2020) to assign offspring of both replicates to their parents using a likelihood approach with decision rules based on the observed distributions of Mendelian transmission probabilities. We considered a maximum threshold of 1% for parentage assignment error.

2.6. Inbreeding coefficient calculation

Runs of homozygosity (ROH) were identified for each fish using the PLINK v1.9 homozyg function (Chang et al., 2015), as defined by D'Ambrosio et al. (2019), with the following parameters: '--homozyg-kb 1000 --homozyg -window-snp 30 --homozyg-snp 30 --homozyg-gap 1000 --homozyg-density 100 --homozyg-het 1'.

The inbreeding coefficient (F_i) for any fish was calculated as the sum of ROH lengths $(\sum Length_{ROH,i})$ in this individual *i* divided by the total length of the autosomal genome covered by SNPs (*LGenome*): $F_i = \frac{\sum Length(ROH_i)}{LGenome}$

The total size of the autosomal genome covered by SNPs (= 1,874 Mb) was considered as the length of the genome, removing gaps of more than 1 Mb without any SNP from the total size. Relatedness between pairs of parents was recovered using identity by descent (IBD) estimates from PLINK v1.9 software (*genome* function) (Purcell et al., 2007).

2.7. Statistical analyzes

Parental contributions were derived by counting each parent and pair's number of alive and dead progeny. With the help of R package *stats*, fisher exact tests were performed (*fisher.test* function) to assess potential unbalanced parental contributions to alive offspring at three stages: at the eyed egg stage for both replicates, at hatching, and 3 weeks after the first feeding for the second replicate. To control from multiple testing, the false discovery rate (FDR) method by Benjamini and Yekutieli (2001) was used to compare contributions two-by-two (*p.adjust* function).

In addition, offspring survival was evaluated from the day of fertilization to the time of the three stages for the second replicate: eyed egg stage (Se), hatching (Sh), and 3 weeks after first feeding (Sf). Survival was also assessed between stages from eyed egg to hatching (Seh) and from hatching to 3 weeks after first feeding (Shf). Pearson correlations were computed between maternal phenotypes and offspring survival rates.

To assess the importance of genetic and maternal factors on early survival, we considered two

phenotypes defined as binary traits: alive or dead from eyed-egg to hatching stages and from eyed-egg stage to three weeks after first feeding. From eyed-egg to hatching stages, 36 dead and 822 alive individuals were counted; 62 dead and 796 alive were counted from eyed-egg stage to the end of the experiment. The following genomic best unbiased prediction (GBLUP) models were considered to describe the vector of phenotypes (\mathbf{y}) of the 858 offspring alive at the eyed-stage and genotyped with the 57K chip.

Various genetic models (A- additive; AM- additive + maternal; AMD- additive + maternal dominance effects) were tested either considering (threshold model) or ignoring (linear model) the binary nature of the survival traits. The full tested GBLUP model described y under a linear (underlying) scale as: $y = X\beta + Za + Wd + Mc + bF_p + b_{sire} F_{sire} + b_{dam} F_{dam} + e$

where β , **a**, **d**, **c** and **e** are the vectors of fixed incubator effects and random additive genetic effects, dominance deviation effects, maternal effects and residual effects, respectively. **X**, **Z**, **W** and **M** are the incidence matrices for β , **a**, **d** and **c**, respectively. The vectors **a** and **d** included the additive and dominance genetic values of the 858 individuals related through the genomic additive relationship matrix **G** and the dominance relationship matrix **D**. The **G** and **D** genomic matrices were built using the parallelef90 program (Vitezica et al., 2013).

The regression coefficients b, b_{dam} , b_{sire} on y of the vectors F_p , F_{dam} , F_{sire} , respectively, account for individual (progeny) and parental inbreeding effects on the studied performance.

Whatever the model, there were no significant effects of parental inbreeding levels, so these effects were removed for the analysis. In addition, while the AMD linear model converged and gave the lowest AIC (Table A.4), we could not make converged the AMD threshold model.

Therefore, the final model retained as main result for the analysis and discussion of the results was: $y = \beta + Za + Mc + bF_p$

The two traits were analyzed separately using BLUPf90 package (Misztal et al., 2014) and the AIREMLF90 program (Thompson et al., 2005) for linear models or THRGIBBSF90 program (Tsurata & Misztal, 2006) for threshold models. With the threshold model, the variance components were estimating using a Gibbs sampler with 200,000 cycles, 10,000 cycles of burnin and 1 sample was kept every 40 cycles for posterior analysis. Convergence was checked by graphical inspection of both samples and posterior distributions of the parameters. All of these checks were implemented in POSTGIBBSf90 program (Aguilar et al., 2019).

3. Results

3.1. Genomic similarities among parents

The average inbreeding coefficients were close to each other for dams (12%) and sires (11%), with similar minimum values around 7% (Table 1). However, one dam had a very high inbreeding coefficient (28%) compared to all other parents (Figure 2).

The majority of the parents were almost unrelated to each other (IBD $\leq 5\%$ - Figure 2). However, two pairs of parents were related with IBD values consistent with a half-sib relationship (ranging from 0.20 to 0.30). On average, the inbreeding coefficient of the progeny was 0.10. Even for the two-parent pairs that were significantly related, the inbreeding coefficient of offspring was never extreme and did not exceed 0.25 (Table 1).

3.2. Offspring survival rates and parental contributions to the next generation

3.2.1. From fertilization to eyed egg stage (replicate 1 and 2)

From fertilization to the eyed egg stage, significant higher mortality was observed in the second replicate (R2), with 8.99% of dead offspring compared to 6.03% of dead offspring in the first replicate (R1). However, no significant (p-value > 0.05) difference between the offspring survival of each parent between both replicates was observed (Figure 3). Dams with a larger number of dead offspring in the first replicate generally also had a larger number of dead offspring in the second replicate.

In both replicates, disequilibrium in parental contribution, measured as alive eyed egg, was observed from fertilization to the eyed egg stage for dams but not for sires (Table 2).

3.2.2. From fertilization to three weeks after the first feeding (replicate 2)

In Tables 3 and 4, offspring survival rates at different stages in replicate 2 are presented. Offspring survival rate from fertilization to 3 weeks after the first feeding (Sf) varied from 63.5 % to 95.2% among dams (Table 3) and from 78.1% to 91.4% among sires (Table 4). Larger differences in offspring survival were observed between dams (up to 33.3 % -unit) than between sires (up to 13.3 % -unit) at all stages. Statistically significant unbalanced contributions were only observed for dams (Table 3). Even if an unbalance between dams was seen on Sf, from hatching to three weeks after the first feeding (Shf), no significant effect of the dam was observed. In addition, no significant effect of the dam-sire pairs was observed, but this can be due to the low number (7) of offspring per pair.

Figure 4 shows the number of dead offspring from fertilization to eyed egg stage, from eyed egg stage to hatching and from hatching to three weeks after the first feeding for each dam or sire. Dams and sires were classified according to the number of their dead offspring at the end of the experiment, with the highest number of total dead offspring to the left and the lowest to the right. Three dams have significantly higher offspring mortality than the three best dams with the lowest numbers of dead offspring (Table A.3). No significant difference for the number of dead offspring was observed across sires. It appears that both paternal and maternal offspring survival were not significantly correlated between the different stages (Table 5).

3.3. Potential sources of imbalance in parental contributions

3.3.1. Quantification of genetic and maternal effects on offspring survival

Early survival variables had low heritability values of 0.196 for Seh and 0.134 for Sef under threshold models. Those values that were not statistically different from zero (Table 6). Slightly higher proportions of phenotypic variance were explained by the common maternal effects (including both genetic and environmental factors) estimated at 0.368 and 0.147, respectively for She and Sef (Table 6).

Under linear AM models (Table A.4), early survival variables had very low heritability values of 0.015 and 0.012, respectively for survival from eyed-egg stage to hatching stage and to the end of the experiment. Those values were lower values than those estimated under threshold model and transformed to the observed scale by Dempster and Lerner (1950) formula (0.035 and 0.042 for She and Sef, respectively). However in any of the alternative (observed or underlying) worlds, there was not significant additive genetic variance on early survival traits. Proportions of phenotypic variance explained by the maternal effects were estimated at significant values, 5.8 % and 3.4% under linear models for She and Sef, respectively. Those values were quite consistent with values estimated under threshold model and transformed to the observed scale by Dempster and Lerner (1950) formula (0.066 and 0.046 for She and Sef, respectively).

There was no significant association between early survival traits and neither parental inbreeding coefficients (Table A.5) nor offspring inbreeding (Table A.6).

3.3.2. Maternal phenotypes and their associations with offspring survival rates

Regarding female traits, two size and six reproduction traits were measured, and basic statistics are presented in Table 7. As expected from mathematical constraints for CV (Lande, 1977), the CV of the average egg weight (corresponding to a volume record) was roughly 3 times larger than the CV of egg diameter (corresponding to a length record). However, CV of both egg size traits were low (CV < 10%). Concerning the three other reproductive traits (CF, EN, and SW) and the PW, there were variables between dams with CV of around 20%.

In addition, a phenotypic correlation between FL and PW was estimated at 0.69; EW and ED at 0.91; SW and EN at 0.95. The reproductive traits SW, ED and EW were positively correlated with FL or PW (Table 8). Negative but non-significant trends were generally observed for correlations between F_{dam} and maternal traits.

A graphical observation was first performed to ensure that the relationships between dam performances and progeny survival traits were globally linear before calculating the correlations between them.

Correlations of dam phenotypes with their progeny survival are presented in Table 9. Fork length was almost uncorrelated with survival until hatching, while PW was significantly and negatively correlated with survival until the hatching stage. After hatching, correlations between size traits and survival became weakly favorable. Note that the phenotypic correlated with fry survival traits until hatching but almost uncorrelated with survival from hatching to 3 weeks after the first meal. Weak correlations that were not statistically different from zero were observed between all early survival traits and CF, EW, or ED. However it should be noted that offspring mortality observed from the eyed egg stage to hatching was significantly (p-value=0.003) higher in the dam group with larger eggs (i.e., 8 dams with $EW \ge 73.5 \text{ mg}$) than in the dam group with lower average EW. In addition, all the 10 abnormal eggs observed at hatching were bred by 5 dams from this dam group with larger eggs.

4. Discussion

4.1. Evidence for variation in reproductive success in farmed trout

Family variance in reproductive success was identified in our study from fertilization to three weeks after the first feeding. It was mainly due to the stage between fertilization and hatching (Seh) because no family differences in progeny survival were observed from hatching to three weeks after the first feeding (Shf) (Table 3 and 4). Only dam contributions to the next generation were significantly unbalanced. No significant unbalanced contribution was observed for sires, probably because our mating plan was designed to avoid sperm competition, which is known to induce variance in family size (Gage et al., 2004; Wedekind et al., 2007). One-by-one male fecundation of dam egg pools is a usual practice in trout breeding programs. Even though the differences in offspring survival between extreme sires were insignificant, they were 11 and 12% at eyed egg stage in the two replicates. Such differences might have been significant should we have used a higher number of sires and/or more offspring per sire. These results confirm previous studies on early progeny survival in rainbow trout, for which maternal effects are always detected, but sire effects are low (Patton et al., 2007) or absent (Nagler et al., 2000). In the study by Patton et al. (2007), the sire effect may be at least partly confounded with a dominance effect because dams were mated with a single male. In chum salmon, significant sire and dam effects on early survival traits were identified by Smoker (1986). Similar results to ours were observed in brown trout, i.e., important maternal effects on offspring survival, but no sire effects when sperm competition was avoided (Régnier et al., 2010; Vandeputte et al., 2002).

As previously found by Rye et al. (1990), we did not observe significant phenotypic correlations between offspring survival at the different stages of larval development (Table 5, Figure 4), because these various traits should be influenced by different determinants.

4.2. Importance of the genetic factors explaining early survival in a cohort of farmed trout fry

We did not observed any significant additive genetic variance on early survival traits. Estimated heritability for survival traits (at hatching or 3 weeks after first feeding) was low (respectively 0.20 and 0.13 under threshold models, but only 0.01 under linear models) in our study. Low to moderate heritability values (ranging from 0 to 0.29 taking into account the binary nature of survival traits) were also reported for early survival in different species of salmonids

(*Oncorhynchus mykiss* and *Salmo salar*: Kanis et al., 1976; Gall and Gross, 1978; Rye et al., 1990; Houde et al., 2013, 2015; Vehviläinen et al., 2008; *Salvelinus fontinalis*: Robison and Luempert, 1984; *Arctic char*: Palaiokostas et al., 2020). However there was high uncertainty on most of these previous estimates and heritability may have been overestimated because maternal and/or dominance effects were not well accounted for in the models. Duenk et al. (2017) have demonstrated that including dominance effects was always equally or more accurate than the simple additive genetic model, even with a small sample size or in the absence of dominance.

In our study, heritability of survival did not significatively change between hatching and 3 weeks after the first feeding. The low mortality levels (4.1 % for Seh and 7.2% for Sef) may limit the detection of genetic variation in early survival and may lead to low estimates of heritability in our study. The additive genetic coefficients of variation of early survival from eyed egg stage to hatching or to three weeks after first feeding, measuring their evolvability (Houle, 1992) were also very low, 0.74 %, and 1.31%, respectively. This means that selection may not be efficient in improving survival from the eyed-egg stage to hatching or 3 weeks after first feeding. However, our experiment was based on a unique cohort with progeny bred from only 15 dams and 9 sires that were randomly sampled from a population with about 10 times more breeders. Uncertainty on our parameter estimates is a consequence of this small sampling set and further analysis on subsequent cohorts should confirmed our first estimates.

Under linear models (Table A.4), extremely high dominance deviation effects were estimated in our study. These results have to be taken with caution as phenotypic variances were low and only a small dataset was used to fit complex genetic models. However, the full AMD model including dominance deviation effects gave the better goodness-of-fit under linear model (minimum AIC value, Table A.4), while the threshold AMD model did not converged. Our high estimates of dominance deviation variance for early survival traits is consistent with the high non-additive genetic variances observed in Atlantic salmon (Houde et al., 2013, 2015) for survival from fertilization to hatching and from hatching to yolk sac resorption. High dominance variance is theoretically linked to inbreeding depression, that has been shown to play a significant role in female reproduction traits in a selected rainbow trout line, even if no genome-wide inbreeding effect was observed (Paul et al., 2021). Indeed, many studies showed inbreeding depression on fitness-related traits due to high levels of parental and own individual inbreeding (*Oncorhynchus mykiss:* Aulstad et al., 1972; Kincaid et al., 1976a; Gjerde et al., 1983; Naish

et al., 2013; Oreochromis niloticus: Fessehaye et al., 2009; Salvelinus alpinus: Palaiokostas et al., 2021). In our study, we did not estimate any significant effect of dam or sire inbreeding levels on offspring survival neither at hatching nor at the end-point of the experiment. However, Su et al. (1996) revealed that dam inbreeding impacts egg quality and may reduce progeny survival in rainbow trout. Fessehaye et al. (2009) demonstrated that sire inbreeding could influence reproductive success in Nile tilapia, with an inbreeding depression effect observed for the number of progeny when males are in competition (which was not the case in our study). In addition, we did not observe any significant difference in the numbers of dead fry among offspring with inbreeding levels over the average (Table A.6). On the contrary, Gjerde et al. (1983) and Aulstad et al. (1972) estimated inbreeding depression effects around 10% on survival from eved egg stage to hatching in rainbow trout populations. Gjerde et al. (1983) also indicated inbreeding depression effects ranging from 5 to 11% on offspring survival from hatching to first feeding and from the first feeding to 6 weeks after the first meal. However, these estimations were based on an experimental line with very high inbreeding levels (from 0.25 to 0.50) due to full-sib mating. Kincaid et al. (1976a) showed a high inbreeding depression effect on early survival in a rainbow trout population with high inbreeding levels (from 0.25 to 0.375). In our study, parents were weakly related, and there was no mating between full-sibs. Therefore, the inbreeding levels of the offspring remained moderate, with an average value of 0.10 and a maximum value of 0.25 (Table 1), which may explain why we did not observe any significant inbreeding depression effects compared to previous studies. Even though we did not observe a significant effect of genome-wide inbreeding on offspring survival, it does not mean that inbreeding depression is not occurring in some local regions in the genome, as Paul et al. (2021) revealed for female reproduction traits in rainbow trout.

Similarly, Kincaid (1976b) showed no effect of inbreeding on the egg hatchability stage in a rainbow trout population but a higher inbreeding effect on fry survival in Kincaid (1976a). Houde et al. (2010) also observed no significant differences in offspring survival between inbred and non-inbred lines. In addition, Moss et al. (2007) highlighted that inbreeding has no effect on Pacific white shrimp survival in normal conditions, but a severe inbreeding depression on survival appears after exposure to viral pathogens. Their study proves that inbreeding may play a major role when life conditions change to extreme ones. In consequence, even if we did not identify any inbreeding depression effect on early survival in rainbow trout in our experimental conditions, we cannot exclude that inbreeding effects may reveal in less favourable rearing conditions.

4.3. Importance of maternal phenotypes on fry survival

Compared to our estimates based on animal models with maternal effects, higher proportion of phenotypic variances of egg, alevin or fry survival in salmonids species were explained by maternal effects under sire-dam models (Kanis et al., 1976; Rye et al., 1990; Houde et al., 2013, 2015). These previous results showed that heritability estimates derived from the dam components of variance were substantially higher (between 0.15 to 0.58 from eyed-egg stage to hatching and between 0.07 to 0.86 from hatching to first feeding) than those derived from the sire components, revealing that additive genetic effects were small, but non-additive genetic effects and/or maternal environment effects explained a high proportion of early survival in salmonids. However experimental designs and statistical models used in these previous studies did not allow to disentangle additive genetic, dominance deviation, maternal genetic and maternal environmental effects from the dam variance components.

In an attempt to understand which biological factors may underlie the maternal effects observed on early survival, we estimated Pearson correlations between various dam performances and offspring survival rates (Table 9). Because there is information on only 15 dams, most correlations are not statistically different from zero. This limits the interpretation of the results; however, some challenging results deserve discussion.

Whatever the stage, favourable correlations were estimated between offspring survival and fecundity traits (SW, EN, and RF). This is consistent with previous results on rainbow trout (Estay et al., 2021), showing a significant positive association between relative fecundity (RF) and progeny survival at the eyed egg stage. However, some weak negative trends between fecundity traits and survival stages (at the eyed egg, hatching, and swim up) were identified in another cultured stock rainbow trout (Kanyilmaz et al., 2016). In lake whitefish, survival until hatching and fecundity traits were not correlated (Wedekin and Müller, 2004).

In our study, as in many others in rainbow trout (Su et al., 1996; Gall and Neira, 2004; Solberg et al., 2014; Islam et al., 2021; Estay et al., 2021), results support the evidence that larger females produce larger eggs (higher EW average) than smaller females. Our results, showing no significant association between egg size and survival contradict those of many studies (Bagenal, 1969; Wallace & Aajord, 1984; Beacham & Murray, 1985; Rana, 1985; Marteinsdottir & Able, 1992) that showed that the survival of fry derived from larger eggs was significantly better, probably because these fries would be bigger. Here we even observed an

almost significant negative correlation between egg weight and survival from eyed egg stage to hatching (Table 9, p-value = 0.06). An explanation for this excess in egg mortality may be the over-ripening of the larger eggs as all observed abnormal embryos at hatching came from the dams with the heaviest average egg weights. Indeed, some females may have reached maturity a few days before the others, inducing greater hydration and, therefore, larger eggs without their over-ripening being visible but potentially inducing developmental defects in the offspring (*Salmo salar*: Horreo et al., 2008; *Leuciscus idus*: Nowosad et al., 2018).

Similarly to our observation that dams with heavier eggs had more malformed progenies, Wallace and Aasjord (1984) observed that progeny groups with higher egg size in Arctic charr have higher fry mortality due to malformations. These observations deserve further attention by salmonid breeders as increasing egg size was initially thought to be an interesting way to increase alevin survival. Some studies demonstrate that the quantity and quality (such as lipid, protein composition, and triiodothyronine concentration) of egg reserves are crucial for fish offspring early survival (Brown et al., 1988; Greenblatt et al., 1989; Gisbert et al., 2000; Stuart et al., 2020). According to Stuart et al. (2020), the egg quality (lipid and protein) is increased with egg size because of a higher metabolic reserve (Brooks et al., 1997). Besides, Berg et al. (2001) and Régnier et al. (2013) demonstrated that small eggs are not always those of lesser quality because small eggs allow, for example, to have a better protein content than larger eggs. Even if a larger egg produces a larger fry, this advantage can be masked by other environmental determinants of growth (Bromage et al., 1992), and egg size does not appear to be an essential indicator of egg quality in farmed rainbow trout populations (Brooks et al., 1997). In addition, Einum and Fleming (1999) observed that differences in offspring's survival from small and large eggs decreased with increasing environmental quality. So, in high-quality environments (facilities, farmed environments), no egg size effect should be observed on offspring's survival. To finish, egg size was uncorrelated with progeny survival in various studies and fish species (Oncorhynchus mykiss: Springate and Bromage, 1985; Herbinger et al., 1995; Blanc, 2007; Salmo trutta fario L.: Vandeputte et al., 2002; Cyprinius carpo L.: Vandeputte et al., 2004; Salvelinus alpinus: Jónsson, B., & Svavarsson, 2000; Leblanc et al., 2016).

5. Conclusion

This study highlights the biological factors underlying early survival and identifies maternal disequilibrium contributions to the next generation in a domesticated rainbow trout line. Heritability of early survival is low, not statistically different from zero, but maternal effects explain a larger amount of the phenotypic variance of embryo survival. While egg size has no significant effects on early survival, dam weight and fecundity seem to play important roles underlying the maternal effects observed on embryo and fry survival. Further studies are needed to well understand these roles and to confirm the existence of non-additive genetic factors impacting early survival in rainbow trout.

Chapitre 3

Effets de la consanguinité génomique locale, récente ou ancienne, sur les caractères de taille et de reproduction des femelles de truite arc-en-ciel

Depuis plus de trente ans, l'amélioration génétique de la truite arc-en-ciel a permis d'accroître l'efficacité de la production truticole. Mais cette sélection a aussi contribué à une augmentation de la consanguinité et une perte de diversité génétique (D'Ambrosio et al. 2019), mettant en péril le progrès génétique à long terme et la capacité d'adaptation des populations aux changements environnementaux. Afin de mieux gérer la consanguinité et ses conséquences au sein des populations de truites arc-en-ciel, il est nécessaire de mieux comprendre l'architecture des effets de la consanguinité sur des caractères d'intérêt aquacole.

A cette fin, trois questions importantes ont été traitées dans ce chapitre. La première question était de **quantifier les effets globaux de la consanguinité sur les performances de taille et de reproduction des truites**. La seconde question était **d'identifier les zones du génome associées à ces variations de performance : des régions particulières sont-elles plus souvent impliquées ? Sont-elles liées à des événements récents d'accouplements entre reproducteurs apparentés ?** La dernière question était de savoir si **nos observations corroboraient l'hypothèse privilégiée pour expliquer le phénomène de dépression de consanguinité**, à savoir le rôle majeur d'allèles récessifs à effet délétère.

Cette étude est la première qui ait visé à estimer les effets précis de la consanguinité accumulée localement et dans le temps au sein d'un génome de poisson. Pour ce faire, les performances de croissance et de reproduction de plus de 1300 truites d'une population commerciale sélectionnée depuis 9 générations ont été analysées.

Conclusion du Chapitre 3

Nous avons montré que la consanguinité localisée dans certaines parties du génome peut avoir des effets notables, négatifs comme positifs, sur les performances de la truite arc-enciel, sans que l'on observe forcément un effet de la consanguinité globale à l'échelle de tout le génome. Comme largement rapporté dans la littérature, le principal phénomène observé est un impact négatif de la consanguinité récente, expliqué par l'accumulation d'allèles récessifs délétères à l'état homozygote. Cependant la consanguinité, en particulier celle accumulée dans les générations passées, engendre aussi des effets favorables sur les performances de reproduction des truites.

Cette étude est une première étape vers une gestion précise des accouplements entre reproducteurs afin de favoriser ou, au contraire, limiter la consanguinité locale selon que ses effets sont positifs ou négatifs sur les performances. L'utilisation d'indicateurs génomiques locaux de la consanguinité permettra ainsi aux sélectionneurs de mieux gérer les compromis entre valeurs génétiques des reproducteurs et effets indésirables de la consanguinité de leur progéniture.

Les différents résultats obtenus dans ce chapitre ont été présentés sous forme de communications orales aux *Journées Techniques du Sysaaf* en 2020, ainsi qu'aux congrès *International symposium on Genomics In Aquaculture* (GIA) et *European Aquaculture Society* (EAS) en 2021. Ils ont également fait l'objet d'un article « *Temporal and region-specific variations in genome-wide inbreeding effects on female size and reproduction traits of rainbow trout* » publié dans le Special Issue '*Genomics for Aquaculture and Livestock breeding improvement*' d'*Evolutionary Applications* en 2022.

Temporal and region-specific variations in genome-wide inbreeding effects on female size and reproduction traits of rainbow trout

Abstract

Recent studies have shown that current levels of inbreeding, estimated by runs of homozygosity (ROH), are moderate to high in farmed rainbow trout lines. Based on ROH metrics, the aims of our study were to (i) quantify inbreeding effects on female size (postspawning body weight, fork length) and reproduction traits (spawning date, coelomic fluid weight, spawn weight, egg number, average egg weight) in rainbow trout, and (ii) identify both the genomic regions and inbreeding events affecting performance. We analysed the performance of 1346 females under linear animal models including random additive and dominance genetics effects, with fixed covariates accounting for inbreeding effects at different temporal and genomic scales. A significant effect of genome-wide inbreeding (F) was only observed for spawning date and egg weight, with performance variations of +12.3% and -3.8%, respectively, for 0.1 unit increase in F level. At different local genomic scales, we observed highly variable inbreeding effects on the seven traits under study, ranging from increasing to decreasing trait values. As widely reported in the literature, the main scenario observed during this study was a negative impact of recent inbreeding. However, other scenarios such as positive effects of recent inbreeding or negative impacts of old inbreeding were also observed. Although partial dominance appeared to be the main hypothesis explaining inbreeding depression for all the traits studied, the overdominance hypothesis might also play a significant role in inbreeding depression affecting fecundity (egg number and mass) traits in rainbow trout. These findings suggest that region-specific inbreeding can strongly impact performance without necessarily observing genome-wide inbreeding effects. They shed light on the genetic architecture of inbreeding depression and its evolution along the genome over time. The use of region-specific metrics may enable breeders to more accurately manage the trade-off between genetic merit and the undesirable side effects associated with inbreeding.

1 | INTRODUCTION

Inbred offspring tend to have a greater number of abnormalities and poorer survival, growth and fertility compared to the progeny of unrelated parents (Fessehaye et al., 2007; Mrakovčič, & Haley, 1979; Thrower & Hard, 2009). This decrease in fitness is referred to as inbreeding depression and is caused by the increased homozygosity of individuals (Aulstad & Kittelsen, 1971; Charlesworth & Charlesworth, 1999; Landweber & Dobson, 1999). Inbreeding depression is currently explained by two main hypotheses. The partial dominance hypothesis assumes that inbreeding depression results from the expression of deleterious recessive alleles in homozygous individuals, that is the so-called genetic load. These deleterious alleles are present at low frequencies in populations. As inbreeding increases in a population, the frequency of deleterious recessive homozygotes, which were initially hidden in heterozygotes, increases and exposes the deleterious effects (Fu & Ritland, 1994). Alternatively, the overdominance hypothesis refers to dominance effects displaying the heterozygote advantage and, as inbreeding increases, the number of heterozygous genotypes is reduced and the superior heterozygote genotypes are less frequent (Wright, 1984). A final hypothesis is that epistasis between dominance effects across loci can also generate inbreeding depression, such that as inbreeding accrues, favourable gene combinations among heterozygous genotypes decrease in frequency (Jain & Allard, 1966). Distinguishing this 'pseudooverdominance' hypothesis from true overdominance is hampered by the difficulty in distinguishing between linked deleterious mutations in a genome region and a single locus with heterozygote advantage (Ohta & Kimura, 1969). If deleterious mutations are common, genome regions may often carry mutations in different genes in repulsion. The region would therefore display a heterozygote advantage even though no overdominant gene is present. The partial dominance hypothesis is widely accepted as the most common mechanism causing inbreeding depression and has received the strongest empirical support until now (Ceballos et al., 2018; Charlesworth & Willis, 2009; Fu & Ritland, 1994). All hypotheses concern the existence of genetic effects that are not additive and need to be considered when describing performance. Fitness-related traits are more affected by inbreeding than traits under less severe directional selection (DeRose & Roff, 1999). Inbreeding depression has been documented in many different plants and animals, both in the wild (Chapman et al., 2009; Reed & Frankham, 2003) and among farmed livestock (Leroy, 2014). In populations under artificial selection, an accumulation of inbreeding is unavoidable because of the use of a limited number of breeding individuals and their intense directional selection. These procedures lead to the widespread use of related individuals as parents of the next generation, thus reducing the effective population size and hence genetic diversity over the generations. In livestock species, inbreeding depression has a direct impact on the income of breeders (Leroy, 2014) and maintaining genetic diversity is a challenge.

Before the massive increase in genomic information, pedigree relationships were used to estimate inbreeding effects and manage inbreeding within a population. The effect of inbreeding on

economically important traits was mainly investigated by regressing phenotypes of interest on the inbreeding coefficient value using pedigree (Wang et al., 2002), which severely limited the understanding of inbreeding effects. Pedigree information is based on the expected proportion of the genome that is identical by descent (IBD) between two parents, so it does not capture variations due to Mendelian sampling and linkage during gamete formation (Kardos et al., 2015; Wang, 2016). Genomic information enables an estimate of the realized proportion of the genome shared by two individuals either genome-wide or in specific regions (Hill & Weir, 2011). The use of genomics rather than pedigrees to measure inbreeding has therefore been promoted (Kardos et al., 2015; Wang, 2016) as enabling major advances in our understanding of inbreeding and identifying the regions and genes that result in inbreeding depression along the genome (Kardos et al., 2016; Pryce et al., 2014). It has also led to renewed interest in estimates of dominance effects that can improve our understanding of the genetic architecture of inbreeding depression and enable more accurate estimates of inbreeding effects (Toro & Varona, 2010; Vitezica et al., 2016).

Although access to local inbreeding is now greatly facilitated due to the development of genomics, the number of studies focusing only on global inbreeding and local inbreeding remains quite low (Botero-Delgadillo et al., 2020; Judson et al., 2018; Lieutenant-Gosselin & Bernatchez, 2006). The use of region-specific metrics to identify areas of low genetic diversity may enable breeders to more accurately manage the trade-off between genetic merit and the undesirable side effects associated with inbreeding (Howard et al., 2017).

Among the various molecular-based inbreeding indicators available (Ferencakovic et al., 2013; Zhang et al., 2015), runs of homozygosity (ROH) have been revealed as being the most accurate measure of inbreeding (Howrigan et al., 2011; Zhang et al., 2015). ROH are defined as contiguous homozygous stretches of the genome assumed to be inherited from a common ancestor and thus considered as IBD segments (McQuillan et al., 2008). ROH detection has been used to identify genetic anomalies based on homozygosity mapping (Keller & Wallers, 2002; Li et al., 2011). In both humans and cattle, it has been found that ROH are enriched with deleterious variants (Szpiech et al., 2013; Zhang et al., 2015) and they can be used to directly estimate inbreeding depression (Silió et al., 2013). Keller et al. (2011) showed by simulation that ROH-based inbreeding measure is the most powerful method to detect inbreeding depression (compared to pedigree or marker-by-marker-based inbreeding metrics) and that the statistical power of ROH-based inbreeding metrics was good (80%) in a randomly breeding population of moderate effective population size (i.e. 100) with only a small sample size of 700 individuals.

As well as its ability to measure region-specific inbreeding, ROH is able to date inbreeding events through the length of ROH segments (Ceballos et al., 2018; Gomez-Raya et al., 2015). A large ROH is likely to result from a recent inbreeding event because only a few recombinations have occurred since generation of the most recent common ancestor of the parents, while a small ROH is in favour of an older inbreeding event as several recombination events are likely to have occurred, leading to reduced IBD segments

In the particular case of Oncorhynchus mykiss, D'Ambrosio et al. (2019) showed that effective population sizes of French farmed rainbow trout lines have been steadily decreasing during the past 10 generations and inbreeding appears to be high not only due to selection, but also because of founder effects and sweepstakes reproductive success at the start of breeding programmes. The impact of these significant levels of inbreeding on French rainbow trout performance needs to be quantified in order to assess potential inbreeding depression phenomena and risk of limiting future genetic gains due to a loss of genetic diversity (Jannink, 2010; Muller & Pearson, 1979). Estimates of inbreeding effects on important traits in fish have been limited to a few experiments on salmonids, as reviewed by Wang et al. (1999, 2002). These previous studies revealed significant but generally moderate inbreeding depression effects on weight at harvest (Kincaid, 1976; Pante et al., 2001; Rye & Mao, 1998), body weight and length (Naish et al., 2013), egg mass, egg hatchability and fry survival (as reviewed by Kincaid, 1983), on egg numbers and the spawning age of rainbow trout (Su et al., 1996) as well as on spawning date for wild populations (Waters et al., 2020).

Therefore, based on ROH metrics, the objectives of our study were to quantify the effects of dominance and inbreeding on female size and reproduction traits in rainbow trout and identify both the genomic regions involved and the time of inbreeding events with effects on these performance traits. The traits under study were therefore female fork length, postspawning weight, spawning date, coelomic fluid weight, spawn weight, egg numbers and egg size. The first question we addressed was whether genome-wide inbreeding and dominance effects could explain significant proportions of phenotypic variance in female size and reproduction performance. The second issue was to assess whether the effects of inbreeding were mainly due to recent inbreeding events and only observed in specific regions of the genome. The last question was whether our results could corroborate the partial dominance hypothesis, that is the major role of deleterious recessive alleles as the underlying mechanism explaining inbreeding depression.

As far as we know, this is the first study to have reported on genome-wide and region-specific inbreeding effects based on ROH metrics, as well as their temporal variations for fish traits. Our results may help rainbow trout breeders to design and implement new genomic selection methods that take account of local genetic diversity along the genome to manage inbreeding at the genome level. In addition, and more globally, they will perhaps shed new light on the genetic architecture of inbreeding depression and its evolution over time.

2 | MATERIALS AND METHODS

2.1 | Population

The phenotyped and genotyped rainbow trout population comprised 1346 females from two successive cohorts: C1 (726 individuals) and C2 (620 individuals), which were produced in 2014 and 2015, respectively. After hatching, the juveniles were raised to about 20 g (C1) in size or 58 g (C2) at the Escort site on the plain (spring water temperature within the range 14-16°C) in 17 m^3 breeding tanks at densities increasing from 2 to 25 kg/m³ (C1) or 36 kg/m³ (C2). They were then moved from the plain to the mountains at the Sarrance site (spring water temperature within the range 8-9°C) and raised in 126 m³ tanks until they reached weights of 450 g (C1) or 580 g (C2). Finally, the trout were transferred to 70 m³ tanks with rearing densities ranging from 40 to 100 kg/m³ until spawning. Both juveniles and trout were fed with commercial standard diets, although some specific modifications were requested by the breeder regarding the diet given to trout from 1 kg until spawning.

The two cohorts were part of the 9th generation of selection by the 'Viviers de Sarrance' breeding company and were produced from 71 fathers and 83 mothers. This 9th generation was the first to have been produced using an optimum contribution method to select and mate the parents for a targeted genetic gain while minimizing the increase in inbreeding through a 'Minimum Parentage Selection' procedure (Chapuis et al., 2016). There were around 4 (\pm 2) full-sibs and 45 (\pm 20) half-sibs per parent in the phenotyped population under study. Details of the population structure can be found in the article by D'Ambrosio et al. (2020).

Raw phenotypes were collected from 2-year-old females. As for size traits, the ready-to-spawn weight (FW in g), postspawning weight (PW in g) and fork length (FL in mm) of the females were recorded (Table 1).

Regarding reproduction traits, the weight of the total egg mass (here in after referred to as the spawn weight (SW)), the weight (EPW) and number (EPN) of eggs pooled in a 2.5 ml sampling spoon and the spawning week number in the calendar year were all recorded. The spawning week number enabled us to calculate the spawning date (SD) corresponding to the rank of the week number within the spawning period, with discrete values ranging from 1 (for the first week) to 5 (for the 5th and subsequent weeks) within the cohort. The presence of overmature eggs in the spawn was also reported as a potential factor to explain certain reproduction traits. This is an important phenomenon in salmonids that do not spawn naturally under farmed conditions (Escaffre & Billard, 1979). Overmature eggs change in terms of their morphology (McEvoy, 1984) and composition (Craik & Harvey, 1984; Springate et al., 1984), which implies a significant decrease in egg quality.

The weight of coelomic fluid (CF) was determined by subtracting the spawn weight (SW) from the difference between the female weight before (FW) and after (PW) spawning:

$$CF = (FW - PW) - SW.$$

Average egg weight (EW) was the ratio between the weight of eggs (EPW) and the number of eggs (EPN) contained in the sampling spoon:

$$EW = EPW/EPN$$

The egg numbers in the spawn (EN) were calculated as

$$EN = SW/EW.$$

To summarize, the traits analysed were three raw phenotypes, FL, PW and SW, and four derived phenotypes, average egg weight (EW), egg numbers in the spawn (EN), the weight of coelomic fluid (CF) and the spawning date (SD). If any two records were more than four standard deviations from the mean in absolute values, they were considered as outliers and discarded from the study. Thus, the phenotypes of 1346 fish were considered during the study (Table 1).

2.3 | Genotypes

One thousand three hundred and forty-six fish (726 and 620 individuals from the C1 and C2 cohorts, respectively) were genotyped for 57,501 SNPs (single nucleotide polymorphism markers) using the Axiom[™] Trout Genotyping array (Palti et al., 2015) at the INRAE Gentyane Genotyping Platform. The quality control of genotyped SNPs was performed as described by D'Ambrosio et al. (2019), with particular focus on removing SNPs with probe polymorphism and multiple locations on the genome. Only the 29,799 SNPs with a call rate higher than 0.97, a test of deviation from the Hardy–Weinberg equilibrium with a *p*-value >0.0001 and a minor allele frequency higher than 0.01 were retained for the analysis. All missing genotypes for the 29,799 SNPs were imputed using family information with FImpute software and default values for all FImpute parameters (Sargolzaei et al., 2014).

2.4 | Runs of homozygosity

Runs of homozygosity were identified for each fish using the PLINKv1.9 homozyg function (Chang et al., 2015) with the options '--homozyg-kb 1000 --homozyg-window-snp 30 --homozyg-snp 30 --homozyg-gap 1000 --homozyg-density 100 --homozyg-het 1'. ROH were thus defined by sliding windows with a minimum length of 1 Mb containing at least 30 homozygous SNPs as defined by D'Ambrosio et al. (2019). This minimum number of homozygous SNP was chosen using the formula described by Purfield et al. (2012) in order to limit the number of ROH that might only occur by chance. The maximum gap allowed between two consecutive homozygous SNPs in a run was kept at the default value of 1 Mb. A minimum density of one SNP every 100 kb was considered not to overestimate ROH length and up to one possible heterozygous genotype was permitted for each ROH. All values for parameters used to define ROH were tuned by D'Ambrosio et al. (2019) according to the marker density and the level of recombination along the genome to well estimate the number and size of ROH segments for French rainbow trout populations.

2.5 | Estimation of inbreeding coefficients

The total inbreeding coefficient (F_i) was calculated as the sum of ROH lengths in an individual *i* (Σ Length(ROH_{*i*})) divided by the total length of the autosomal genome covered by SNPs (LGenome):

$$F_i = \frac{\sum \text{Length}(\text{ROH}_i)}{\text{LGenome}}.$$

The total size of the autosomal genome covered by SNPs (= 1.788 Gb) was calculated as the length of the autosomal genome, removing gaps of more than 1 Mb without any SNP from the total size.

We also derived local inbreeding coefficients, at either the chromosome Omyk level or a smaller region r scale (20 Mb segment) in order to accurately localize inbreeding events in the genome:

$$F_{\text{Omyk}_r,i} = \frac{\sum_{k_r} \text{Length}(\text{ROH}_i)}{\text{LRegion}_{k_r}}$$

where \sum_{k_r} Length(ROH_i) is the sum of ROH lengths of an individual *i* on chromosome Omyk (or the 20 Mb region k_r on Omyk), and LRegion_k,

is the total length covered by SNPs on the Omyk chromosome or on the r region on Omyk.

Furthermore, we derived three other inbreeding coefficients (F_{Gt}) depending on the expected generation Gt (ancient, middle or recent) in which inbreeding started to accumulate.

$$F_{Gt} = \frac{\sum \text{Length}(\text{ROH}_i > n)}{\text{LGenome}},$$

where t is the number of generations and n the minimal size of a ROH.

The correspondence between the number *t* of past generations and ROH length was derived using the average recombination rate *c* (in Morgan) between markers distant from the threshold value of n Mb (with 1 cM corresponding to 600 kb) and the formula t = 1/2c (D'Ambrosio et al., 2019). Thus, recent inbreeding (F_{G3}) accumulated on average during the last three generations was calculated as the sum of ROH lengths longer than 10 Mb divided by the total length of the genome covered by SNPs. This '3 generation'/'10 Mb' ROH length time point was chosen because it is well known that recent inbreeding events occurring during the last three generations play an important role in inbreeding depression effects (Makanjuola et al., 2020). We were also interested by the '9 generations' time point because it corresponded to the start of the breeding programme. On average, this earlier time point corresponds to an ROH size of 3 Mb. In addition, we chose an intermediate time point at 6 generations to better describe the dynamics of inbreeding events throughout the course of the breeding programme. The ROH length corresponding to this intermediate inbreeding (F_{G6}) was 5 Mb. It should be noted that any one of these temporal inbreeding coefficients could account for all the inbreeding events accumulated since the threshold generation considered, and therefore always contains the most recent inbreeding events. In addition, because the recombination rate varies along the genome, the average dating of size-specific ROH segments in terms of the number of generations overestimates the age of the most recent ancestor in genomic regions with lower than average recombination rates, but underestimates this age in genomic regions with higher recombination rates. Dating is therefore a very rough proxy used to describe global dynamics at the genome scale without any consideration of absolute dating values at region-specific scales.

2.6 | Mixed linear BLUP in animal models

In order to estimate the effects of inbreeding on female size and reproduction traits, two different genetic models were considered: (1) GBLUP— a genomic animal BLUP model with only additive genetic effects, and (2) D_GBLUP— a GBLUP animal model with both additive and dominance genetic effects.

For each of the seven traits studied, the following statistical models were considered to describe the vector of performance **y** of the 1346 phenotyped fish. Genomic BLUP (GBLUP) considering a genomic relatedness matrix **G** (VanRaden, 2007, 2008):

$$\mathbf{y} = \mathbf{X}\boldsymbol{\beta} + \mathbf{Z}\mathbf{a} + \sum_{r} b_{r} \mathbf{F}_{r} + e \tag{1}$$

where β , **a** and **e** are the vectors of, fixed environmental effects, random genetic additive effects and random residual effects, respectively, explaining the performance of all phenotyped animals. **X** and **Z** are the incidence matrices for β and **a**, respectively.

For all traits, the cohort fixed effect was considered (two levels). In addition, the spawning week number was introduced as a covariate nested within the cohort for the SW, EN, EW and PW traits. For SW and EN, the presence of overmature eggs was an additional significant fixed effect considered.

The vector **a** includes the breeding values of 1346 phenotyped and genotyped individuals related through the genomic relationship matrix **G**.

The regression coefficients b_r of **y** on the vectors \mathbf{F}_r account for inbreeding effects in different ways depending on the model considered. First of all, a single regression on the total inbreeding vector **F** was considered (r = 1 in that case). A multiple regression model was then studied and accounted for r = 30 vectors of chromosomal inbreeding coefficients F_{omy} . To finish, a series of nk multiple regression analyses was considered to assess the local inbreeding effects for a specific chromosome k; in that case, r equals the total number nk of 20 Mb-window regions of chromosome k in addition to the 29 remaining chromosomes. Depending on the chromosome size, nkranged from 2 (e.g. Omy28) to 4 (e.g. Omy1).

The model accounting for dominance effects (D_GBLUP) was previously described by Vitezica et al. (2016):

$$\mathbf{y} = \mathbf{X}\boldsymbol{\beta} + \mathbf{Z}\mathbf{a} + \mathbf{W}d + \sum_{r} b_{r}\mathbf{F}_{r} + e \tag{2}$$

where *d* corresponds to the dominance breeding values of 1346 phenotyped and genotyped individuals related through the dominance relationship matrix **D**. **W** is the incidence matrix for *d*. The additive **G** and dominance **D** genomic relationship matrices were built using the *parallelef90* program (Vitezica et al., 2016).

All traits were analysed separately to estimate inbreeding regression coefficients, breeding values and the genetic additive and dominance variances based on the BLUPf90 package (Misztal et al., 2002) using the AIREMLF90 program (Thompson et al., 2005).

3 | RESULTS

3.1 | Evaluation of total inbreeding, recent inbreeding and local inbreeding along the rainbow trout genome

Inbreeding coefficients were based on the number and size of ROHs derived for each individual in the population. The average number of ROHs per individual was 61, with an average ROH size of 5.07 Mb. The smallest number of ROHs observed in an individual

was 24 and the largest 113. The proportion of large ROH segments (ROH > 10 Mb) corresponding to recent inbreeding events in the population was 11.5%. Inbreeding coefficient values for the complete genome are shown in Table 2 for the full population and its two cohorts according to the number of ancestral generations included.

The average inbreeding level in the population was about 17%, with individual values ranging from 8% to 30%. We observed that 38% of the genome-wide inbreeding came from the last three generations. In addition, nearly 82% of all inbreeding observed in the C1 and C2 cohorts had been produced since the start of the breeding programme (nine generations earlier). On average, individuals in

cohort C2 were more inbred than those in cohort C1 (+6.6% average inbreeding coefficient), this being linked to a few individuals with extreme inbreeding coefficient values (F > 25%).

As for inbreeding across chromosomes (Figure 1), we noted that chromosomal inbreeding levels (F_{omy}) varied considerably along the genome. While the average F_{omy} was 17.0%, values ranged from 11.6% for F_{18} on Omy18 to 25.1% for F_{20} on Omy20. Some individuals had very high F_{omy} for a particular chromosome, with values reaching almost 100%. However, because the total *F* of any individual did not exceed 30% (Table 2), an individual with a very high F_{omy} on a specific chromosome would have a low F_{omy} on the other chromosomes. Details on F_{omy} distributions are given in Table S1.

With the sole exception of the moderate correlation estimated at 0.61 between F_{25} and F_{30} , the chromosomal inbreeding coefficients (F_{omy}) were almost uncorrelated (Figure S1).

3.2 | Heritability and dominance ratios for female size and reproduction traits

With the sole exception of coelomic fluid weight with low heritability value, all traits had intermediate heritability values with estimates higher than 30% for female size traits and between 20% and 30% for reproduction traits, for all genetic models (Table 3). Adding a dominance effect into the genomic model (D_GBLUP) resulted in slight reductions in estimates of genetic variance and heritability when compared to GBLUP. However, the correlations between the additive estimated breeding values from G_BLUP and D_GBLUP models were higher than 0.99 for all traits.

Considering the genome-wide inbreeding coefficient as the only covariate in the D_GBLUP model, dominance variance explained about 0%-13% of the phenotypic variance of each trait, the greatest effect being estimated for spawning weight. However, the dominance ratio increased (+25%-107% depending on the trait) when all 30 chromosomal inbreeding coefficients F_{omy} were considered as covariates in the D_GBLUP model. In the same model, dominance variance explained about 4% to almost 19% of the phenotypic variance of each trait, the greatest effect still being estimated for spawning weight. The lowest d^2 estimates concerned female size traits and coelomic fluid weight; they did not differ significantly from 0. Although the d^2 estimates were moderate for spawning date (5%-7% depending on the D_GBLUP model), they differed significantly from 0. Intermediate dominance ratios (ranging from 8% to 14% depending on the D_GBLUP model) were estimated for egg number and average weight.

Because of their better goodness-of-fit (minimum AIC values), the D_GBLUP models were considered to be the reference models to study the impact of inbreeding on performance for all traits, as dominance effects explained at least 5% of phenotypic variance in six out of the seven traits analysed.

3.3 | Estimating the total inbreeding effect on female size and reproduction performance

Regression coefficients *b* of performance on the total *F* estimated under the D_GBLUP model are presented in Table 4. Significant effects of total inbreeding were only observed for SD and EW. Increased inbreeding raised SD values, that is delayed spawning. A significant reduction of 3.8% and an increase of 12.3% for EW and SD performance were observed with a 0.1 unit increase in the *F* coefficient. Very minor effects (not differing significantly from 0) of total inbreeding were estimated on all other traits, but slight negative trends were observed in all cases.

Please note that we use the terms 'positive' or 'negative' to simply qualify increased or decreased trait values because of an increase in

F. When we wish to interpret these trends in terms of fitness, the terms 'favourable' or 'unfavourable' are used.

3.4 | Local variations in inbreeding effects regarding female size and reproduction traits

When considering the chromosome scale (Figure 2), we observed highly variable effects of local inbreeding on all reproduction traits, even those where total inbreeding had no significant effects. Details of the chromosomal inbreeding effects are presented for all traits in Table S2. For a given chromosome, an increase of 0.1 unit in the

inbreeding coefficient corresponded to variations in performance ranging from -2.9% to +3.9% of the trait mean. For some chromosomes, we observed similar negative (e.g. on Omy1, except on coelomic fluid weight) or positive (e.g. Omy20) trends of inbreeding effects on female reproduction traits, while for most of the chromosomes, opposite inbreeding effects were observed on the different traits. Chromosomal inbreeding effects were more variable on coelomic fluid weight (-2.9 to +3.9% of the trait mean, depending on the chromosomes) than on other traits. In particular, the chromosomal inbreeding effects on egg number had a very small amplitude (ranging from -1.1% to 0.9% of the trait mean) and none of them were significant (Figure 2; Table S2). Moreover, we saw a significant and high total inbreeding effect on average egg weight, but with very small chromosomal inbreeding effects ranging from -0.7% to 0.3% of the trait mean. Whatever scale considered (genome-wide, chromosomal or local scale), very small inbreeding effects were seen to affect female fork length (ranging from -0.2% to 0.3%). Despite these very weak inbreeding effects on this trait, some significant effects were observed on certain chromosomes (see Omy17 and Omy28 in Figure 2) as well as more region-specific inbreeding effects (see Omy28_r1 in Figure S2).

A few significant chromosomal inbreeding effects (one to four chromosomes, depending on the traits) were estimated for SW, EW, PW and FL. Although we estimated some significant and positive effects of chromosomal inbreeding on the size traits PW and FL, a majority of negative effects were observed for the reproductive traits SW and EW. None of the chromosomal inbreeding effects estimated for SD, EN and CF were statistically different from zero.

Moreover, we did not observe any strong association between chromosomal inbreeding coefficients (F_{omv}) and the corresponding

Thus, we did not even observe a clear trend towards stronger inbreeding depression with higher F_{omy} values. Nevertheless, recent chromosomal inbreeding levels ($F_{G3,omy}$) were more markedly negatively associated with the corresponding regression coefficients on performance, particularly for the CF, SW and EN traits.

Zooming at the intra-chromosomal scale, we also observed highly variable effects of local inbreeding on trait performance whatever the chromosome (F_{omy_r} values are presented in Table S3). We focused our analysis on two chromosomes (Figure 3): Omy1 containing several QTLs on reproduction traits (D'Ambrosio et al., 2020) and Omy10 containing an ROH segment (in the 10_r3 region) shared by diverse rainbow trout populations (D'Ambrosio et al., 2019). Along Omy1 (Figure 3a), highly variable local inbreeding effects were observed, in particular for coelomic fluid weight, with positive effects of the first and last 20-Mb regions of the chromosome. A unit increase of 0.1 in the local inbreeding coefficient corresponded to performance variations ranging from -1.2% to +3.8% of the trait means.

Except for average egg weight, which had a significant positive inbreeding effect on region 1_r3, local inbreeding coefficients exerted no significant effects on the two intermediate regions of Omy1. In addition to the positive inbreeding effect of the 1_r4 region on CF, significant negative effects of inbreeding in this 1_r4 region were observed for EW and SW. We also observed highly variable effects of local inbreeding along the Omy10 chromosome (Figure 3b). The effects were small and not statistically different from 0 in the first and last regions of Omy10. However, local inbreeding in the second and third regions of Omy10 exerted significant effects, but only on spawn weight (decreased performance) and spawning date (increased performance).

3.5 | Variations over generations in inbreeding effects on female size and reproduction traits

Genome-wide inbreeding effects over generations were generally very small, except for SD, SW and EW (Figure 4). We analysed inbreeding effects due to total inbreeding (F) accumulated in the population, but also due to inbreeding events that had accumulated over the past nine generations that we qualified as old inbreeding (F_{G9}), or over just the past three generations that we qualified as recent inbreeding (F_{G3}). Comparing this recent time point to the intermediate point of six generations (F_{G6}), we are able to assess inbreeding events that had occurred between generations 4 and 6. Regarding average egg weight, the effects of recent inbreeding, as well as those accumulated since older generations, were significantly negative. Similar trends were observed for spawn weight although the inbreeding effects did not differ significantly from 0. All temporal inbreeding effects showed clear positive trend on spawning date, but they did not differ significantly from 0, except for the total inbreeding effect. Inbreeding effects mainly appeared to be due to recent inbreeding (F_{G3}) for EW and SW, whereas they appeared to be due to both recent and older inbreeding events for SD.

As for both temporal and chromosomal inbreeding effects along the genome, we observed highly variable effects for all traits (Table S2). We focused our analysis on postspawning body weight and

spawn weight (Figure 5) in order to highlight the point that effects could be revealed at temporal and/or chromosomal scales even when total inbreeding effects were null at the genome scale. Indeed, a variation of 0.1 unit in the inbreeding coefficient corresponded to performance variations ranging from -3.9% to +4.6%, depending on the trait, the chromosome and the number of generations used to evaluate the inbreeding effect.

An impact of recent inbreeding (F_{G3}) was considered to be important when, in absolute values, the recent inbreeding effect was equal to or higher than the other temporal inbreeding effects. Important impacts of older inbreeding events were considered when nonzero values of total (F) and old (F_{G9}) inbreeding effects were estimated but the recent inbreeding effect was estimated to be null. Applying these definitions, chromosomal inbreeding effects appeared to be largely explained by recent inbreeding. Indeed, 50% (all traits gathered together, otherwise 40%–67% depending on the trait) of chromosomes with nonzero B^* estimates (above the threshold of 0.5% of the trait mean) indicated an important impact of recent inbreeding, while 33% of chromosomes (21%–50% depending on the trait) displayed important effects of older inbreeding events.

Six scenarios of inbreeding evolution over generations were observed depending on the trait and chromosome. We present them below, from the most common to the least frequent.

The first scenario corresponded to negative effects of recent inbreeding (as shown in Figure 5 for PW on Omy6; SW on Omy4). The second scenario consisted in positive effects of recent inbreeding (e.g. Figure 5 for PW on Omy22; SW on Omy12). The third scenario was associated with negative effects of older inbreeding events (as shown in Figure 5 for SW on Omy28). The fourth scenario was related to positive inbreeding effects in old generations (e.g. Figure 5 for PW on Omy13; SW on Omy30), while the fifth scenario corresponded to observations of negative inbreeding effects accumulated from old to recent generations (as shown in Figure 5 for PW on Omy11; SW on Omy16). The last scenario was related to positive inbreeding effects accumulated from old to recent generations (as shown in Figure 5 for PW on Omy28).

4 | DISCUSSION

Because inbreeding effects are mainly due to dominance genetic effects, we first of all quantify and discuss the importance of dominance effects on performance.

4.1 | Genome-wide dominance effect on female size and reproduction traits

Dominance variance arises from heterozygotes deviating from the mean of the two homozygotes. Loci with overdominant alleles (i.e. inducing a heterozygote advantage) cause high dominance genetic variance in populations (Haldane, 1947), whereas the partial dominance hypothesis predicts that most genetic variations will be additive when the mutations are incompletely recessive (Houle et al., 1992). Therefore, the partitioning of genetic variance into components of additive variance and dominance variance may help to assess the relative contributions of genetic load and heterozygote advantage to genetic variations in performance.

At least 4% of the phenotypic variances of the female size and reproduction traits were explained by dominance effects in our study. The high dominance ratios (up to 19%) we estimated for reproduction traits (particularly spawn weight and egg number) when compared to size traits may have corresponded to a larger number of loci with overdominant alleles acting on female fecundity.

As far as we know, the literature is very scarce regarding estimates of variance dominance in fish, except for growth and size traits. Based on pedigree estimates and large number of families composed of about 100 full-sibs in three populations of rainbow trout, the d^2 for rainbow trout body weight (Pante et al., 2002) ranged from 0% to 21% depending on the populations. With a similar family structure in four populations of Atlantic salmon, Rye and Mao (1998) indicated that dominance and additive-by-additive epistasis variances were equal to or greater than the additive variance for body weight, with ratios ranging from 2% to 9% and 13% to 16% of phenotypic variance, respectively.

In a recent study based on genomic information on Nile tilapia, Joshi et al. (2020) showed that nonadditive genetic effects were negligible regarding body length and were explained by additive-byadditive epistasis rather than dominance for body weight at harvest. They reported that under pedigree analysis, the additive-by-additive epistasis component was confounded with the dominance component. Our low estimates of dominance ratios for postspawning body weight and female fork length therefore appear to be in relatively good agreement with these previous findings in different fish species.

Regarding d^2 estimates for reproduction traits, we could only compare our estimates to previous studies in terrestrial livestock species where dominance variance ratios were estimated at around 2% for pig litter size (Vitezica et al., 2016, 2018) and 0%–10% for layers on reproduction traits (i.e. egg production, egg colour, egg weight and yolk weight) (Heidaritabar et al., 2016; Misztal & Besbes, 2000).

To the best of our knowledge, our study is the first to have looked at the partitioning of phenotypic variance when performance is corrected for chromosomal inbreeding effects rather than a genome-wide inbreeding effect. The estimates of dominance variance were markedly higher when applying a D-GBLUP model with multiple corrections for all the 30 chromosomal inbreeding coefficients (F_{omy}) compared to simple regression on the genome-wide inbreeding coefficient (Table 3). While this important increase in dominance variance captured by the model using the combined effects of all F_{omy} was mainly associated with a reduction in residual variances for reproduction traits, it was generally associated with a reduction in additive genetic variance among female size traits. The reduction in residual variances WILEY

corresponded to a better fit of the model to the data (minimum AIC value) but did not provide any clues regarding the mechanisms that underlie dominance for reproduction traits. The reduction in genetic variance for size traits could perhaps be explained by additive-by-additive epistasis effects captured in the dominance effect when regressing performance on all F_{omy} , which could confirm the pseudo-overdominance hypothesis affecting some loci (Ohta & Kimura, 1969).

4.2 | Genome-wide inbreeding effect on female size and reproduction traits

The mean levels of recent (6.6%) and total (17.3%) inbreeding in the ninth generation of selection of the population under study were slightly higher than previous estimates (5.8% and 16.6%, respectively) in the eight generation (D'Ambrosio et al., 2019). This corresponds to an increase in inbreeding rate ΔF of 0.7% in one generation, which is below the 1% limit targeted under the optimal contribution selection procedure recommended for fish breeding programmes (Skaarud et al., 2014).

Nevertheless, inbreeding levels were quite high when compared to those that can be observed in terrestrial livestock (D'Ambrosio et al., 2019). The main objective of our study was therefore to quantify inbreeding effects at different genomic scales (all genome, chromosome or region-wide), as well as at different time periods. Considering that the positive effects of inbreeding we observed on spawning date were in fact unfavourable because they delayed the moment of spawning, we can sum up our results by saying that unfavourable or null effects of genome-wide inbreeding were estimated on all female size and reproduction traits.

These results corroborate widespread observations of inbreeding depression on fitness-related traits. First of all, the significant negative inbreeding effect observed on average egg weight was undoubtedly unfavourable as large egg size is advantageous in terms of fitness (Einum & Fleming, 1999; Hutchings, 1991); egg size has a direct effect on the body size of offspring at emergence and hence on fry survival. As for spawning date, delayed spawning in a wild context is considered to be favourable to fitness when predators and competition exist between either females for spawning space (Essington et al., 1998) or offspring for territory (Brännäs, 1995). Without predators, however, early spawning may be advantageous because offspring can grow faster than progeny born later because of their access to the best available feeding habitat (Brännäs, 1995; Einum & Fleming, 2000). We can hypothesize that spawning date is always under stabilizing selection when environmental conditions remain unchanged, as it has been suggested by Ford et al. (2006) evaluating long-term changes in a naturally spawning coho salmon population after several decades of intensive hatchery supplementation. Their study showed an optimum run timing observed with fish that returned to their native creek at either end of the run timing distribution producing fewer offspring compared with fish that returned in the middle of the distribution. Under farming and selection

conditions, early spawning is expected to be favourable to fitness because offspring are then larger and have a greater chance of being selected (Chevassus et al., 2004). In addition, delayed spawning leads to larval rearing at warmer temperatures, which is unfavourable for some species of salmonids and may increase fry mortality (Crozier & Zabel, 2006; Smith et al., 2003).

It therefore makes sense to interpret the significant positive inbreeding effect observed on spawning date in our commercial selected line as being unfavourable in terms of fitness.

It should be noted that we did not observe any significant genome-wide effects of inbreeding for size traits, although such effects have generally been observed in studies on salmonids and particularly on rainbow trout. In terms of postspawning weight in rainbow trout, Su et al. (1996) estimated an inbreeding depression of 3.9% per 0.1 unit increase in inbreeding. Pante et al. (2001) estimated a reduction in body weight at harvest that ranged from -1.7% to -5.0% per 0.1 unit increase in inbreeding, depending on the population, the highest values being very similar to earlier estimates for adult body weight (Gjerde et al., 1983; Kincaid, 1983). All these estimations were higher than ours with respect to female postspawning weight. Our estimate (-0.9% per 0.1 unit increase in F) was closer to an estimate of 2-year weight in four Atlantic salmon populations, ranging from -0.6% to -2.6% per 0.1 unit increase in F (Rye & Mao, 1998). Based on genomic information, Waters et al. (2020) found that inbreeding did not affect female weight and fork length in two hatchery lines of Chinook salmon derived from the same source. Inbreeding and its potential effects on growth depend on a variety of factors, including environmental conditions (Armbruster & Reed, 2005), that may explain the variable effects observed across salmonid populations.

Concerning inbreeding effects on reproduction traits, Waters et al. (2020) showed in Chinook salmon that inbreeding did not affect fecundity but delayed spawn timing by 1.75 days per one standard deviation increase in F. While we also observed a significant delay in spawn timing (with an increase of +12% in SD per +0.1 unit increase in F in our trout population), we detected some inbreeding depression effects on spawn weight (-3.5% per + 0.1 unit in F) and EN (-1.0% per +0.1 unit in F), although these effects were not statistically significant. The inbreeding effect on egg number was modest when compared to the estimate of -6.1% for EN per +0.1 unit increase unit in F derived from an experimental line of rainbow trout (Su et al., 1996). This negative inbreeding effect is likely to be unfavourable in terms of fitness, because a large number of eggs is expected to produce a large number of juveniles, at least if egg quality is not altered when egg production is high. While a slight negative phenotypic correlation was observed in our study population between average egg weight and egg number, a null genetic correlation had been estimated between them (D'Ambrosio et al., 2020), which corroborates earlier results in the rainbow trout (Su et al., 1996). Assuming that egg weight is a good predictor of egg quality, we can hypothesize that the fall in EN and EW values observed with increased inbreeding levels would be unfavourable to fitness in rainbow trout populations.

All these varying results across studies could be due to species differences, environmental differences (Armbruster & Reed, 2005), different degrees of inbreeding and performance or population management factors. For example, the effect of inbreeding may be undetectable on fitness traits if the rate of inbreeding is slow (Wang et al., 1999).

4.3 | Local inbreeding effects on female size and reproduction performance

Because of the marked variations in inbreeding levels we observed along the genome, it was indeed intuitive to expect stronger and more variable effects of local inbreeding than those of genome-wide inbreeding. The first question we tried to address was therefore whether a higher chromosomal inbreeding coefficient corresponded to greater inbreeding effects on performance? The general answer was that no strong associations were observed between the chromosomal inbreeding level and the corresponding regression coefficient impacting performance. However, for all traits, higher recent chromosomal inbreeding levels ($F_{G3,omy}$) have been associated with negative effects on performance (Table 5), although these trends were only clear for CF, SW and EN. This observation is consistent with the literature, where it has been said that recent inbreeding has more deleterious effects than older inbreeding (Doekes et al., 2019).

When focusing on chromosomal and region-specific inbreeding effects on performance, we observed a mixture of negative and positive effects on each trait. This phenomenon had been also shown in a wild bird population by Botero-Delgadillo et al. (2020) through a correlation study between heterozygosity and fitness traits. Because region-specific inbreeding effects are not exclusively unfavourable, the global unfavourable or null effects observed for genome-wide inbreeding should however correspond to an accumulation of larger numbers and/or stronger impacts of unfavourable local inbreeding effects. For example, F_{10} had a significant negative effect on spawn and average egg weight (Figure 3), but to the best of our knowledge, no QTL has been found to be related to female reproduction traits on Omy10. As for the favourable effects of inbreeding, we should underline the significant positive effect of F_{28} on female length and weight (Figure S2), which may be linked to a putative QTL on Omy28 and which explained about 1.5% of genetic variance in body weight at 18 months in a Chilean rainbow trout line (Neto et al., 2019). Two candidate genes have been identified in this QTL region (located between 20.6 and 21.3 Mb): G protein-coupled receptor-54 like 1 (GPR54L1) and early growth response 1 (EGR1), which plays an important role in growth processes (Aljada et al., 2002; McKee et al., 1997). These results may explain the positive effect of inbreeding on the second region r₂ of Omy28 with respect to female size traits in our French line. Increased size performance (PW and FL) has undoubted favourable effects in terms of fitness among farmed populations. Firstly, large body weight is one of the main selection goals for breeders, and secondly, large body size has been positively correlated with fish survival and reproduction in several

studies (Foote, 1990; Huang & Gall, 1990; Pollock et al., 2007; Quinn & Peterson, 1996).

When focusing on local windows of 20 Mb within a chromosome, we also observed strong variations in inbreeding effects for all traits. For example, and as shown in Figure 3, for average egg weight and Omy1 we observed a small but significant favourable effect on region r3 (from 40 to 60 Mb), but a clearly unfavourable inbreeding effect on region r4 (60 to 80 Mb). Regarding the latter case, several QTLs for egg weight have been detected on the same dataset (D'Ambrosio et al., 2020) and deleterious haplotypes have been observed in another French line (Fraslin et al., 2020) that might explain inbreeding depression.

These observations convinced us that the study of local inbreeding is of prime importance to identifying genomic regions and genes with a major impact on inbreeding depression or, on the contrary, regions where inbreeding should be favoured. Further study of inbred regions will help us to highlight selective sweeps and genomic signatures of selection (Aramburu et al., 2020), thus retracing the evolutionary history of the population. Although we have considered the identified QTLs in splitting chromosomes in 20-Mb regions, we probably cut some ROHs into two segments and the QTLs may not locate in the same region as the majority of the ROHs. Therefore, the search for regions where increased inbreeding is associated with impaired phenotypic performance is not trivial. The use of sliding windows of small size rather than fixed 20-Mb windows may overcome this issue and help to better estimate local inbreeding effects.

4.4 | Origin and evolution of inbreeding along the genome

The second objective of our study was to propose underlying mechanisms that might explain our observations regarding temporal and spatial inbreeding effects. All hypotheses relate to underlying mechanisms associated to nonadditive genetic effects, but their long-term implications are not the same. For the overdominance hypothesis, selection would favour heterozygote states at multiple loci, so that mutations would be maintained by mechanisms related to balancing selection. Under the partial dominance hypothesis, the selection of inbred individuals with good performance to become reproducers would purge any deleterious alleles generated by mutations (Kristensen & Sørensen, 2005).

We have identified six scenarios that describe the evolution of local inbreeding effects over time. Here, we will connect these scenarios with some hypotheses including the three that underlie inbreeding depression, that is partial dominance, overdominance and pseudo-overdominance.

Scenarios with inbreeding effects due to recent inbreeding are the most common, particularly when the effects are negative, as has also been shown in cattle (Doekes et al., 2019; Makanjuola et al., 2020). Our first scenario, corresponding to the unfavourable effects of recent inbreeding, might be explained by any of the three hypotheses underlying inbreeding depression. Under the partial dominance hypothesis, this means that recent deleterious alleles have not yet been purged. Under the overdominance and pseudo-overdominance hypotheses, inbreeding depression is not subject to any allelic purge (Charlesworth & Willis, 2009). The second scenario corresponds to a favourable effect of recent inbreeding. This can be explained by one favourable allele or underdominance, which corresponds to the disadvantages of a heterozygous genotype regarding reproductive success (the advantage of both homozygous genotypes) that increased the frequency of homozygotes (Reed et al., 2013).

Scenarios 3 and 4 concern the regions where we observed older inbreeding effects on performance which were either unfavourable (scenario 3) or favourable (scenario 4).

Scenario 4 corresponds to either an underdominance phenomenon or to the purging of deleterious alleles (under the partial dominance hypothesis), leading to the fixation of favourable alleles and improved fitness associated with domestication and/or selection phenomena. Purging tends to regress inbreeding depression towards zero because homozygosity in some genomic regions is no longer unfavourable (Boakes et al., 2007). Scenario 3 relates to a lack of purging and local recombination events under the three hypotheses of inbreeding depression, leading to the maintenance of old inbreeding with unfavourable effects on performance (Hedrick, 1994). This lack of effective purging can be explained by alleles, which have only minor unfavourable effects on performance. Indeed, the purging mechanisms are effective in the case of alleles with severely deleterious or even lethal effects (Charlesworth et al., 1990; Wang et al., 1999), which are purged at a faster rate than mildly deleterious alleles. In the case of rare alleles with minor effects, deleterious alleles can be eliminated over hundreds or even thousands of generations (Hedrick, 1994; Hendry et al., 2011; Lande & Schemske, 1985; Larsen et al., 2011). As a direct consequence of purging, populations with a long history of inbreeding are likely to be less affected by inbreeding depression than others with similar levels of inbreeding because they have had more opportunity to purge deleterious alleles than those with recent inbreeding history (Day et al., 2003; Ehiobu et al., 1989). As we observed quite frequently under scenario 3, we can suppose that the bottleneck associated with initial steps in rainbow trout domestication and selection have increased the mutational load of the population and caused an accumulation of deleterious alleles without it being possible to purge them all (Bosse et al., 2019).

The least frequent scenarios with unfavourable (scenario 5) or favourable (scenario 6) effects from old to recent inbreeding correspond to genomic regions subjected to a combination of events observed in the previous scenarios. Recent inbreeding effects are observed, but a lack of purging of deleterious alleles or a low recombination rate in those specific regions may maintain unfavourable old inbreeding effects.

For all the scenarios revealing unfavourable effects of inbreeding, it is not possible to differentiate the three hypotheses underlying inbreeding depression. Nevertheless, the high estimates of dominance variance for some traits may indicate that these traits might be more affected by overdominant loci.

4.5 | Variable evolution of inbreeding effects depending on traits

Inbreeding effects vary considerably along the genome but also from one trait to another because of different histories during domestication and selection processes.

Size traits have been strongly selected since species domestication. The purging of deleterious alleles has already occurred and some favourable alleles for growth function have been selected, thus explaining the positive effects of old inbreeding such as those observed on Omy28. Favourable effects of recent inbreeding are also observed on Omy22, although no QTL seems to have been identified yet for body weight or size on this chromosome, apart one linked to head yield in a different French rainbow trout population line (Blay et al., 2021).

Globally, we found that all chromosomal inbreeding effects were low for female length and weight, as were the estimates of dominance variance which did not exceed 7%. We therefore believe that the partial dominance hypothesis is the best to explain inbreeding depression affecting female size traits.

By contrast, the quantity of coelomic fluid (CF) is not a trait under direct selection. We observed the highest chromosomal inbreeding effects for this trait and a general trend towards an accumulation of recent and older chromosomal inbreeding effects. We can therefore assume that inbreeding depression for this trait is due to an accumulation of deleterious mutations. There are no mentions in the literature regarding the quantity of coelomic fluid, but its composition appears to be linked to progeny survival (Inanan, 2020; Kobayashi et al., 2001). Nevertheless, our CF results need to been taken with caution as CF was a trait derived indirectly through the use of three weight measurements.

For spawning date, we observed both a significant genome-wide inbreeding effect and marked chromosomal inbreeding effects. As a result of the low estimate for the dominance variance ratio (5%), the overdominance hypothesis could not explain a large part of inbreeding effects and the hypothesis of partial dominance should be preferred to explain inbreeding depression.

A significant genome-wide inbreeding effect was also observed for average egg weight, while chromosomal inbreeding effects were null and the dominance ratio was moderate (8%). We therefore postulate an accumulation of small negative inbreeding effects due to slightly unfavourable alleles, which is consistent with the partial dominance hypothesis underlying inbreeding depression for egg weight.

As for the fecundity traits spawn weight and egg number, we observed quite similar profiles of temporal and local inbreeding effects, consistent with their high genetic correlation (D'Ambrosio et al., 2020). Although we did not estimate any significant genome-wide inbreeding effect for these two traits, numerous chromosomes displayed significant and high inbreeding effects. In addition, the dominance variance ratios were quite high (19% for SW and 14% for EN). We can therefore assume that the inbreeding depression observed for fecundity traits could be explained by both the partial dominance and overdominance hypotheses.

5 | CONCLUSION AND IMPLICATIONS

To conclude, we observed very variable inbreeding effects on female size and reproduction traits along the genome and over generations. These results suggest that local inbreeding can strongly impact performance without observing any effects of genome-wide inbreeding. In general, and as might usually be expected, we observed either null or unfavourable effects of genome-wide inbreeding on female size and reproduction traits. However, some favourable effects of local inbreeding were also observed and could be explained by either the selection of favourable homozygotes in the population or an underdominance effect of the heterozygotes. Partial dominance appeared to be the main hypothesis explaining inbreeding depression for all the traits studied, although regarding fecundity traits (spawn weight and egg number), the overdominance hypothesis could also play a significant role in inbreeding depression. Future studies need to focus on the evolution of inbreeding effects near regions under intense directional selection. The limitation of using ROH-based metrics to identify a region associated with inbreeding depression is that a region with long stretches of homozygosity may contain multiple ROH genotypes with variable effects on the phenotype of interest. Further investigations are therefore necessary to determine which specific ROH genotypes result in unfavourable performance.

These new findings offer important keys to the future management of breeding programmes by considering the local genomic scale and not just the genome-wide scale to allow inbreeding in areas where its impact is favourable, and limit it when its effect is deleterious on traits of interest. To achieve this, two options have been advocated to reduce inbreeding depression; purging induced by deliberate inbreeding and genetic rescue.

Chapitre 4

Détection de signatures de sélection positive ou équilibrante communes à quatre populations domestiquées de truite arc-en-ciel

Au fil du temps les populations évoluent, s'adaptent à leur environnement, laissant des traces spécifiques dans le génome. Alors que de nombreuses espèces de poissons font encore l'objet d'un processus de domestication, la domestication de la truite arc-en-ciel est plus ancienne (cf Chapitre 1, partie 1.1.2) et des programmes de sélection existent depuis déjà une trentaine d'années en France. L'objectif de cette étude est d'identifier des régions génomiques sous signatures de sélection dans différentes populations de truites, soit simplement domestiquées, soit soumises à sélection artificielle depuis au moins 8 générations.

Dans ce dernier chapitre présentant les travaux de thèse, nous avons cherché par la détection de traces de sélection communes à différentes populations domestiquées à répondre aux questions suivantes : **Existe-t-il des régions du génome des truites arc-en-ciel, très homozygotes, sous sélection positive conservées entre plusieurs populations domestiquées ? Ou bien des régions hétérozygotes, sous sélection équilibrante également partagées entre plusieurs populations domestiquées ? Ces régions sont-elles simplement en lien avec des fonctions essentielles dans la survie et la reproduction des truites ? Ou sont-elles liées fortement au processus de domestication des populations ?**

Nous avons utilisé deux méthodes, basées sur les îlots de consanguinité (ROH) et l'Homozygotie d'Haplotype Étendue (EHH), pour détecter des signatures de sélection récente (positive ou équilibrante) communes à quatre populations de truite arc-en-ciel domestiquées (originaires d'Amérique du Nord et de France). Nous avons ensuite identifié les fonctions des gènes contenus dans les régions fortement homozygotes ou hétérozygotes, communes à ces quatre populations et avons regardé si ces gènes avaient déjà été identifiées comme des gènes clés dans des processus de domestication ou sélection d'animaux d'élevage.

Conclusion du Chapitre 4

Treize régions ont été identifiées sous sélection positive ou équilibrante dans les quatre populations de truites arc-en-ciel étudiées (originaire d'Amérique du Nord et de France). Alors que dans les régions fortement homozygotes, de nombreux gènes dont les fonctions sont variables (comportement, croissance, immunité, reproduction, développement embryonnaire et organisation cellulaire) et touchent toutes les fonctions liées à la survie et la domestication de l'espèce ont été identifiées sous sélection positive, les gènes identifiés sous sélection équilibrante (présents dans les régions hétérozygotes) semblent avant tout liés à la seule à la *fitness* des individus (organisation cellulaire, développement embryonnaire et immunité).

Cette étude nous permet de confirmer l'importance d'un large ensemble de gènes déjà détectés comme étant sous sélection positive dans diverses espèces animales et d'identifier de nouveaux gènes candidats importants pour la survie et la domestication chez la truite arcen-ciel. Ces résultats doivent permettre d'établir une première carte génomique des régions où la diversité génétique est soit à éviter, soit à privilégier dans les populations de truite arcen-ciel domestiquées en particulier quand elles sont soumises à sélection artificielle.

Les différents résultats obtenus dans ce chapitre ont été présentés lors d'une communication orale au congrès *Génétique en Aquaculture* (GIA) en 2022 et ils ont également fait l'objet d'un projet d'article « *Genome-wide detection of positive and balancing selection signatures shared by four domesticated Oncorhynchus mykiss populations* » présenté ici et soumis à *Molecular ecology*.

Genome-wide detection of positive and balancing selection signatures shared by four domesticated rainbow trout populations (*Oncorhynchus mykiss*)

Abstract

Evolutionary processes leave footprints across the genome over time. Highly homozygous regions may correspond to positive selection of favourable alleles, while maintenance of heterozygous regions may be due to balancing selection phenomena. We analyzed 176 genomes coming from 20 sequenced US fish and 156 fish from three different French lines that were genotyped using a HD Axiom Trout Genotyping 665K SNP Array. Using methods based on either Run of Homozygosity or Extended Haplotype Homozygosity, we detected selection signals in four domesticated rainbow trout populations. Nine genomic regions composed of 253 genes, mainly located on chromosome 2 but also on chromosomes 12, 15, 16, and 20, were identified under positive selection in all four populations. In addition, four heterozygous regions containing 29 genes putatively under balancing selection were also shared by the four populations and located on chromosomes 10, 13, and 19. Whatever the homozygous or heterozygous nature of the region, we always found some genes highly conserved among vertebrates due to their critical roles in cellular and nuclear organisation, embryonic development or immunity. We identify new promising candidate genes involved in rainbow trout fitness, as well as genes already detected under positive selection in other fishes (auts2, atp1b3, zp4, znf135, igf-1a, brd2, col9a2, mrap2, pbx1, emilin-3). These findings represent a genome-wide map of signatures of selection common over rainbow trout populations, which is the foundation to understand the processes in action and to identify what kind of diversity should be preserved, or conversely avoided in breeding programs, in order to maintain or improve essential biological functions in domesticated rainbow trout populations.

1| Introduction

Any population, whether animal or plant, wild or domesticated, evolved through continuous and cumulative changes over time (Wright, 1931). It relies on various evolutionary forces, mutation, migration, selection, and genetic drift, whose relative effects may vary depending on population history and structure. For example, genetic drift is more substantial when the effective population size is small and randomly induces fixation of alleles, which may lead to degeneration and extinction due to the fixation of deleterious alleles in small populations (Smith & Haigh, 1974). When modifications of environmental conditions occur, allele frequencies will change to a new relevant equilibrium, as a result of natural selection. Indeed, favorable alleles in a particular environment due to either new mutations or standing variation, will be positively selected. In wild populations, favourable alleles are generally affecting fitness through individual survival, mating, or fertility (East, 1918; Fisher, 1958). Natural selection can also act by negative (or purifying) selection that hinders the spread of deleterious alleles (Charlesworth et al., 1995). These two processes tend to reduce the genetic diversity at the target genes but had different effect on the genome, positive selection leading to stronger selection signatures (selective sweep) than negative one. Conversely, the population's polymorphism can be actively maintained in some rare genomic regions through balancing selection that keeps an equilibrium in the frequencies of alleles. The two main biological causes of balancing selection are heterozygote advantage at a single locus, known as overdominance effect, and frequencydependent selection with a rare-allele advantage that tends to restore a frequency equilibrium between alleles at the population level (Charlesworth, 2006, Fijarczyk & Babik, 2015).

Domestication is the evolutionary process of genetic adaptation over generations of a wild population to handling by humans and breeding in captive environments (Darwin, 1859, 1868; Price, 1984). During domestication, humans exert artificial selection pressure on the initial population by choosing and organizing the reproduction of the most adapted individuals to cohabitation or more globally to those whose aptitudes correspond the best to their expectations (Price, 1999; Russell, 2002), such as a less fearfulness of humans (Price, 2002; Harri et al., 2007). Domestication induces severe genetic bottlenecks due to the selection and reproduction of only a few adapted animals from the wild population. Thus, many genetic evolutionary processes, such as selection, genetic drift, and inbreeding, have a significant role in the evolution of farmed animal populations (Helmer, 1992; Mignon-Grasteau et al., 2005). The domestication process affects life history traits due to changes in morphological, physiological, reproductive, behavioural, and immune functions (Mignon-Grasteau et al., 2005; Pulcini et al.,

2013; Milla et al., 2021 for review in fishes) compared to their wild relatives (Darwin, 1859, 1868). Wilkins et al. (2014) suggest that these specific modifications, called domestication syndrome, may be due to mild deficit of neural-crest cells during embryonic development in domesticated animals. In addition, both natural and artificial selection in domesticated species leaves footprints across the genome, known as selection signatures, which can point to regions harboring essential genes for domestication or natural fitness (Dobney & Larson, 2006; Qanbari & Simianer, 2014; Wright, 2015).

Compared to domestication in terrestrial animals (Mignon-Grasteau et al., 2005), fish domestication is recent and was first documented with carp about 2,000 years ago. The precise date and location (Neolithic China or at the Roman period in Central and East Europe) of the carp domestication are still debated (Balon, 1995; Balon, 2004). However, most farmed fish species have only been domesticated since the last century. The rainbow trout is native to the Pacific drainages of North America and to Kamchatka in Russia and its domestication started in the 1870s in California (Hershberger, 1992; Gall & Crandel, 1992). It was then introduced in Western Europe at the beginning of the 20th century (Fabrice, 2018).

Numerous studies have been carried out over the last ten years to detect signatures of selection in farmed fish species (Channel Catfish: Sun et al., 2014; Atlantic salmon: Mäkinen et al., 2015; Gutierrez et al., 2016; Liu et al., 2017a; Pritchard et al., 2018; López et al., 2019; Carp: Su et al., 2018; Nile Tilapia: Hong et al., 2015; Cádiz et al. 2020; Yu et al., 2022; Rainbow trout: Cádiz et al., 2021; Coho salmon : López et al., 2021; Australasian snapper: Baesjou & Wellenreuther, 2021; Brown trout: Magris et al., 2022) in order to identify genomic regions involved in recent adaptation or domestication processes (Smith & Haigh, 1974; Pennings & Hermisson, 2006). In this study, we were interested in farmed rainbow trout populations as it is one of the oldest farmed fish and the analysis of genes under either positive or balancing subsequent selection in. Indeed, only a few studies on selection signatures were performed in rainbow trout. Three of them only focused on wild populations and showed signatures of selection linked to life-history variation, egg development, spawning time (Martínez et al., 2011), immune response (Limborg et al., 2012), and smoltification (Weinstein et al., 2019). The first study in domesticated rainbow trout was performed on a single Chilean population (Cádiz et al., 2021) genotyped with a 57K SNP array; identified signatures of selection were associated with early development, growth, reproduction and immune system. Recently, a high-density array (665K SNPs) was developed for rainbow trout (Bernard et al., 2022), allowing us to potentially more accurately detect signatures of selection and to compare them across various domesticated rainbow trout populations. The existence of signatures of selection shared by farmed populations from different geographical areas is essential to understand the importance of genetic diversity in several genomic regions in rainbow trout and then to identify genes having key roles in either the domestication process or fitness because conserved by all populations (Bruford et al., 2003; Yáñez et al., 2022).

Various approaches have been developed to reveal selection signatures within population based on site frequency spectrum, linkage disequilibrium (LD), or reduction of local variability (Vitti et al., 2013; Saravanan et al., 2020). Among these approaches, we will use two strategies, one based on the reduction of local variability using Run of Homozygosity (ROH) metrics and the second one relying on allele frequencies and the extent of LD based on Extended Haplotype Homozygosity (EHH). ROH is a large homozygous stretch in the genome of an individual inherited from a common ancestor to his parents (McQuillan et al., 2008; Purfield et al., 2012), while EHH measures the extent of shared haplotypes through the association between a single core haplotype and multiple loci at various distances from the core region (Sabeti et al., 2002). In our study, we considered four populations: one INRAE experimental line (with no intentional selection), two French selected lines from two different breeding companies, and a pooled American population gathering samples from one wild river and four hatchery populations, all coming from the North-West of the USA and closely genetically linked (Gao et al., 2018). Our work aimed to discover the main genomic regions sharing strong homozygosity (positive selection) or heterozygosity (balancing selection) across the four rainbow trout populations and to get further insights into the nature of genes spanning these regions.

2 | Material and methods

2.1 / Populations

Three French populations were considered: 14 breeding females from the INRAE synthetic line SY and, 90 and 72 females from two selected lines LB and LC from the breeding companies "Bretagne Truite" (Plouigneau, France) and "Viviers de Sarrance" (Sarrance, France) respectively. The SY was developed by intercrossing several domesticated lines of rainbow trout, in order to create a population with a large diversity (D'Ambrosio et al., 2019). In addition, we considered an American pooled population, hereafter named HA, using the

whole genome sequence data of 20 fishes obtained by Gao et al. (2018). The sampling strategy consisted in collecting DNA from 4 individuals in each of five locations from the North-West of the USA: wild fish from Elwha River, and farmed fish from Dworshak, L. Quinault, Quinault, and Shamania hatcheries. We pooled together the 20 individuals, as these five populations were genetically close to each other (Supplementary Figure 1; Gao et al., 2018) and greatly distant from the three French populations (Figure 1).

2.2 / Genotyping and quality control

High-density genotypes were obtained at the INRAE genotyping Platform Gentyane (Clermont-Ferrand, France) for all the 176 French samples using the Affymetrix 665K SNP array recently developed for rainbow trout (Bernard et al., 2022). We only considered the genotypes for the 576,118 SNPs of the Rainbow Trout Axiom® 665K SNP array that were positioned on the Arlee genome (GCA_013265735.3, Gao et al., 2021; Bernard et al., 2022). From the whole-genome sequence information of the 20 American samples (Gao et al., 2018), we extracted the genotypes for the same 576,118 SNPs of the HD chip.

Among the 177 French genotyped fish, 19 individuals with more than 30% identity-by-state (IBS) with other individuals were removed from the dataset. We thus kept for the analysis 76, 67, 20, and 14 fish sampled from LB, LC, HA, and SY populations, respectively.

Then, SNP quality control was performed using PLINK v1.9 software (Chang et al., 2015). Note that, to avoid limitations due to the low number of individuals in SY, quality filters were made considering LC and SY together, as both populations were genotyped on the same SNP plate and are close genetically (D'Ambrosio et al., 2019). About 4,000 SNPs randomly distributed over all the genome were removed for all populations due to extreme deviation from Hardy-Weinberg equilibrium (p-value < 10-7). It allowed us to discared SNPs with high risk of wrong genotyping, in addition to the edit for SNP call rate lower than 97%. We retained 571,319 SNPs, 569,030 SNPs, and 573,793 SNPs on LB, 'LC- SY', and HA populations, respectively. Finally, crossing the three SNP lists, we kept the 546,903 common SNPs for the analysis.

2.3 / Genetic structure of the populations

Genetic differentiation between populations was measured with a pairwise Fst estimate using the VCFtools v0.1.13 software (Danecek et al., 2011). In addition, a principal component analysis (PCA) was performed with the R package *Adegenet* (function *glPca*) (Jombart & Ahmed, 2011) to visualize the genetic structure of the populations.

2.4 | Runs of homozygosity

Runs of homozygosity (ROH) were identified for each fish using the PLINK v1.9 *homozyg* function (Chang et al., 2015) with the following options '--*homozyg-kb 500 –homozyg-windowsnp 40 –homozyg-snp 40 –homozyg-gap 500 –homozyg-density 40 –homozyg-het 1*'. ROH was defined by a sliding window with a minimum length of 500 kb containing at least 40 homozygous SNPs. This minimum number of homozygous SNPs was chosen using the formula described by Purfield et al. (2012) in order to limit the number of ROHs that might only occur by chance.

2.4.1 | Estimation of inbreeding coefficients

The individual inbreeding coefficients (F_{ROH}) were calculated according McQuillian et al (2008) as $F_{i,ROH} = \frac{\sum length(ROH_i)}{LGenome}$

With $\sum length(ROH_i)$ the sum of ROH length in an individual *i* and *LGenome* the total length of the autosomal genome covered by SNPs.

2.4.2 | Identification of ROH islands

For each SNP, the number of individuals with this SNP included in a ROH was calculated in order to identify the regions of the genome that were frequently homozygous in each population, i.e. constituting ROH islands (Nothnagel et al., 2010). These ROH hotspots may then be considered as signatures of positive selection (Saravanan et al., 2021).

To allow the comparison of ROH islands across populations, we implemented populationspecific thresholds based on the ROH occurrence to define ROH islands, as proposed in many studies (Purfield et al., 2017; Mastrangelo et al., 2017; Zhang et al., 2018; Peripolli et al., 2018; Grilz-Seger et al., 2018; Gorssen et al., 2021; Illa et al., 2022). The number of individuals corresponding to the top 5% of SNPs most often found in a ROH within each population was chosen as a threshold to define a ROH island.

These top 5% values were equivalent to 35, 27, 5, and 10 individuals for LB, LC, SY, and HA, respectively. Values chosen within each population corresponded to 48.6%, 40.3%, 35.7%, and 50% of individuals with a ROH in LB, LC, SY, and HA, respectively. In addition, two close SNPs in the top 5% were considered in the same ROH island if there were separated by a

distance lower than 500 kb with less than 40 SNPs in the gap stretch. The ROH island was delimited by a number of individuals, with ROH falling below the top 10% of the SNPs, which correspond to 30, 22, 3, and 7 individuals for LB, LC, SY, and HA populations, respectively.

2.4.3 | Detection of balancing selection signals based on regions without ROH

We used the ROH occurrence information per SNP to detect extreme heterozygous regions, i.e. without ROH. In these regions, we have an enrichment of heterozygous SNP relative to the genome-wide prevalence that may be due to balancing selection phenomena (Szpiech et al., 2013).

Applying the same criteria as for defining ROH, the minimal size and number of SNPs to define a heterozygous region were fixed to 500 kb and 40 SNPs, respectively. Moreover, two successive SNPs were considered in the same region if they were separated by a distance lower than 50 kb. A region was detected in extreme heterozygosity if less than 5% of individuals (per population) have SNPs in ROH in the region, corresponding to a maximum of respectively 4 and 3 individuals with a ROH in LB and LC populations, and to 0 individual with a ROH in SY and HA.

2.5 / Detection of signatures of selection based on Extended Haplotype Homozygosity (EHH)

For a given core allele, the EHH is defined as 'the probability that two randomly chosen chromosomes carrying the core haplotype of interest are identical by descent for the entire interval from the core region to the point x' (Sabeti et al., 2002). EHH measures the association between a single allele from the study locus (the core region) with multiple loci at various distances x (Sabeti et al., 2002). The iHS (Integrated Haplotype Homozygosity Score) proposed by Voight et al. (2006) aims to compare the integrated EHH profiles obtained for a SNP in the ancestral versus derived states. An extreme value of iHS corresponds to a positive selection because a core haplotype with unusually high EHH and high frequency in the population indicates the presence of a mutation that has spread through the population faster than the haplotype broke down.

EHH methodology requires haplotype information. Thus, genotype data must be phased before their calculation. We used FImpute3 (Sargolzaei et al., 2014) to phase the genotypes of the study females, considering all parents (including our study females) and offspring genotyped

in LB, LC, and SY populations for different purposes (see respectively Prchal et al., 2022, Lagarde et al., 2022 and Paul et al., 2022). All parents (except 8 SY sires) were genotyped with the HD chip (Bernard et al., 2022), while offsprings (and 8 SY sires) were genotyped with a 57K chip only (Palti et al., 2015). Information used for phasing is given in Table 1. Due to the lack of genotyped offsprings, only the HD genotypes information was used to phase the genotypes of the HA population.

Once phasing was performed, the *rehh* R package (Gautier & Vitalis, 2012; Gautier et al., 2017) was used to conduct EHH-based analyses. EHH detection was stopped when the EHH value declined under 0.1 or when the gap between two consecutive SNPs was higher than 20 kb (*scan_hh* function with the following options: limehh = 0.1; maxgap=20 kb).

2.5.1 / Cross population Extended Haplotype Homozygosity (XP-EHH)

From EHH information, we used the XP-EHH statistics (*ies2xpehh* function) to compare the integrated EHH profiles (iES), two by two, between a French (popA) and the HA (popB) populations at the same focal SNP (Sabeti et al., 2007) as:

The median (*Med*) and standard deviation (*SD*) of $ln(iES_A/iES_B)$ were computed over all the analysed SNPs.

2.5.2 | Integrated Haplotype Homozygosity Score (iHS)

In the same way, we used the iHS test (Voight et al., 2006) to evaluate the evidence of positive selection based on haplotype frequencies in a single population, using the *ihh2ihs* function of the package *rehh*. This statistic was based on the log-ratio of the integrated EHH (iHH) for haplotypes with the ancestral (A) *versus* the derived (D) alleles and was computed for each

autosomal SNP as

The average ($Mean_p$) and standard deviation (SD_p) of ln(iHH_A/iHH_D) were computed over all the SNPs with a derived allele frequency p similar to that of the core SNP. In our study, the ancestral allele state is unknown. Therefore, we assumed that the most frequent allele represents the ancestral state as proposed by Bahbahani et al. (2015).

2.5.3 / Detection of candidate regions

To detect candidate regions for signatures of selection based on the iHS test, we used *the calc_candidate_region* function of the R package *rehh* (Gautier & Vitalis, 2012). We considered windows of 500 kb across the genome containing at least 30 SNPs, with 10 kb of overlapping. A region was considered as under positive selection if at least one SNP had a $-\log(p\text{-value}) > 4$ and extreme iHS value *i.e.* $|\text{iHS}| \ge 2.5$.

2.6 | Identification of common regions under positive selection

ROH islands and regions identified by iHS were pooled within each population. Then, the intersection set of the regions identified by one or another method across the four studied populations was established. We eliminated an intersection from the study if one population does not have at least one SNP with an $|iHS| \ge 2.5$ or enough individuals with an ROH in the intersected region. So, only intersections containing either ROH island or extreme iHS ($|iHS| \ge 2.5$) for the four populations were thus further analyzed.

2.7 / Gene analysis

The genes annotated in the regions under positive or balacing selection were identified from the NCBI *Oncorhynchus mykiss* genome assembly (GCA_013265735.3). Gene symbols were checked, and, if necessary, familiar names were added using the information available from GeneCards (https://www.genecards.org/).

Gene ontology (GO) terms study was performed with 'g:profiler' (Raudvere et al., 2019; https://biit.cs.ut.ee/gprofiler/gost) for the list of genes identified in the regions of interest.

Percent identity of rainbow trout proteins with nine other vertebrate species (human, mouse, cow, goat, pig, chicken, zebrafish, medaka, and Atlantic salmon) was established using the blastp tool (Basic Local Alignment Search Tool on proteins).

3 Results

3.1 / Genetic diversity within and across populations

The ROH statistics and inbreeding coefficients are presented in **Table 2** for all the populations. The average number of ROH per individual varied between 141 (SY) and 168 (LB). French selected lines had larger average sizes of ROH than populations SY and HA. The average inbreeding coefficients of HA individuals were between three (compared to SY) and five (compared to LB) times lower than those of the French lines.

Based on genome-wide Fst values, large differentiation of around 0.28 was observed between HA and any of the French populations (**Table 3**). In the PCA figure (**Figure 1**), the three French lines differed strongly from the American pooled populations, and the first two PCA axes explained 29% of the total genetic variation. In addition, Fst values indicated that all the French lines were moderately differentiated (0.104 - 0.122).

Using the XP-EHH statistics, we identified 93, 105 and, 135 regions that strongly discriminated HA from LB, LC and SY, respectively. Among these regions, 34 regions were shared, spanning about 32 Mb in total over 21 chromosomes, and differentiated any of the French lines from the American HA pooled population (Supplementary information S1).

The distribution of the proportion of individuals having a ROH at each SNP position is presented in Figure 2. In average, ROH were more shared between individuals for selected lines (LB and LC, on average, 23.39% and 19.82% of individuals respectively) than for other populations (SY and HA, on average, 13.67% and 8.91% of individuals respectively). Probably linked to the composite nature of the HA population (5 sub-groups of 4 individuals), HA contained the lowest number of shared ROH among the individuals but also showed the most shared ROH among individuals.

3.2 / Signatures of positive selection

3.2.1 / ROH islands

The sharing of ROH among individuals, regardless of the population considered, was presented Figure 3. Eight ROH islands were shared by at least 2 populations, and a minimum of 50% of individuals concerned. However, only three of these regions were defined as ROH island in each of the 4 populations.

We listed all ROH islands within each population which resulted in the identification of 270 ROH islands distributed among the four populations (Supplementary Informations S2 to S5,

for LB, LC, SY, and HA, respectively). The ROH islands were not evenly distributed across populations and chromosomes. The average ROH island size was 2,737 kb, varying from 1,593 kb to 4,465 kb, depending on the population. The longest ROH island was observed in SY (21.4 Mb), while the shortest one was observed in LC (16.1 kb).

3.2.2 / Identifying selection signatures using iHS

The $-\log(p\text{-values})$ of iHS calculated along the genome are presented in **Figure 4** for each population (all regions identified with *calc-candiate_region* are described in **Supplementary Informations S6-S9**). While numerous regions have been detected as under positive selection overall, fewer candidate regions were detected for the French lines (LB, LC and, SY) than for the Amercian pooled population (HA). The genome-wide highest estimated values of |iHS| were 8.97, 7.24, 5.67, and 9.09 for LB, LC, SY, and HA, respectively (with -log(p-values) > 7.8).

In total, 72, 68, 76, and 54 ROH islands were identified in LB, LC, SY, and HA populations respectively (**Figure 5**). Using iHS statistics, 55, 69, 73, and 362 signatures of selection were detected for LB, LC, SY, and HA populations, respectively. Only 10.4%, 8.7%, 8.0%, and 5.6% of the regions were detected by both methods (ROH + iHS) for LB, LC, SY, and HA populations, respectively.

3.2.3 / Regions under positive selection shared by the four studied populations

Among the numerous regions identified for each population by either ROH or iHS methods, only nine regions were shared by the four studied populations (Table 4). The average size of these shared regions was 1,135 kb. Five of them were located on chromosome 2, and the four other regions were on chromosomes 12, 15, 16, and 20, respectively.

Depending on the population, six regions were identified by either ROH or iHS metrics. Two regions, chr2_c and chr15_a, were only detected by ROH in all four populations, while a single region, chr16_a, was only identified through significant iHS statistics in all the four populations (Supplementary Information S10). The list of genes annotated in the nine shared genomic regions is given in Supplementary Informations S11.

3.3 / Signatures of balancing selection

3.3.1. Regions under balancing selection detected within population

In total, 14, 24, 158, and 265 hot spots of polymorphism (i.e. without ROH) were identified in LB, LC, SY, and HA populations, respectively. The numbers of heterozygous regions detected for SY and HA populations were drastically larger than those observed for the LB and LC selected lines. The average size of the detected heterozygous regions was 1,400 kb, varying from 1,086 kb to 1,828 kb, depending on the population.

Tables listing all heterozygous regions within each population are presented in Supplementary Informations S12 to S15, for LB, LC, SY, and HA, respectively.

3.3.2. Regions under balancing selection shared by the four studied populations

A substantial lack of ROH was observed in four regions of all studied rainbow trout populations (Table 5). Two of them, chr10_a and chr19_a, were particularly small (53 kb and 70 kb, respectively), but still contained at least 20 SNPs. The region chr10_a only encoded one of the introns of the *ctnna2* (= catenin alpha 2) gene while chr19_a was composed of two genes, *smarca5* (=SWI/SNF-related matrix-associated actin-dependent regulator of chromatin subfamily A member 5) and *frem2* (= FRAS1-related extracellular matrix protein 2). A second heterozygous region on chromosome 19 was larger (163 kb) but contained a single annotated gene, *pou4f2* (= POU domain, class 4, transcription factor 2-like). A last region chr13_a spanned over 1,100 kb) on chromosome 13 and was composed of 25 genes. The list of genes annotated in the four shared genomic regions is given in Supplementary Informations S16.

3.4 | Identification and roles of genes underlying the regions under selection across all populations

3.4.1. Common homozygous regions under positive selection

The nine common homozygous regions contained a total of 253 genes (listed in Supplementary Information S11). A gene ontology (GO) study was performed and showed a significant over-representation (p-value < 0.01) among the 253 genes of functions related to the following GO terms: membrane (GO:0016020, CC: Cellular Component, *p-value* = $1.3e10^{-5}$), intrinsic and integral component of membrane (GO:0031224; GO:0016021, CC, *p-value* = 0.001/0.005), ion binding (GO:0043167, MF: Molecular Function, *p-value* = 0.002), and nuclear speck (GO:0016607, CC, *p-value* = 0.008).

Among the nine studied regions, the three regions chr2_a, chr2_c, and chr15_a, that contain less than ten genes annotated in each, were analyzed in further detail to accurately define the roles of underlying genes. The 17 genes located in these three regions are listed in **Table 6** with their associated biological functions. These genes play key roles in protein transduction/maturation, genome stability, embryonic development, growth, energetic function, reproduction, or immune function. In addition to this list of genes, a subset of 15 genes in the six other homozygous regions already identified as signatures of selection in the literature were further studied in terms of their biological functions. Detailed information for these genes is also given in Table 6.

We studied the degree of protein identity among 10 vertebrate species for all the 17 genes of regions chr2_a, chr2_c, and chr15_a (Table 7), considering a protein as highly conserved if its identity between rainbow trout and other species was higher than 85%. Except for the proteins linked to *cep162* (centrosomal protein of 162 kDa) and *zp4* (zona pellucida sperm-binding

protein 4-like) genes, all other proteins were highly conserved at least between the two studied salmonids. In each of the three regions, one or two genes were highly conserved across the all ten study species: in chr2_a, rainbow trout *cdk14* (cyclin-dependent kinase 14) protein had a percent identity between 86 and 99.6% with the other species; in chr2_c, rainbow trout *brsk2a* (serine/threonine-protein kinase *brsk2*) protein had between 92 and 96.3 % of percent identity with the other species; in chr15_a, two genes, *chn1*(n-chimaerin) and *atp5mc1* (ATP synthase lipid-binding protein, mitochondrial), also had protein percent identity ranging from 85% to 98% depending of the species.

Some other rainbow trout proteins (*tsnare1*, t-SNARE domain-containing protein 1; *pttg1IP*, pituitary tumor-transforming gene 1 protein-interacting protein) were conserved to a lesser extent (minimum 65% of percent identity) with the three other fish species, some being also conserved at least with chicken (*adgrb1*, adhesion G protein-coupled receptor B1;*b4galnt4a*, N-acetyl-beta-glucosaminyl-glycoprotein 4-beta-N-acetylgalactosaminyltransferase 1) or even with all the nine study species (*zc3h15*, zinc finger CCCH domain-containing protein 15).

3.4.2. Common heterozygous regions under balancing selection

The four common heterozygous regions (Table 5) contained 29 genes (listed in Supplementary Information S16). A gene ontology (GO) terms study showed no significant over-representation of specific GO terms.

The degree of protein percent identity among 10 various vertebrate species for these 29 genes are presented in supplementary information S17.

Regions chr10_a, chr19_a, and chr19_b contained only a few genes and were then analyzed in further detail to accurately determine the role of underlying genes (Table 8). These genes play key roles in cellular and nuclear organisation and in embryonic development.

4| Discussion

The objective of our study was to detect signatures of selection into domestic rainbow trout. To reach that goal we studied four genetically distinct populations coming from different locations either in France or in the North-West of the USA. We used two different approaches, ROH and EHH, to detect the genomic regions shared by all populations using a HD SNP. We were able to detect 9 very conserved regions and 4 hotspots of polymorphism, corresponding to 253 and 29 annotated genes, respectively.

4.1 | Genetic structure

First, we described the genetic structure of the populations under scrutiny. The three French lines were moderately differentiated with Fst ranging from 0.10 to 0.12. These estimations were congruent with those computed by D'Ambrosio et al.'study (2019) with the same populations that ranged between 0.09 and 0.14, but were estimated using a 38K SNPs array. These moderate differences between the 3 French populations were consistent with the PCA we performed and the history of these populations with a partly common INRAE origin (D'Ambrosio et al., 2019). This trend is shared between European populations with for instance an average Fst of 0.13 between 12 European rainbow trout strains (Gross et al., 2007) or 0.12 among 9 Norwegian populations (Glover, 2009). Similarly, US farmed populations are also weakly to moderately differenciated with an average Fst of about 0.09 (Silverstein et al., 2004) or 0.13 (Liu et al., 2017b) and pairwise values ranging from 0.06 and 0.16. We observed a similar pattern in the present study with the HA population that consisted in samples from 5 locations, which all clustered together in the PCA. Reversely, we observed a large differentiation between our French and US populations revealed by large Fst values (0.27-0.29). This is likely the result of numerous factors, including selection, genetic drift and absence of gene flow between these very geographically distant populations. In addition, the European farmed populations originated from Californian domesticated strains, that have been shown to differ from strains of North-Western USA (Stanković et al., 2015). We found 34 haplotypes distributed over 21 chromosomes that differed between the American pooled population (HA) and all French populations (Supplementary information S1).

Due to the moderate to large differentiation between the 4 populations, the conserved regions across all populations are likely to be the result of ancient natural selection traces.

4.2 | Comparison of methods to detect common signatures of positive selection

We used a double check of positive selection traces in the genome by using both ROH and EHH approaches. However, for each population, only a few regions were identified by both methods. These regions detected by more than one method represent stronger evidence of selection signatures since outlier markers detected by various genome scan methods help to uncover true selection signatures by reducing the number of false positives.

Even if both methods evaluate the homozygous large stretches in the genome, iHS also considers information based on haplotypic version and linkage disequilibrium from a core SNP. ROH approach detects homozygous regions regardless of their haplotypic versions, contrary to iHS. Thus, it may detect a signature of positive selection even if various haplotypes were present at the homozygous state in the population. In addition, while the ROH approach only detects the homozygous large stretches (at least 500 kb in the present study), iHS can detect small regions under positive selection as the only limitation in EHH region size is based on a threshold value for a minimum LD (0.10). Consequently, the sizes of the detected homozygous region varied between 1,065 kb and 2,857 kb based on ROH metrics and between 1,000 kb and 1,600 kb with iHS statistics.

The high number of regions (55, 69, 73, and 362) detected by iHS in our study was consistent with numbers detected in either Atlantic salmon (López et al., 2019) or cattle (Saravanan et al., 2021). However, these two previous studies used a lower threshold than ours $(-\log(p-value)) =$ 3 and 2, respectively vs 4 in the present study). Lower numbers of regions were previously detected by iHS in rainbow trout by Cádiz et al. (2021) and in Coho salmon by López et al. (2021). We speculate that these differences in the numbers of detected signals may be linked to the lower density of SNPs they used in both studies (57K or 200K chip versus 665K chip for our study) and the subsequent lower ability to detect LD and haplotypes at fine scale. Indeed, in the Chilean rainbow trout study (Cádiz et al., 2021), only one signal of positive selection was detected by iHS located at 6.398-14.936 Mb on chromosome 20 of the Swanson reference genome, which corresponds to the region 7.488-16.111 Mb on chromosome 20 of the Arlee reference genome. Nevertheless, we also detected by iHS signals of selection in each of our four studied populations, located at 10.5-16.5 Mb for LB, 11.2 – 13.3 Mb for LC, 13.0 – 14.2 Mb for SY and 12.3-13.2 Mb for HA (Supplementary Informations S6 to S9 for LB, LC, SY, and HA, respectively). Thus, all these signals were consistent with the larger region identified by Cádiz et al. (2021).

A common putative selection signature located at 13.0-13.2Mb could also be shared by all studied populations. In this 200kb-region, we observed at least one iHS value over |2.5| for LB, LC and SY lines, but not for HA population. In this region of 200 kb on chromosome 20, six genes were identified (*lgi1, noc3l, plce1, slc35g1, fra10ac1, tbc1d12*). Among these genes, Cádiz et al. (2021) identified two candidates genes associated with domestication, *noc3l* (nucleolar complex protein 3 homolog) and *plce1* (1-phosphatidylinositol 4,5-bisphosphate phosphodiesterase epsilon-1). Both are related to early development traits in zebrafish (*noc3l*: Walter et al., 2009; *plce1*: Zhou et al., 2009).

4.3 | Biological functions of genes under positive or balancing selection

Among the 282 genes in the 13 regions detected under either positive or balancing selection, most genes seem to play essential roles in fitness as expected with such a dataset comprising both European and US populations. They are related to all main biological functions (genome stability, cell organization, neuronal and embryonic development, energy metabolism, growth, reproduction, and immunity). All identified biological functions were already described in other studies of signatures of selection in farmed rainbow trout (Cádiz et al., 2021) and other domesticated species (López et al., 2018, 2019, 2021; Naval-Sanchez et al., 2020; Baesjou & Wellenreuther, 2021; Signer-Hasler et al., 2022).

4.3.1 Hotspots of heterozygosity and balancing selection for fitness traits

In livestock species, many variants under balancing selection are known to improve performance in heterozygote state but cause defect in homozygous state (Hedrick, 2015; Georges et al., 2019). However, in such cases of balancing selection, there is generally only one homozygous state, which is deleterious at a locus level, while the alternative homozygous state is observed in the population. In our study, we highlight four regions potentially involved in balancing selection for which we observed a lack of any kind of long streches of homozygosity. Even if these regions are extremely heterozygous, the proteins associated with these genes are highly conserved among vertebrates (Supplementary information S17). Many processes may explain these surprising observations at first glance. First of all, these regions may concentrate polymorphism in non-coding parts of the genome. Polymorphism in intronic regions may promote various proteins by allowing alternative splicing. We may also observe an excess of synonymous polymorphism in exons without effects on proteins. Further analyses must be conducted to better understand the mechanisms underlying the maintenance of extreme

polymorphism, whether to validate the hypothesis of balancing selection or the existence of high mutation and recombination rates in these specific regions.

In the heterozygous region chr10_a, the gene *ctnna2* (Table 8) enables actin filament binding activity and is involved in the regulation of neuron migration and neuron projection development. Thus, *ctnna2* plays an essential role in brain development among vertebrates (Uvarov et al., 2014). In yonlong grouper, *ctnna2* seems implicated in vertebral development, because significantly differentially expressed between normal and fish with lordosis (Li et al., 2022). In mice, a homozygous for a mutation of *ctnna2* reduced body weight, male fertility, and induced brain abnormalities (hypoplastic cerebellum, abnormal foliation pattern, ectopic Purkinje cells, and abnormal pyramidal cells in the hippocampus). While the protein associated to this gene is highly conserved among vertebrates (Uvarov et al., 2014; Supplementary information S17), the gene exhibits a strong polymorphism in all the four studied rainbow trout populations. However, a large part of its polymorphism is located in one intronic region (intron 6-7) of *ctnna2*. In the zfin database, five transcripts of this gene were identified (three mRNA and two non-coding RNA). We hypothezise that the polymorphism in the intronic region of *ctnna2* is essential for alternative splicing.

In the heterozygous region chr13_a (Supplementary information S16), mmd and map2k4 are identified as highly conserved across vertebrates (Supplementary information S17). The gene *mmd* plays an important role in maturing macrophages, which is essential for immune response as observed in mice (Lin et al., 2021). The gene map2k4 is implicated in a variety of cellular processes (proliferation, differentiation, transcription regulation, development), seems to play a role in liver organogenesis and embryonic development during gastrulation, as demonstrated by morpholino-mediated knockdown in zebrafish (Seo et al., 2010), and implicated in immune response in yellow catfish (Zheng et al., 2022). The inflammatory process in immune response seems linked to the polymorphism of the *map2k4* gene, which is consistent with our hypothesis of balancing selection, and more precisely potential ancestral trans-species polymorphism in this genomic region (Gu et al., 2016; Fijarczyk & Babik, 2015). Trans-species polymorphism is a crucial evolutionary mechanism for sharing adaptative genetic variation across taxa (Klein et al., 1998). The study of this mechanism has primarly concentrated on major histocompatibility complex genes, but a few studies described this process for other immune genes (Ferrer-Admetlla., et al., 2008; Leffler et al., 2013; Těšický & Vinkler, 2015). Maintaining genetic diversity in regions related to the immune system may be

essential to resilience against various pathogens. In addition, this region of chromosome 13 has been recently detected as a significant QTL playing a role on resistance to temperature (Lagarde et al., 2022).

In the heterozygous region chr19_a (Table 8), the protein encoded by *smarca5* is a component of chromatin remodeling and spacing factor RSF, a facilitator of the transcription of class II genes by RNA polymerase II (zebrafish: Armas et al., 2013; Ding et al., 2021; mice: Limi et al., 2018). The protein is highly conserved among vertebrates (Supplementary information S17), which is consistent with its essential role thought to regulate the transcription of many genes by altering the chromatin structure around those genes. In the same region chr19_a, *frem2* codes for an extracellular matrix protein required for maintenance of the integrity of skin and renal epithelia in zebrafish (Gautier et al., 2008). This protein is moderately conserved across vertebrates (Supplementary information S17). In a study searching for genomic regions with ancestral trans-species polymorphism shared between humans and chimpanzees (Leffler et al., 2013), *frem3*, an important paralog of *frem2*, was identified under balancing selection. However, further studies should test the hypothesis of trans-species conservation of *map2k4* and *frem2* genes that may help to understand the various cellular processes in which the gene is implicated.

In the heterozygous region chr19_b (Table 8), *pou4f2* protein is highly conserved among vertebrates (Supplementary information S17) and is a tissue-specific DNA-binding transcription factor involved in the development and differentiation of specific cells. It maintains the visual system neurons in the retina and the lateral line (DeCarvalho et al., 2004) and seems also related to cardiac development in zebrafish (Maskell et al., 2017).

4.3.2 Hotspots of homozygosity and positive selection for essential biological functions

4.3.2.1 | Regions and genes involved in cellular and nuclear organization, and embryonic development

In homozygous region chr2_a, three genes plays important roles in embryonic development and then fitness (*cep162*, *tsnare1*, *mrap2*, Table 6). In the homozygous region chr2_b (Table 6), the gene *pbx1* (pre-B-cell leukemia transcription factor 1) is related to early development in zebrafish (Teoh et al., 2010). Mutations in this gene generally cause major malformations, which seem to play an essential role in survival in various species (zebrafish: Teoh et al., 2010; mouse: Selleri et al., 2001; human: Le Tanno et al., 2017). It was detected under positive selection in a Chilean farmed rainbow trout population (Cádiz et al., 2021). However only

moderate percent identity (> 65%) is observed between pbx1 proteins across vertebrates.

In the homozygous region chr15_a, many genes (*chn1, atp5mc1, zc3h15, nid2 and brca2*) were playing essential roles in cell functioning and early development (Table 6). However only two of them were highly conserved among vertebrates (> 85%; *chn1* and *atp5mc1*). The gene *atp5mc1* is a crucial gene for mitochondrial cristae morphology, and plays important roles in metabolic processes associated to growth (Table 6; Palmer et al., 2011; Miller et al., 2019; Wang et al., 2020). In zebrafish, a morpholino knockdown of *chn1* reveals its crucial role in early development, revealing severe abnormalities (development of round somites, lack of yolf extension, and kinkled posterior notochord) (Leskow et al., 2006).

Three genes located in close vicinity in region chr16_a (between 46.42 and 46.53 Mb; Supplementary information S11), *samd10* (sterile alpha motif domain-containing protein 10-like), *dnajc5* (dnaJ homolog subfamily C member 5-like), and *tpd54* (tumor protein D54) were also detected in close chromosomal vicinity and under positive selection in ten modern goat breeds and one wild Bezoar goat (Signer-Hasler et al., 2022). This cluster of genes has a significant role in survival and cellular processes (Table 6). In addition, in this region chr16_a, the protein of the gene *magi2* (membrane-associated guanylate kinase, WW and PDZ domain-containing protein 2, Table 6) plays a vital role in embryogenesis in zebrafish (Borah et al., 2016). The gene *magi2* was also identified under positive selection in a domesticated sheep breed compared to the wild Asiatic mouflon (Cumer et al., 2021).

4.3.2.2 / Regions and genes involved in neural and brain development, and behaviour

In total, we identified 7 genes as primarly associated to neural and brain development in both regions detected under positive selection (*tsnare1, cdk14, brsk2a, auts2, brd2, znf135,* and *grxcr1*). Some genes (*brsk2a, znf135, grxcr1, auts2; Table 6*), related to brain development may induce behavior modifications in farmed animals, that may be related to domestication processes (Pasquet, 2018; Milla et al., 2021; Deng et al., 2022; Liu et al., 2022). This is in line with Żarski et al. (2020) study showing that domestication modulates gene expression involved in neurogenesis.

In particular, the gene *auts2* gene was previously identified under positive selection both in cattle (Consortium, bovine Hapmap, 2009) and in domesticated Atlantic salmon populations from Canada and Scotland compared to their wild Atlantic salmon counterpart (López et al., 2018). The gene *znf135* was also detected under positive selection in a farmed population of Atlantic salmon compared to a wild-type population (Gutierrez et al., 2016). The gene *grxcr1*

was detected under positive selection in the Tharparkar cattle (Saravanan et al., 2021). It strongly suggests that all these genes play a key role in domestication processes and may act on essential behaviours in both terrestrial and aquatic farmed animals.

4.3.2.3 | Regions and genes involved in growth metabolism

Genes related to growth metabolism were only identified in four regions under positive selection, none of them were detected in high heterozygosity regions.

In the homozygous region chr2_a (*Table 6*), the protein *mrap2* (*melanocortin-2 receptor accessory protein 2A*) is associated to growth. A lack of this gene exhibit severe obesity in many species (human, zebrafish, rodent: Liu et al., 2013; sea lamprey: Zhu et al., 2019; snakehead: Wen et al., 2021). *Yoshida et al.* (2017) detected a growth-QTL in Atlantic salmon and considered mrap2 as a candidate gene for growth up to 25 months. In addition, mrap2 was identified in the Chilean farmed rainbow trout population as under positive selection (Cádiz et al., 2021). A QTL related to sea lice resistance in rainbow trout (Cáceres et al., 2021) was also detected in the region chr2_a (located from 10.43 Mb to 11.81 Mb of the Swanson reference genome, which corresponds to 26.69 Mb – 28.07 Mb of the Arlee reference genome). Cáceres et al. (2021) explained that having a high potential for growth seem essential for sea lice resistance. Indeed, proteomic investigations allow to establish a link between growth and immune function in salmonids (Causey, 2018).

In homozygous region chr2_b (Table 6), the *col9a2* (collagen alpha-2(IX) chain) gene is a component of cartilage and seems also related to growth (Xu et al., 2022).-This gene is detected under positive selection in a Scottish farmed population of Atlantic salmon (López et al., 2018). In addition, the gene *scap* (sterol regulatory element-binding protein cleavage-activating protein) was already identified under positive selection in six farmed Pacific white Shrimp populations (Wang et al., 2022).

In the homozygous region chr2_d (Table 6), the gene igf- 1α (insuline like growth factor receptor 1a) plays an important role in growth and transformation events. In salmonids, expressions of igf- 1α and growth hormone were demonstrated to be modified between domesticated and wild populations of rainbow trout and coho salmon (Tymchuk et al., 2009). The same observation was made with a higher expression of igf- 1α between larvae from domesticated spawners than larvae from wild spawners of the Eurasian perch (Palińska-Żarska et al., 2021). In addition, igf-1 was also observed as a marker of domestication in dogs (Wayne & vonHoldt, 2012).

In the homozygous region chr16_a, the *emilin-3a* gene (elastin microfibril interfacer 3a, Table 6) plays a role in extracellular matrix organization and elastic fiber formation. Its gene expression is related to embryonic development and involved in muscle fiber development in zebrafish (Milanetto et al., 2008). *Emilin-3a* had already been identified as under positive selection in one population of F2 Australian snapper farmed population compared to the first generation (F1) of domestication of a wild population (Baesjou & Wellenreuther, 2021). Thus, this signature of selection can be considered as a result of the domestication process.

All identified growth-related genes seem associated with domestication. This assertion is confirmed for five genes (*mrap2*, *col9a2*, *scap*, *igf-1a*, *emilin-3*) that were also identified under positive selection in various farmed populations with favorable alleles linked to better growth phenotypes (Table 6).

4.3.2.4 | Regions and genes involved in reproduction

Very few genes directly related to reproduction traits were only identified in highly homozygous regions.

In the homozygous region chr2_b, the *brd2* (bromodomain-containing protein 2, Table 6) gene is implicated in several biological process (see section 4.4.1.). It seems related to oogenesis and egg-to-embryo transition in zebrafish (DiBenedetto et al., 2008), which is consistent with a QTL detected for egg size in this region in rainbow trout (D'Ambrosio et al., 2020). Moreover, it seems that *brd2* is involved in spermatogenesis or folliculogenesis, as demonstrated in situ on mice cells (Rhee et al., 1998). Khendek et al. (2017) compared the reproductive performances (egg size, gonadal histology, hormonal levels) between domesticated and F1 with wild broodstock of Eurasian perch populations. They showed that domestication may have increased the oocyte diameter and the level of 17β -Estradiol, but decreased the embryo survival of domesticated fish. This gene was also identified under positive selection in a selected Canadian population of Atlantic salmon (López et al., 2018).

In the homozygous region chr15_a (Table 6), the gene zp4 has already been identified under positive selection in a farmed Scottish population of Atlantic salmon compared to a wild population (López et al., 2018), and may be related to domestication process.

4.3.2.5 / Regions and genes involved in immunity

Magris et al. (2022) observed that regions under positive selection revealed an enrichment of KEGG terms related to viral infection in farmed brown trout. However, it should be noticed that in our study, few genes related to immune function were identified and no enrichment in immune terms was observed in GO analysis.

Genes related to immune function were mainly identified in three different regions detected as putatively under positive selection for two of them and under balancing selection for the last one.

In the homozygous region chr2_b (Table 6), genes *tnfaip8l2b* (tumor necrosis factor, alphainduced protein 8-like protein 2 B) and *atg5* (autophagy protein 5) are related to immune functions. Note that atg5 is well conserved across vertebrates (> 80%).

In the region chr15_a, the gene zc3h15 (Table 6) seems to have an inhibitory effect on HIV-1 replication and then on HIV infection in vitro (mice cells) (Capalbo et al., 2010).

A last gene in the region chr16_a, the gene *atp1b3* (sodium/potassium-transporting ATPase subunit beta-1-interacting protein 3) was also identified under positive selection in farmed Atlantic Salmon (Naval-Sanchez et al., 2020). In the Senegalese sole, atp1b3a and atp1b3b paralogs have been hypothesized to be involved in response to low salinity (Armesto et al., 2015). In addition, this gene is involved in some immune responses. It was shown in cell culture study, that *atp1b3* inhibits hepatitis B virus replication via inducing NF-kappa B activation (human: Zhang et al., 2021) and is involved in numerous viral propagation such as HIV and EV71 (Zheng et al., 2020) in cell culture experiments.

4.4. Conclusion

To sum up, we identified 13 regions under selection with numerous genes strongly involved in essential biological functions. By identifying signatures of selection shared by our four studied populations, we have focused our detection on regions related to ancient evolutionary processes that are essentially important for species survival. We only identified nine homozygous regions presumably under positive selection and four heterozygous regions putatively under balancing selection in four different rainbow populations. While common homozygous regions may be associated with important biological functions underlying both fish fitness and domestication, the heterozygous regions seem mainly linked to fitness functions (cell organization, embryonic

development, and immunity) which are involved at different developmental stages or to cope with various pathogens or abiotic stressors. Maintaining genetic diversity in these regions could be essential for the species survival.

This study allows us to confirm the importance of a large set of 17 genes already detected as under positive selection in previous studies, among which 10 genes were identified in fishes (*auts2, atp1b3, zp4, znf135, igf-1a brd2, col9a2, mrap2, pbx1* and *emilin-3*). We also identify new promising candidate genes as important for rainbow trout fitness. In our opinion, this study substantially increases knowledge of evolutionary processes and helps to determine the genomic location and the nature of the genetic variation that must be maintained in rainbow trout populations for domestication and selection purposes.

Chapitre 5

Discussion Générale

Dans un contexte de changement climatique et de diversification des objectifs de sélection, il est essentiel de gérer et de préserver la diversité génétique des lignées sélectionnées de truites arc-en-ciel, dont la baisse observée ces dernières décennies devient inquiétante (D'Ambrosio et al., 2019). Dans ce chapitre, à la lumière des connaissances sur la diversité génétique acquises au cours de cette thèse, nous proposerons des pistes d'amélioration de sa gestion dans les programmes de sélection truiticole. La discussion s'organisera donc selon les étapes d'un programme d'amélioration génétique, en abordant les enjeux de sa gestion, ainsi que les méthodes et les outils disponibles pour gérer ces ressources au sein des populations sélectionnées de truite arc-en-ciel.

Tout programme de sélection se construit en quatre étapes clefs (Phocas, 2011). Premièrement, il faut déterminer des objectifs et des critères de sélection, puis réaliser l'évaluation génétique des individus, permettant un choix objectivé des reproducteurs. Ensuite, il est nécessaire d'organiser et d'optimiser les différentes actions de création du progrès génétique, c'est-à-dire sélectionner les reproducteurs et réaliser les plans d'accouplement. Pour finir, la dernière étape d'un programme de sélection est la diffusion du progrès génétique acquis dans les élevages de production.

Les schémas de sélection aquacole actuels sont divisés en deux catégories : des schémas de sélection massale basés sur les seuls phénotypes des candidats à la sélection, et des schémas de sélection généalogique. La sélection généalogique en aquaculture a été initiée dans les

années 70 en Norvège chez le saumon (Gjedrem, 2010), où l'élevage est fait en familles séparées. Avant l'essor de la génomique, cette stratégie avait de nombreux avantages : améliorer la précision de l'évaluation des caractères grâce à la possibilité d'utiliser l'information familiale ; sélectionner sur des caractères létaux mesurés sur des collatéraux apparentés ; et gérer la diversité génétique (Gjedrem, 2010). Cependant, cette stratégie présente deux inconvénients majeurs. D'une part, elle nécessite d'investir dans des structures d'élevage induisant un surcoût important, limitant le nombre de familles produites (Vandeputte & Haffray, 2014). D'autre part, dans ce système, il n'est pas possible de dissocier les effets génétiques additifs des effets environnementaux et maternels, ce qui induit des pertes de précisions et une surestimation de la composante génétique dans l'évaluation des reproducteurs.

Aujourd'hui, la sélection dans les élevages truiticoles français se fait à l'aide d'une combinaison de sélection massale sur la croissance et la morphologie selon la méthode PROSPER (Chevassus et al., 2004), et d'une sélection sur une indexation généalogique BLUP. Depuis 2004, l'assignation de parenté assistée par marqueurs génétiques est utilisée en routine pour permettre l'indexation BLUP – modèle Animal (Vandeputte et Haffray 2014). Depuis 2018, l'essor et la baisse des coûts du génotypage ont également permis aux sélectionneurs de commencer la mise en place de la sélection génomique GBLUP (D'Ambrosio, 2020). En outre, une gestion des accouplements est réalisée pour éviter de croiser des reproducteurs trop apparentés grâce à un algorithme d'optimisation de leurs contributions afin de minimiser l'augmentation de consanguinité sous contrainte d'un progrès génétique fixé (Colleau et al., 2009; Chapuis et al., 2016).

Au sein de chaque entreprise de sélection truiticole, il existe au moins deux populations de truites répondant à des finalités différentes : la population de sélection et la population de multiplication. La population (ou noyau) de sélection est conservée au sein de chaque entreprise, et permet d'alimenter la population de multiplication pour fournir suffisamment d'œufs embryonnés améliorés à destination des grossisseurs (Chavanne et al., 2016). Les stratégies à mettre en place au sein des programmes de sélection, pour gérer la diversité génétique et ses effets, pourront donc être variables entre le noyau de sélection et la population multiplicatrice.

5.1. Les objectifs des programmes d'amélioration génétique

5.1.1. Choix de la stratégie d'amélioration génétique

La diversité des programmes d'amélioration génétique des animaux d'élevage dépend non seulement des contraintes biologiques des espèces considérées (en particulier leur niveau de fécondité), mais aussi des types de production (importance des effets d'hétérosis sur les caractères avant le plus d'importance économique) et des objectifs de sélection (compromis entre caractères de production, de reproduction et santé des animaux). Deux stratégies différentes sont distinguées : le croisement et la sélection. Il y a sur certains points un recouvrement, comme, par exemple, le croisement d'absorption qui s'apparente à un processus de sélection pour introduire de nouvelles aptitudes ou de la variabilité dans une population. L'élevage en race/lignée pure consiste à accoupler des reproducteurs issus de la même population. Tandis que le croisement consiste à accoupler des reproducteurs issus de races/lignées différentes. L'objectif du croisement est de tirer parti de la variabilité génétique entre populations (races ou lignées) disponibles à un moment donné. Dans cette discussion, le croisement est considéré comme une stratégie d'utilisation des reproducteurs (cf 5.4.3. Valorisation de l'hétérosis). Un programme d'amélioration génétique en croisement implique des coûts supplémentaires conséquents, car il nécessite de conduire au moins deux programmes de sélection en race pure sur de races/lignées distinctes. Mais les avantages principaux du croisement sont : 1) de bénéficier de l'effet de complémentarité entre des types génétiques spécialisés pour des fonctions pouvant être antagonistes, comme une meilleure aptitude de reproduction sur la voie maternelle couplée à une meilleure production sélectionnée sur la voie paternelle (Sellier, 1976; Roehe et al., 2010); 2) d'exploiter le phénomène d'hétérosis (ou de vigueur de l'hybride) chez les individus hybrides, se traduisant par des performances moyennes de ces animaux supérieures à la moyenne des performances de leurs parents.

Le croisement constitue également une potentielle protection des améliorations génétiques réalisées par les sélectionneurs, et leur confère donc un avantage compétitif.

5.1.2. La définition de l'objectif de sélection

La définition des objectifs de sélection est l'étape préalable et indispensable à la mise en place de tout programme d'amélioration génétique. Cela permet de connaître et de mettre en relation l'ensemble des aptitudes biologiques héritables que l'on souhaite améliorer (Nielsen et al., 2014). Cette fonction permet ensuite d'évaluer et donc de classer objectivement les individus pour y choisir les reproducteurs répondant au mieux à l'objectif de sélection décidé en amont (Phocas et al., 2020). Les objectifs de sélection dans les programmes truiticoles sont majoritairement liés aux caractères de croissance et de production (rendement de découpe et qualité de chair). Cependant, aujourd'hui chez la TAC, de nouveaux caractères, comme des caractères de résistance à des maladies ou de reproduction des femelles, sont intégrés dans les objectifs de sélection (Fraslin, 2018 ; D'Ambrosio, 2020).

5.1.3. Limiter la dépression de consanguinité et l'érosion de la diversité génétique

Au-delà du choix des caractères à inclure dans l'objectif de sélection, la finalité du programme doit être précisée (maximisation de la réponse à la sélection à court versus long terme) car l'importance à accorder au maintien de la variabilité génétique dans l'optimisation du programme de sélection en dépend. Le maintien de la variabilité génétique au-delà des 4-5 premières générations de sélection devient un problème majeur dès lors que l'on s'intéresse à des populations d'effectifs génétiques limités (Ne < 100), en raison des problèmes de dérive génétique et de consanguinité. Etant donné les faibles effectifs efficaces calculés dans les populations de truites arc-en-ciel (D'Ambrosio et al., 2019), l'intégration du maintien de la diversité génétique est un enjeu majeur pour les sélectionneurs souhaitant poursuivre leurs programmes d'amélioration génétique en lignées fermées au-delà d'une dizaine d'années.

Deux méthodes alternatives basées sur l'optimisation des contributions des reproducteurs aux générations suivantes ont été proposées pour répondre à cet enjeu. La première développée par Meuwissen (1997) consiste à maximiser le progrès génétique à contrainte fixée pour limiter l'accroissement de la consanguinité à un niveau prédéfini (méthode des contributions optimales (OC)). La seconde méthode mise en place par le SYSAAF chez certains sélectionneurs, vise à minimiser l'accroissement de consanguinité à contrainte fixée sur le progrès génétique souhaité (Colleau et al., 2006). Ces deux méthodes diffèrent dans l'enjeu prioritaire défini pour le programme de sélection. Meuwissen (1997) propose avant tout de limiter l'augmentation de la consanguinité alors que Colleau et al (2006) mettent en priorité l'atteinte d'un gain génétique suffisant. La recommandation faite par la FAO est de limiter l'accroissement de la consanguinité de 0,5 à 1% d'une génération à l'autre (FAO, 2009; Rischkowsky & Pilling, 2007). Cette recommandation est respectée dans les programmes de sélection truiticole du SYSAAF ayant incluent une gestion de la consanguinité (D'Ambrosio, 2020).

D'autres approches sont également proposées pour gérer le choix des reproducteurs et leurs accouplements, telles que l'utilisation d'index d'originalité chez les bovins (Hoze et al., 2018) ou la gestion des anomalies génétiques (Danchin-Burge et al., 2016) pour limiter les effets délétères de la consanguinité dans les populations sous sélection intensive.

Dans mes travaux de thèse, d'importants effets de dépression de consanguinité ont été estimés sur les caractères de reproduction de la truite arc-en-ciel (cf Chapitre 3), ainsi que sur des caractères de production (cf Résultats annexe 3) et de survie (cf Chapitre 2 et Résultats annexe 4). Ces résultats sont cohérents avec ceux de deux méta-analyses répertoriant les différentes estimations de dépression de consanguinité dans plusieurs espèces et sur différents types de caractères (Leroy, 2014 ; Doekes et al., 2021). Ces deux méta-analyses montrent que les effets de dépression de consanguinité peuvent être conséquents pour des caractères de production, et ne sont donc pas uniquement importants à considérer pour les caractères liés à la *fitness* (survie, reproduction), malgré le consensus largement admis dans la littérature, mais vraisemblablement fortement issu des observations en populations sauvages (Lynch & Walsh, 1998 ; DeRose & Roff, 1999). Il est donc essentiel de maintenir une diversité génétique suffisante au sein des populations de truites, pour limiter les phénomènes de dépression de consanguinité sur l'ensemble des caractères d'intérêt en aquaculture.

Au-delà des effets de la dépression de consanguinité, la perte de diversité génétique engendre des risques pour l'adaptation des animaux à des milieux hétérogènes et changeants. Dans le contexte actuel de changement climatique, il est essentiel pour les populations sélectionnées d'avoir de bonnes performances, pas seulement dans un milieu optimal, mais dans différents environnements (Pilling & Hoffmann, 2011). De plus, les entreprises de sélection truiticole françaises exportent une bonne partie de leur production d'œufs à l'international (dans plus de 20 pays d'Europe et du Moyen-Orient) (D'Ambrosio, 2020), où les conditions d'élevage peuvent différer fortement des conditions françaises. Avoir des animaux aux performances constantes dans divers milieux est donc également un enjeu majeur pour l'économie des entreprises de sélection. La résilience des animaux et de leurs performances à des variations environnementales est donc un objectif poursuivi.

Aujourd'hui, il est nécessaire d'avoir une approche plus raisonnée pour poursuivre l'amélioration génétique des lignées commerciales de truites arc-en-ciel, tout en maintenant un réservoir suffisant d'allèles dans ces lignées sélectionnées en populations fermées. A la lumière des travaux de thèse décrits dans le Chapitre 3, la gestion fine de la consanguinité, au niveau des fragments chromosomiques, nous apparaît comme un enjeu majeur pour ces programmes de sélection, non seulement pour limiter les effets de dépression de consanguinité et donc améliorer les performances des cheptels, mais aussi pour garantir la possibilité pour les lignées de s'adapter aux changements environnementaux, à divers stress abiotiques ou biotiques, ainsi qu'à des objectifs de sélection futurs.

5.2. L'évaluation génétique des reproducteurs

L'évaluation génétique des candidats à la sélection est une étape nécessaire au choix objectivé des reproducteurs. Plus l'évaluation des candidats sera précise, plus la sélection sera efficace. Cette évaluation se fait sur la base d'un index synthétique constitué d'une combinaison linéaire de plusieurs index élémentaires établie pour maximiser la réponse sur l'objectif de sélection pré-déterminée (Hazel, 1943).

La méthode et le modèle d'évaluation génétique de référence est depuis trente ans le BLUPmodèle animal (Henderson, 1975) basé sur la prise en compte des relations génétiques entre animaux via une matrice de parenté établie sur pedigree. Classiquement, seuls les effets génétiques additifs sont pris en compte dans le modèle, car les effets non-additifs (dominance, épistasie, interactions génotypes/environnement) sont plus difficiles à estimer précisément sur la base de données pedigree.

L'utilisation de l'information génomique pour construire la matrice de parenté (GBLUP, Habier et al., 2007) permet à présent de considérer efficacement les effets non-additifs dans les modèles d'évaluation génétique. Au sein de ces modèles génomiques, différentes valeurs génotypiques (GV) et génétiques (BV) peuvent être prédites. La valeur BV correspond à l'estimation des effets génétiques additifs, classiquement utilisée en sélection. La valeur GV peut se décomposer en trois composantes : additive, dominance et épistasie (Minvielle, 1992).

5.2.1. Prise en compte des effets de dominance

Jusqu'à maintenant les effets de dominance sont très peu pris en compte dans les évaluations génétiques pour diverses raisons. On s'intéresse en priorité aux effets additifs car ce sont eux qui sont directement héritables et transmissibles aux générations futures. De plus, l'estimation des effets de dominance est difficile (manque d'informations sur le pedigree ; peu de grandes familles ; calculs plus complexes, etc.) et n'est pas utile dans tous les programmes d'amélioration génétique. Toutefois, inclure les effets de dominance dans les modèles d'évaluation est conseillé, surtout avec l'utilisation des données génomiques qui facilite leur estimation. Dans tous les cas, ajouter l'effet de la dominance dans le modèle génétique ne détériore pas l'évaluation des reproducteurs, et cela même si le caractère étudié est purement additif (Zeng et al., 2013; Duenk et al., 2017). L'évaluation des candidats en considérant les effets de dominance semble indispensable dans les programmes d'amélioration génétique en croisement, notamment pour identifier les meilleurs accouplements à réaliser pour valoriser l'hétérosis (Toro & Varona, 2010; Su et al., 2012; Sun et al., 2013; Vitezica et al., 2013, 2016; Xiang et al., 2016; Varona et al., 2018a, 2018b; Fernández et al., 2021). Dans les programmes de sélection en lignée pure, l'intérêt de la prise en compte des effets de dominance est moins évident.

Dans l'étude présentée au Chapitre 3, les valeurs génétiques des individus estimées dans les modèles GBLUP avec ou sans effets de dominance sont corrélées à plus de 99% (Tableau 5.1). Donc, inclure des effets de dominance ne semble pas améliorer la précision de l'estimation des valeurs génétiques additives des reproducteurs. Nos résultats concordent avec ceux obtenus dans plusieurs espèces terrestres, où aucune amélioration des prédictions des valeurs génétiques n'a été observée en considérant les effets de dominance dans les évaluations (poules pondeuses : Heidaritabar et al., 2016 ; mouton : Moghaddar & Van der Werf, 2017 ; bovin : Garcia-Baccino et al., 2020).

Quelques études basées sur des données de simulation ont montré que l'ajout des effets de dominance dans les modèles permet d'augmenter un peu la précision de l'estimation des valeurs génétiques additives (BV) (Toro & Varona, 2010 ; Varona et al., 2018a), mais augmentait surtout la précision de l'estimation des valeurs génotypiques (GV) des individus (Wellmann & Benewitz, 2012). Une étude sur données réelles chez le porc, considérant deux lignées pures (Yorkshire et Landrace) et leur croisement, montre une amélioration de la précision des valeurs génomiques prédites (GEBV) entre 5 et 18% sur la taille de portée en considérant les effets de dominance dans chacune des deux races (Esfandyari et al., 2016).

Par ailleurs, Xiang et al. (2018) ont montré qu'il existait une corrélation entre les effets additifs et les effets de dominance. Cependant la prise en compte de la corrélation entre les effets additifs et de dominance, n'améliore que très peu la précision valeurs génotypiques (GV) qui sont finalement proches de celles estimées par l'approche orthogonale ne prenant pas en compte la corrélation entre les deux effets génétiques (Vitezica et al., 2016). Cette approche orthogonale développée par Vitezica et al. (2016) nous a servi à réaliser les études décrites dans le Chapitres 2 et 3. Elle semble être la méthode la plus fiable et simple à mettre en œuvre.

L'hypothèse de dominance partielle est largement acceptée comme le mécanisme le plus fréquent causant la dépression de consanguinité (Fu & Ritland, 1994 ; Charlesworth & Willis, 2009). Cette hypothèse implique l'existence d'effets génétiques non-additifs (dominance et épistasie). Sur la base de ces éléments, il nous semble important de considérer, lorsque la structure des données le permet, les effets de dominance dans les modèles génétiques afin d'évaluer correctement les effets de dépression de consanguinité, et ainsi mieux gérer le choix des reproducteurs.

5.2.2. Evaluation des effets de dépression de consanguinité et des anomalies génétiques

Dans le Chapitre 3 de cette thèse, ainsi que dans les résultats annexe 3 et 4, nous avons pu voir que la consanguinité pouvait avoir des effets variables, positifs comme négatifs, sur les performances (taille, production, reproduction femelle et survie) en fonction de sa localisation le long du génome. Il est donc essentiel dans l'évaluation des reproducteurs d'estimer les effets de la consanguinité localement le long du génome pour définir les accouplements à éviter (cf partie 5.4. Les plans d'accouplements), lorsque ces effets sont défavorables.

La dépression de consanguinité résulte le plus souvent de l'expression d'allèles récessifs délétères chez les individus homozygotes (cf Chapitre 1). La prise en compte des anomalies génétiques dans l'évaluation des candidats à la sélection est important afin d'éviter la propagation d'une mutation très délétère dans la population. Dans les programmes de sélection bovine, après avoir identifié les anomalies génétiques en se basant sur les déficits d'haplotypes homozygotes grâce aux données de génotypage et de séquençage (Fritz et al., 2013), les marqueurs associés sont utilisés pour pénaliser les candidats à la sélection plus ou moins fortement dans leur évaluation. Pour cela, les anomalies génétiques sont intégrées avec un poids variable dans l'index de sélection ISU (= Index Synthèse Unique) en fonction de l'importance de l'effet de la mutation d'un point de vue économique (coût souvent lié à la performance et à la survie des descendants), la fréquence de l'allèle délétère dans la population et le génotype des individus (Boichard et al., 2016 ; Michot, 2017).

Varona et al. (2019) proposent de gérer la consanguinité efficacement, en estimant une valeur globale de 'charge de dépression de consanguinité' ou de 'fardeau génétique' pour chaque reproducteur. Chaque individu sera évalué, via une analyse multivariée, sur la base de deux effets génétiques : *a* (exprimant directement le phénotype individuel) et *i* (exprimant le phénotype des descendants et correspondant au fardeau génétique, d'après Casellas (2018) qui considère que le fardeau génétique est un trait héritable).

5.2.3. Prise en compte de l'originalité génétique des individus

Une note d'originalité peut être estimée pour chaque candidat à la sélection afin d'avantager les individus génétiquement les plus distants de la population de reproducteurs, permettant ainsi de préserver la diversité génétique de la population (Bordonaro et al., 2012). Pour estimer l'originalité de chaque animal, on peut se baser sur l'apparentement d'un individu *i* par rapport à la population globale, ou bien sur les fréquences alléliques. Ainsi, dans certaines populations bovines, un indice d'originalité (ORI) est estimé à partir des fréquences alléliques (Danchin-Burge et al., 2016 ; Ganteil et al., 2021) :

 f_i : Fréquence moyenne des marqueurs portés par l'individu *i* (exemple : pour un seul locus homozygote *AA*, $f_i = (f_A + f_A)/2$).

 f_{pop} : Moyenne des fréquences alléliques pour l'ensemble des marqueurs de la population, pour <u>n</u> individus, $f_{POP} = \sum_{i=1}^{n} \frac{f_i}{n}$

 $\sigma_{f_{pop}}$: Ecart-type des moyennes des fréquences alléliques des marqueurs la population

Cet indice d'originalité permet de mettre en évidence des animaux porteurs d'allèles peu fréquents. Un animal original aura un ORI positif alors qu'un animal avec des allèles communs dans la population aura un ORI négatif. La simplicité des index ORI les rend facile à mettre en place. Danchin-Burge et al. (2016) ont proposé de calculer plusieurs ORI par candidat à la sélection, dans le but de les comparer à la population des animaux contemporains (jeunes), à tous les reproducteurs mâles ou à toutes les femelles en reproduction. Ces différents ORI permettent ensuite de pondérer l'ISU de chaque candidat afin d'avantager les individus originaux, par rapport à la population globale, mais également par rapport aux futurs reproducteurs (contemporains).

Une récente étude chez le porc a mis en évidence l'efficacité des indices d'originalité pour conserver de la diversité génétique dans les programmes de sélection (Ganteil et al., 2021). Cet indicateur pourrait être utilisé dans les programmes de sélection aquacole actuels afin de sélectionner un stock de géniteurs relativement divers. Dans le cas de la truite arc-en-ciel, seul l'index estimé sur la base de la population de candidats à la reproduction nous apparait intéressant et pertinent. En effet, dans les programmes de sélection truiticole, les reproducteurs ne sont utilisés qu'une seule fois, pour générer la génération suivante, donc un ORI basé sur les anciens/nouveaux géniteurs n'a pas d'intérêt. Le calcul des ORI des candidats à la sélection par rapport à la population globale (50 000 individus avant la sélection massale) nécessiterait bien trop de génotypage à chacune des générations pour les comparer aux 2000 candidats à la sélection.

5.3. Le choix des reproducteurs

Le choix des reproducteurs est décisif car il permet le renouvellement de la population en lui assurant un progrès génétique, en lien avec les objectifs de sélection. On sélectionne donc les animaux ayant les meilleures valeurs génétiques, c'est-à-dire les meilleurs effets additifs des gènes, qui sont transmissibles à la descendance et permettent d'améliorer les performances des générations futures.

5.3.1. Interactions Génotype x Environnement et conservation de la diversité génétique dans le pool de reproducteurs

Dans le contexte actuel de forts changements climatiques et environnementaux, il nous semble essentiel de prendre en compte les effets d'interaction pour choisir les reproducteurs, dans le cas de caractères où des interactions Génotype x Environnement (GxE) sont parfois observées entre milieux contrastés (Phocas et al., 2017). De plus, dans plusieurs espèces de poissons dont la TAC, des niveaux d'interactions GxE modérés à forts ont été observés, en particulier sur des caractères de croissance (Ayles, 1975 ; Fishback et al., 2002 ; Dupont-Nivet et al., 2010 ; Sae-Lim et al., 2013, 2016 ; Li et al., 2019). Pour prendre en compte les interactions GxE, deux options s'offrent à nous : i) sélectionner les individus les plus résilients, c'est-à-dire ayant une valeur génétique stable entre différents environnements, indicateur de la capacité d'adaptation des animaux à différents milieux (Dumont et al., 2014) ; ou ii) choisir les meilleurs candidats pour l'environnement de production ciblé. Dans le contexte d'exportation d'œufs et d'alevins améliorés par les sélectionneurs truiticoles français dans de nombreux pays aux conditions de milieu contrastées, il nous semble important de favoriser la première option,

qui permet également de préserver plus de diversité génétique. En effet, les populations les plus diverses génétiquement et les individus les moins consanguins sont généralement jugés plus résilients face à des modifications de leur environnement (Kristensen et al., 2010). Cette importance de la diversité génétique est à mettre en perspective avec les résultats décrits au Chapitre 4, où quatre régions hétérozygotes (non consanguines) ont été identifiées communes à plusieurs populations de truites arc-en-ciel. Dans ces régions, des gènes ont été identifiés comme ayant un effet essentiel pour l'organisation cellulaire, le développement embryonnaire et les fonctions immunitaires. Nous supposons que cela est lié à la nécessité d'avoir un fort polymorphisme génétique afin de remplir les fonctions nécessaires aux diverses étapes de développement embryonnaire en toutes circonstances, ou encore pour faire face à une variété de pathogènes, virus et bactéries (Gu et al., 2016 ; Durland et al., 2021).

5.3.2. Elimination des candidats à la reproduction porteurs d'allèles délétères

Dans les populations où la gestion des anomalies génétiques est rendue nécessaire, cette dernière doit se faire différemment selon que l'anomalie est létale ou non, dominante ou récessive (Boichard et al., 2016). En effet, il est difficilement envisageable d'éliminer systématiquement les individus porteurs d'anomalies génétiques récessives des groupes de reproducteurs potentiels, contrairement à ce qui a pu être envisagé dans le cas d'anomalies dominantes létales. En races bovines Montbéliarde et Holstein, respectivement 5 et 12 anomalies génétiques létales sont intégrées dans le choix des reproducteurs (Michot, 2017; Hoze et al., 2018). Pour cela, les index ISU des candidats porteurs d'anomalies récessives létales sont pénalisés en fonction de la gravité et de l'impact économique de la mutation (Hoze et al., 2018; Bérodier, 2020; cf partie 5.2.2). L'élimination systématique des reproducteurs porteurs d'anomalies récessives aurait pour conséquence de créer un goulot d'étranglement qui ferait chuter la diversité génétique dans la population (Howard et al., 2017). De plus, cette stratégie d'éradication s'applique seulement 'allèle par allèle', car il est impossible d'éliminer tous les allèles délétères du génome de cette manière. Contrairement aux ruminants, la truite arc-en-ciel est une espèce hyper-prolifique, les anomalies létales dans les premiers stades de vie n'ont donc que peu d'impact économique. Dans cette espèce, la pénalisation forte des reproducteurs portant certaines anomalies récessives létales lors du développement embryonnaire ne semble pas être une solution à privilégier car elle conduirait essentiellement à une baisse globale de la diversité génétique.

Une autre stratégie, basée sur le modèle proposé par Varona et al. (2019), permettrait de choisir les individus ayant une estimation de 'fardeau génétique' la plus faible possible et donc la plus favorable pour limiter les effets de dépression de consanguinité sur la descendance (Martinez-Castillero et al., 2021). Cette stratégie pourrait être appliquée dans les programmes d'amélioration génétique truiticole afin d'éliminer, non pas 'allèle par allèle', mais globalement les individus porteurs d'un fardeau génétique élevé.

5.3.3. Conservation d'un nombre minimal de reproducteurs

Afin de limiter l'érosion de la diversité génétique d'une génération à l'autre, Il faut s'assurer d'avoir un réservoir génétique suffisant, c'est-à-dire avoir un nombre suffisant de reproducteurs génétiquement variés, pour limiter le niveau de consanguinité dans la génération suivante. En effet, plus le nombre d'animaux sélectionnés pour la reproduction est faible, plus la taille efficace de la population décline et donc plus la diversité génétique de la population diminue rapidement au cours des générations.

Sur la base des recommandations faites par le FAO, il est conseillé de limiter l'accroissement de la consanguinité de 0,5 à 1% par génération (FAO, 2009). Cela nous permet d'estimer le nombre de reproducteurs minimal à conserver dans le stock de reproducteurs. Sur la base de la formule classique donné dans le Chapitre 1, on peut estimer un nombre de 25 paires de reproducteurs. Toutefois, Bentsen & Olesen (2002) ont montré, sur la base de simulations stochastiques d'une sélection massale sur 15 générations, qu'un minimum de 50 paires de reproducteurs devait être utilisé par génération afin de limiter l'accroissement de la consanguinité à 1% par génération. Cette différence peut tout simplement s'expliquer par le fait que la formule initiale sur une génération implique que les reproducteurs soient non apparentés. On peut cependant s'attendre à ce que le niveau d'apparentement des reproducteurs augmente au cours des générations, augmentant donc le nombre de paires de reproducteurs indispensable pour limiter l'accroissement de la consanguinité au sein de la population.

5.4. Les plans d'accouplement

Le choix des plans d'accouplement (croisements hiérarchiques ou factoriels) est la partie fondamentale d'un programme d'amélioration génétique pour former les bons croisements pour produire la génération suivante. Dans le programme de sélection d'une lignée pure, la gestion de la diversité génétique se fait majoritairement en limitant l'apparentement des reproducteurs utilisés dans le plan d'accouplement. Ainsi, dans les schémas de sélection truiticole, on limite l'accouplement d'animaux trop apparentés (cousins germains) (D'Ambrosio, 2020). La stratégie d'amélioration en croisement permet de valoriser la diversité génétique en optimisant les performances du produit final grâce aux effets d'hétérosis attendus, ainsi qu'à la bonne complémentarité génétique entre les reproducteurs des lignées utilisées dans le croisement.

5.4.1. Choix du plan d'accouplement

Que ce soit pour limiter l'augmentation de la consanguinité ou pour améliorer le gain génétique d'une génération à l'autre, Sonesson & Ødegård (2016) ont montré, en simulant des schémas de sélection aquacole, que l'utilisation d'un plan factoriel 10:10 à la place d'un plan 1:1 ou 1:2 (de type hiérarchique) était bien plus performant. Un plan factoriel 10:10 correspond à un croisement de 10 femelles avec 10 males, autrement dit, chaque femelle est croisée avec les 10 males et inversement. De plus, les plans factoriels 10 :10, avaient déjà été montrés plus efficaces que les plans d'accouplement hiérarchiques pour limiter l'augmentation de la consanguinité (Dupont-Nivet et al., 2006).

Les plans factoriels partiels constitués d'environ 10 blocs 10:10 sont les plans d'accouplement utilisés en France depuis plus de vingt ans dans les schémas de sélection de la truite arc-en-ciel pour croiser à chaque génération une centaine de reproducteurs mâles avec une centaine de reproducteurs femelles (D'Ambrosio, 2020). Un plan factoriel complet de 100 reproducteurs de chaque sexe est coûteux à entretenir, et les gains génétiques attendus du plan factoriel complet et du plan factoriel partiel sont similaires, à nombre total de reproducteurs constant (Dupont-Nivet et al., 2002, 2006). Ainsi, l'utilisation des plans factoriels en sélection est une méthode classique, facile à mettre en place chez la truite arc-en-ciel, permettant d'améliorer l'efficacité de la sélection, ainsi que de préserver la variabilité génétique de la population. Qui plus est, au sein des plans d'accouplement factoriels, par rapport aux plans d'accouplement hiérarchiques, un grand nombre d'individus est croisé, permettant d'exploiter

l'information génétique associée à des individus avec des degrés d'apparentement variés et à diverses combinaisons génétiques (pleins-frères et demi-frères) indispensables à l'estimation correcte des effets maternels et de dominance (Haffray et al., 2018).

5.4.2. Gestion de la consanguinité

L'apparentement des reproducteurs, estimé à l'aide de données sur pedigree, peut induire une forte limitation dans la gestion de la diversité génétique au sein des populations de truites arc-en-ciel. En effet, le pedigree parfois très incomplet dans les populations de truites arc-en-ciel peut conduire à une forte sous-estimation des apparentements et donc de la consanguinité réelle dans certaines populations. Il a été démontré que, dans le cadre de sélection génomique, la consanguinité doit être gérée sur la base d'informations génomiques plutôt que sur la base d'informations pedigree (Sonesson et al., 2012 ; Sun et al., 2013 ; Kardos et al., 2015 ; Ceballos et al., 2018; Doekes et al., 2021). En effet, l'apparentement calculé sur le pedigree ne prend pas en compte l'aléa de méiose, qui peut alors différencier deux pleins-frères (Kardos et al., 2015 ; Wang, 2016 ; Howard et al., 2017). Il est donc nécessaire de se baser sur des données d'apparentement génomique afin d'avoir une valeur 'vraie' d'apparentement entre deux individus. De plus, la localisation dans le génome de la consanguinité ne peut pas être identifiée sur pedigree. Or, cela peut grandement limiter la précision de la gestion de la consanguinité et de ses effets.

5.4.2.1. La localisation de la consanguinité dans le génome, une information clef

Les études réalisées dans cette thèse ont démontré que les estimations des effets globaux de la consanguinité ne représentent qu'une moyenne des effets de la consanguinité locale à l'échelle des génomes, avec peu d'effets significatifs malgré des effets parfois importants estimés localement (cf Chapitres 2 et 3, résultats annexe 3 et 4). Les 'vrais' effets de la consanguinité sont donc à estimer localement afin d'avoir une bonne vision des régions où la dépression de consanguinité sévit, ou, *a contrario*, un avantage a été identifié pour l'homozygote porteur d'allèles favorables. En comparant les traces de domestication/sélection observées dans quatre populations de truites, des signatures de sélection positive (avantage à

l'homozygote favorable), mais également de sélection équilibrante (avantage à l'hétérozygote) ont pu être identifiées comme communes à ces populations diverses. L'une étant notamment constituée d'un pool d'individus issus d'écloseries et rivières du Nord-Ouest des USA, et les trois autres, étant des populations françaises (cf Chapitre 4). Il est notable que parmi les 13 zones identifiées sous signature de sélection commune, 18 gènes avaient déjà été mentionnés dans des recherches de traces de sélection dans des espèces variées de vertébrés (bovins, ovins, chiens...). Ces traces de sélection semblent donc être liées à des avantages primordiaux pour assurer la *fitness* (développement embryonnaire, développement cellulaire, etc.) et la domestication (croissance, comportement, reproduction, immunité), qu'il s'agit donc de préserver (cf Chapitre 4).

C'est pourquoi, si l'on veut gérer précisément la consanguinité de nos populations de truites, la valeur globale de l'apparentement entre les reproducteurs n'est pas la seule information à considérer dans les programmes de sélection. La localisation de l'apparentement entre deux individus peut avoir un impact majeur sur la *fitness* de leurs descendants. De plus, l'impact de la consanguinité étant globalement variable entre les caractères, une caractérisation fine multi-caractère des effets de la consanguinité dans le génome de la truite est une étape essentielle avant d'être en mesure de la piloter dans les programmes de sélection.

Pour illustrer l'intérêt et l'impact économique que peut avoir une gestion locale des effets de consanguinité par rapport à une gestion globale, je vous présente différentes stratégies de gestion de la consanguinité au sein d'une population de truite sous sélection. Cet exemple est basé sur le nombre d'œufs produits par femelle, qui est un caractère pouvant être directement valorisé par les sélectionneurs français (la valeur d'un lot de 1000 œufs de truite peut être estimée à 12€, D'Ambrosio, 2020). Considérons ici que le nombre moyen d'œufs par ponte est de 4802 œufs et que les effets locaux de la consanguinité sur le nombre d'œufs sont ceux estimés dans le Chapitre 3. Dans le cas où, seuls l'effet global de la consanguinité est considéré (scénario 1), lorsque le coefficient de consanguinité moyen augmente de 0,10 point, la dépression de consanguinité conduit à une diminution de 49 œufs par ponte, soit une perte économique de 1%, c'est-à-dire à une perte de 0,59€/femelle. Imaginons ensuite deux cas de figures extrêmes : i) scénario 2 : la consanguinité supplémentaire se porte sur les chromosomes où elle est défavorable au nombre d'œufs par femelle ; ii) scenario 3 : elle se porte exclusivement sur les chromosomes où elle induit un effet positif sur le nombre d'œufs par femelle. Dans le scénario 2, une augmentation de 0,10 point de consanguinité induit une perte

de 323 œufs par ponte, alors que dans le scénario 3, l'augmentation de la consanguinité (+ 0,10 points) se traduit par une augmentation de 256 d'œufs par ponte, conduisant soit à une perte économique de 6,7% (perte de 3,88€/femelle) soit à un gain de 5,3% (gain de 3,07€/femelle).

Cela illustre clairement qu'une gestion des seuls effets de la consanguinité globale peut grandement sous-estimer la perte économique associée à la dépression de consanguinité (scénario 1 versus scénario 2). De plus, on peut observer qu'un levier d'amélioration des performances de production des œufs est envisageable grâce aux effets positifs d'une consanguinité localement bien choisie sur le génome. C'est pourquoi, il me semble essentiel de gérer les niveaux de consanguinité locaux dans les programmes d'amélioration génétique, notamment en introduisant le suivi des apparentements génomiques locaux dans le choix des accouplements.

5.4.2.2. Quelles sont les méthodes disponibles pour une gestion de la diversité génétique à l'échelle locale des génomes ?

Varona et al. (2019) proposent de gérer efficacement la consanguinité sans forcément se placer au niveau local en ajoutant un critère d'évaluation des reproducteurs, avec une valeur globale de 'fardeau génétique' estimée pour chacun d'eux (cf partie 5.2.2. Evaluation des effets de la dépression de consanguinité et des anomalies génétiques).

Toutefois, plusieurs approches basées sur l'Optimum Contribution (OC) permettent de gérer la consanguinité localement au niveau des génomes.

Gómez-Romano et al. (2016) proposent une gestion locale de la consanguinité avec une approche d'optimum contribution (Meuwissen, 1997). Pour cela, des coefficients d'apparentement locaux sont utilisés, via des matrices d'apparentement génomique, afin de choisir au mieux les accouplements, minimisant l'apparentement des reproducteurs dans certaines régions génomiques où la diversité génétique est essentielle. Pour chaque locus, la matrice d'apparentement génomique est construite de la manière suivante : si les deux individus partagent le même génotype, la valeur d'apparentement du locus sera de 1, sinon elle sera de 0.

Les matrices d'apparentement génomique peuvent être basées sur divers types d'informations génomiques : 1) l'évolution des fréquences alléliques (Meuwissen et al., 2011 ; Meuwissen et al., 2020), 2) l'état homozygote/hétérozygote d'un locus (Nejati-Javaremi et al., 1997 ; De Beukelaer et al., 2017), 3) les ROH (De Cara et al., 2013), ou 4) des segments IBD (Meuwissen et al., 2001 ; VanRaden, 2008 ; Meuwissen et al., 2020). Le choix du type d'information utilisée pour construire la matrice d'apparentement est important et pourra avoir un impact sur le résultat final de la gestion de la consanguinité d'une population (Meuwissen et al., 2020).

Meuwissen et al. (2020) proposent, tout comme Gómez-Romano et al. (2016), une méthode basée sur l'utilisation d'informations génomiques et dérivée de l'Optimum Contribution : Genomic OC. Cependant, ils observent que l'utilisation de matrices d'apparentement génomique basée sur l'information IBD est plus performante pour gérer la diversité génétique au cours des générations tout en maintenant un progrès génétique suffisant. De plus, pour gérer la diversité génétique, ils proposent d'utiliser deux matrices génomiques : une première comprenant l'information globale (valeur globale de l'IBD entre individus), et une seconde comprenant l'information des IBD locaux, permettant de gérer localement la diversité génétique. Cela permet donc de garder le contrôle sur l'évolution de la consanguinité globale de la population, tout en gérant également la diversité génétique locale dans les régions où elle a été identifiée comme essentielle.

5.4.3. Valorisation de l'hétérosis

La valorisation des effets génétiques de dominance, à travers le phénomène d'hétérosis (ou overdominance), peut améliorer significativement les performances des descendants. Cette valorisation engendre la création de génotypes hétérozygotes, ce qui réduit le niveau de consanguinité de la nouvelle génération.

5.4.3.1. Prise en compte des effets d'hétérosis dans un programme d'amélioration génétique en lignée pure

Dans le cadre de ma thèse, j'ai pu montrer qu'une part non négligeable de la variabilité phénotypique de la survie précoce des alevins, ainsi que des caractères liés à la taille et la reproduction des femelles d'une population commerciale de truites arc-en-ciel, étaient expliqués par des effets génétique de dominance (cf Chapitre 2 et 3). Ces effets de dominance mériteraient donc d'être exploités dans les plans d'accouplement des populations multiplicatrices afin d'augmenter la performance des descendants en production, mais également les performances de reproduction des parents. Cette stratégie limiterait également l'érosion de la diversité génétique dans les populations de truites (Wellmann & Bennewitz, 2012).

L'utilisation de la dominance permettrait aussi d'améliorer des caractères peu héritables, comme la survie des poissons (Chapitre 2). Pour rappel, les effets de dominance expliquaient entre 5 et 7% de la variance phénotypique pour des caractères de taille des truites, ce qui était relativement faible par rapport aux estimations obtenues pour les caractères de reproduction et de survie, pour lesquels nous avons estimé des proportions allant jusqu'à 22% de la variance phénotypique.

Plusieurs études, que cela soit pour des espèces terrestres (Toro & Varona, 2010 ; Sun et al., 2013 ; Aliloo et al., 2017) ou bien aquacoles (Fernández et al., 2021), exposent l'intérêt de valoriser les effets d'hétérosis dans les plans d'accouplement au sein des programmes d'amélioration génétique en lignée pure. Toro & Varona (2010) ont démontré par simulation (à partir de performances simulées sur la base d'une héritabilité comprise entre 20 et 40% et d'effets de dominance expliquant entre 5 et 10% de la variance phénotypique) qu'en considérant les effets de dominance lors de la gestion des accouplements, la réponse à la sélection était améliorée (+ 6 à 22%). Sun et al. (2013) montrent également que l'utilisation des effets de dominance, dans les programmes d'amélioration génétique en race pure (bovin), permet d'avoir des descendants avec de meilleures performances et cela malgré de faibles variances de dominance (expliquant seulement 4% de la variance phénotypique).

5.4.3.2. Prise en compte des effets d'hétérosis dans un programme d'amélioration génétique en croisement

Tout comme dans les schémas d'amélioration génétique des porcs et des volailles qui sont réalisés avec des croisements trois ou quatre voies (Sellier, 1976 ; Stock et al., 2020), on pourrait envisager au vu des effets de dominance estimés chez la truite arc-en-ciel, une stratégie de croisement de plusieurs lignées pour les populations multiplicatrices. La sélection sur les lignées paternelles serait sur la croissance, l'efficacité alimentaire et les qualités de découpe et de chair, alors que les lignées maternelles seraient elles-mêmes issues d'un croisement entre deux lignées grand-parentales permettant de valoriser l'hétérosis sur les caractères de reproduction et de survie des alevins. Cela permettrait d'augmenter le nombre et la survie des juvéniles en évitant les phénomènes de dépression de consanguinité (González-Diéguez et al., 2019, 2020). L'importance des effets de dominance estimés intra-lignée chez la truite arc-enciel est un indicateur de l'intérêt potentiel qu'il pourrait y avoir à valoriser les effets d'hétérosis à travers d'accouplements inter-lignées.

Cette stratégie permettrait d'augmenter de manière importante les performances dans les populations de production, c'est-à-dire la performance des alevins exportés par les entreprises françaises, ce qui augmenterait leur compétitivité. Toutefois, pour bénéficier d'effets d'hétérosis forts dans la population de production, il est nécessaire de croiser et donc d'entretenir au moins deux lignées paternelles et maternelles sélectionnées séparément, afin qu'elles soient génétiquement différentes. Il faut, cependant, éviter de croiser des lignées pures trop éloignées, car un croisement hybride entre lignées extrêmes peut conduire à une dépression hybride, c'est-à-dire à une valeur sélective de la descendance inférieure à celle des parents (Edmands, 2007). Ce phénomène, souvent observé dans des populations végétales, a été mis en évidence dans plusieurs espèces de poissons (Gharrett et al., 1999 ; Neff, 2004 ; Granier et al., 2011 ; Huff et al., 2011). Il est généralement dû à une rupture d'association de gènes coadaptés (phénomènes d'épistasie).

5.4.4. Purge du fardeau génétique

La purge du fardeau génétique, c'est-à-dire l'élimination des allèles délétères (Barrett & Charlesworth, 1991 ; Lande et Schemske, 1985), est une théorie selon laquelle, l'obtention de niveaux de consanguinité et de dérives élevés dans une petite population expose les mutations délétères à la sélection naturelle. Cela peut avoir deux conséquences : la diminution de la valeur sélective moyenne de la population par augmentation des phénomènes de dépression de consanguinité, ou la purge des mutations délétères. Dans les espèces hyper-fécondes comme les poissons, on peut imaginer organiser volontairement cette purge génétique en accouplant des reproducteurs très apparentés entre eux. Cette tactique permet de concentrer les allèles favorables dans la population d'alevins survivants. Toutefois, cette stratégie pour limiter les phénomènes de dépression de consanguinité à long terme est très délicate, car cela peut causer une perte de diversité génétique drastique et donc engendrer un risque élevé d'extinction de la population en l'absence de capacité évolutive suffisante (Hedrick, 1994 ;

Frankham & Ralls, 1998). Cette stratégie est donc associée à un risque non négligeable d'aboutir au résultat inverse de ce qui était initialement souhaité.

5.5. Gestion des déséquilibres de contribution des reproducteurs à la génération suivante

A la fin du programme de sélection, après la gestion des accouplements et de la fécondation, des verrous reproductifs généralement présents dans les espèces aquatiques très prolifiques peuvent conduire à une baisse de la taille efficace et donc de la diversité génétique de la population (Hedgecock & Pudovkin, 2011).

Nous avons pu voir dans l'étude du Chapitre 2, que les femelles, les plus petites et les plus fécondes, semblent produire des descendants plus résistants, créant ainsi un déséquilibre de contribution à la génération suivante entre reproducteurs sur la voie maternelle. Ces femelles ont significativement moins de mortalité dans leur descendance que les autres mères, et participent donc plus à la génération suivante, ce qui implique une baisse de la taille efficace de la population. La surmortalité dans certaines descendances maternelles pourrait être liées à des œufs de taille anormalement élevée et un nombre de malformations accrus, mais ce résultat n'est vraiment observé que sur la descendance d'une femelle extrême parmi les 15 femelles du plan d'accouplement expérimental.

Actuellement, dans les schémas de sélection de type PROSPER pratiqués dans les élevages de truites arc-en-ciel français, après la fécondation des ovocytes, un premier regroupement des œufs de taille similaire est effectué avant la sélection sur la taille des descendants qui se fera sur les alevins (Chevassus, 2004). Finalement, cette différence de mortalité des descendants entre mères semble être déjà prise en compte par cette méthode dans les populations de truites arc-en-ciel françaises. Notre étude a été réalisée sur une lignée non-sélectionnée de truites pour laquelle aucun tri sur la taille des œufs n'a été effectué. Cette différence pourrait expliquer la forte baisse de l'effectif efficace (N_e) de la lignée synthétique INRAE (D'Ambrosio et al., 2019), malgré le croisement d'un nombre important de parents et la quasi-absence de sélection volontaire.

Dans le cadre de la conservation de la lignée synthétique, mais également pour limiter l'érosion de sa diversité génétique, il faudrait, dans les premières semaines après la fécondation des œufs, élever les embryons par pool de taille d'œufs afin de limiter les effets maternels. Cela permettrait d'avoir une contribution similaire entre les femelles concernant le nombre d'alevins après l'éclosion, en lien direct avec le nombre d'individus à la génération suivante. Cependant, il ne faut pas oublier qu'un déséquilibre de contribution parental peut également subvenir bien après la fin de notre expérimentation, c'est-à-dire lors de la croissance des alevins. Une étude complémentaire pourrait être utile pour identifier si des déséquilibres de contribution surviennent ultérieurement dans le développement des alevins, pouvant participer à la perte de diversité génétique de la truite arc-en-ciel.

5.6. Que faire en cas de situation critique ?

Afin de s'assurer que les populations sous sélection ne passent pas sous un seuil critique de diversité génétique, pouvant conduire à l'extinction de la population, il est nécessaire de mettre en œuvre une surveillance génomique. Plusieurs indicateurs peuvent être employés à cet effet. Tout d'abord la mesure génomique de la taille efficace de la population, une baisse trop importante devrait alerter les sélectionneurs. D'autres indicateurs classiques de la diversité génétique, comme l'évolution des niveaux d'hétérozygotes observés et attendus (Ho/He), les niveaux de dépression de consanguinité observés, ainsi que l'évolution des fréquences alléliques pourraient également être utilisés pour surveiller l'évolution de la consanguinité des populations (Meuwissen, 2009 ; Flanagan et al., 2018). A l'échelle des espèces ou des races/lignées, il existe une mesure de la diversité selon Weitzman dont une étude a montré l'intérêt pour définir les stratégies de conservation de certaines races bovines en danger (d'Arnoldi et al., 1998).

En cas de situation critique, le sauvetage génétique est une des solutions permettant de lutter contre le déclin des petites populations (Hedrick, 2009, 2014 ; Whiteley et al., 2015). Le sauvetage génétique permet de restaurer de la diversité génétique en introduisant de nouveaux allèles favorables, pouvant répondre à de nouveaux objectifs de sélection ou simplement à des changements environnementaux. Un sauvetage génétique réussi permet une augmentation de la diversité génétique d'une population, une baisse de la dépression de consanguinité et induit généralement une augmentation de la taille efficace de la population concernée. Le matériel génétique à utiliser pour ré-introduire de la diversité génétique dans la population peut provenir d'une autre population in vivo, c'est-à-dire une population avec des individus actuellement 'vivant'. Il est également possible de réinjecter de la variabilité génétique dans les populations

en utilisant les gamètes cryoconservées d'animaux originaux (Doekes et al., 2018). Ainsi, un plan de sauvegarde génétique a été mis en œuvre il y a plus de vingt ans dans une race bovine française locale à très faible effectif, la Bretonne Pie-Noire, (Colleau et al., 2002).

Le matériel cryoconservé est une ressource précieuse pour gérer la diversité génétique des animaux domestiqués. En effet, si l'on considère du matériel génétique suffisamment éloigné des ressources génétiques des populations 'vivantes', l'apport d'allèles anciens éliminés et donc nouveaux pour la population peut être intéressant. La limite, qui se pose lors de la réintroduction de matériel cryoconservé ancien, est que généralement le niveau génétique de la semence cryoconservée depuis plusieurs années est bien inférieur à la valeur génétique de la population actuelle. Dans ce cas, l'utilisation de matériel cryoconservé peut induire une forte perte de la valeur génétique de la population. C'est pourquoi, le sauvetage génétique reste à ce jour très peu, voire pas utilisé dans les populations en sélection. De plus, il n'existe pas ou peu de recommandations et d'outils pour aider les sélectionneurs et gestionnaires des populations à choisir les meilleurs individus cryoconservés pour répondre à leurs objectifs de sélection. Pour pallier aux limites que pose le sauvetage génétique, que ce soit avec du matériel vivant ou cryoconservé, la génomique pourrait être utilisée en routine afin de choisir au mieux les individus originaux, permettant ainsi un sauvetage génétique efficace, tout en limitant la perte de niveau génétique dans la population. Ainsi, pour restaurer de la diversité génétique dans la lignée synthétique INRAE de truites arc-en-ciel à l'aide de semence cryoconservée, une approche inspirée du sauvetage génétique et de la méthode OCS a récemment été proposée au sein de l'équipe (Colon, 2022) à l'aide d'informations génomiques en quantités limitées. La stratégie de maintien de la diversité génétique sur le long terme proposée peut s'appliquer à faibles coûts humains et financiers aux autres lignées expérimentales, ainsi qu'à toutes populations commerciales où seules des actions ponctuelles de génotypage et cryoconservation de la semence seraient envisageables.

Conclusion

Pour conclure, comprendre l'impact et le rôle de la diversité génomique locale est essentiel afin de mieux la gérer dans les programmes de sélection, et ainsi maîtriser les compromis entre valeurs génétiques des reproducteurs et les effets indésirables de la consanguinité ainsi que de la perte de diversité génétique dans les populations sélectionnées. De plus, en raison de l'importance des effets de dominance observés, concevoir des programmes d'amélioration génétique en croisement serait une perspective intéressante à considérer pour améliorer les performances des cheptels de truite arc-en-ciel en production tout en protégeant la génétique créée par les sélectionneurs.

Development of a High-Density 665 K SNP Array for Rainbow Trout Genome-Wide Genotyping

We used preexisting variant datasets from USDA, a French commercial line and 30X-coverage whole genome sequencing of INRAE isogenic lines to develop an Affymetrix 665 K SNP array (HD chip) for rainbow trout. In total, we identified 32,372,492 SNPs that were polymorphic in the USDA or INRAE databases. A subset of identified SNPs were selected for inclusion on the chip, prioritizing SNPs whose flanking sequence uniquely aligned to the Swanson reference genome, with homogenous repartition over the genome and the highest Minimum Allele Frequency in both USDA and French databases. Of the 664,531 SNPs which passed the Affymetrix quality filters and were manufactured on the HD chip, 65.3% and 60.9% passed filtering metrics and were polymorphic in two other distinct French commercial populations in which, respectively, 288 and 175 sampled fish were genotyped. Only 576,118 SNPs mapped uniquely on both Swanson and Arlee reference genomes, and 12,071 SNPs did not map at all on the Arlee reference genome. Among those 576,118 SNPs, 38,948 SNPs were kept from the commercially available medium-density 57 K SNP chip. We demonstrate the utility of the HD chip by describing the high rates of linkage disequilibrium at 2-10 kb in the rainbow trout genome in comparison to the linkage disequilibrium observed at 50-100 kb which are usual distances between markers of the medium-density chip.

INTRODUCTION

Next-generation sequencing (NGS) has transformed the fields of quantitative, ecological and evolutionary genetics by enabling the discovery and cost-effective genotyping of thousands to millions of variants across the genome, allowing for genome-wide association studies (GWAS) of complex traits, genomic selection (GS) through accurate inference of relationships among individuals (Meuwissen and Goddard, 2010), inbreeding (Kardos et al., 2015), population

structure, and genetic diversity studies. Large numbers of densely genotyped individuals are required to get accurate results thanks to a high SNP density along the genome that constructs strong linkage disequilibrium between SNP and causative mutations (de Roos et al., 2008). However, regardless of the animal or plant species, it remains very challenging to cost-effectively genotype large numbers of individuals at polymorphic sites in all the genomes. An appealing strategy is to use a cheaper and reduced-density SNP chip with markers being chosen for optimizing the imputation accuracy to higher density genotypes. Genotype imputation describes the process of predicting genotypes that are not directly assayed in a sample of individuals (Marchini and Howie, 2010). Imputation has become a standard practice in research to increase genome coverage and improve GS accuracy and GWAS resolution, as a large number of samples can be genotyped at lower density (and lower cost) then imputed up to denser marker panels or to sequence level, using information from a limited reference population (Phocas, 2022).

Two main methods are employed for large-scale and genomewide SNP genotyping. Array-based methods use flanking probe sequences to interrogate pre-identified SNPs (often named "SNP chips"). The alternative genotyping-by-sequencing (GBS) methods call SNPs directly from the genome (Davey et al., 2011). In GBS methods, either restriction enzymes are used to target sequencing resources on a limited number of cut sites (Baird et al., 2008) or low-coverage whole genome resequencing is performed. Low-coverage GBS followed by imputation has been proposed as a cost-effective genotyping approach for human genetics studies (Pasaniuc et al., 2012), as well as farmed species (Gorjanc et al., 2017) that cannot afford a high development of genomic tools. Nevertheless, compared to GBS methods, SNP chips offer a robust and easily replicable way of genotyping samples at a consistent set of SNPs, with very low rates of missing data.

Medium (~thousands to tens of thousands of loci) and high (~hundreds of thousands of loci) density SNP chips have been routinely developed for commercial species to perform genomic selection (Meuwissen et al., 2001) and to identify genes playing significant roles in livestock and crop performances (Goddard et al., 2016). SNP chips developed for model organisms or farmed species have also been utilised to address evolutionary and conservation questions, in particular in animal populations. For example, they have been used to identify signatures of adaptation in cattle (Gautier et al., 2010) or genes under selection in grey wolves (Schweizer et al., 2016), characterize the genetic diversity and inbreeding levels in pig (Silió et al., 2013), sheep (Mastrangelo et al., 2014), cattle (Rodríguez-Ramilo et al., 2015) or fish (D'Ambrosio et al., 2019), and infer the genomic basis of recombination rate variation in cattle (Sandor et al., 2012) or sheep (Johnston et al., 2016; Petit et al., 2017).

While there is now over ten fish and shellfish species for which commercial SNP arrays had been developed (Boudry et al., 2021), most of those contain only about 50 to 60 K SNPs. Such medium-density chips are sufficient for genomic selection purposes but are clearly too low-density tools for fine QTL detection and help in identification of causal variants. As rainbow trout (*Oncorhynchus mykiss*) is a major academic model for a wide range of investigations in disciplines such as cancer research, toxicology, immunology, physiology, nutrition, developmental or evolutionary biology in addition to quantitative genetics and breeding (Thorgaard et al., 2002), it is important to get access to very high-density genomic tools for this salmonid species.

For rainbow trout, SNP discovery has been firstly done through sequencing of restriction-site associated DNA (RAD) libraries (Palti et al., 2014), reduced representation libraries (RRL) (Sánchez et al., 2009), and RNA sequencing (Sánchez et al., 2011). A first commercial medium-density Axiom[®] Trout Genotyping array (hereafter termed 57 K chip) has then been developed (Palti et al., 2015) and produced by Affymetrix (Thermofisher). Since then it has been largely used in population genetics studies (Larson et al., 2018; D'Ambrosio et al., 2019; Paul et al., 2021), GWAS and GS accuracy works for various traits in farmed populations (Gonzalez-Pena et al., 2016; Vallejo et al., 2017; Vallejo et al., 2019; Reis Neto et al., 2019; Rodríguez et al., 2019; Yoshida et al., 2019; Fraslin et al., 2019; Fraslin et al., 2020; Karami et al., 2020; D'Ambrosio et al., 2020; Blay et al., 2021a; Blay et al., 2021b). However, out of the 57,501 SNPs included in this chip, nearly 20,000 were found to be unusable because they were either duplicated due to the ancestral genome duplication or showing primer polymorphism in five French commercial or experimental lines (D'Ambrosio et al., 2019). Of the 57,501 markers from the original chip, 50,820 are uniquely localized on the Swanson reference genome (Pearse et al., 2019), and in the remaining number, only 38,332 markers pass the control quality filters [no primer polymorphism, call rate > 97%, Minor Allele Frequency (MAF) >0.001 over 3,000 fish from five French lines].

To overcome these limitations as well as to get access to a more powerful tool for GWAS and population genetics studies in rainbow trout, the aim of our study was to develop a highdensity SNP array. To develop this resource for rainbow trout, we made use of a large set of resequencing data from 31 doubled haploid (DH) lines from Washington State University (WSU) and Institut National de la Recherche pour l'Agriculture, l'Alimentation et l'Environnement (INRAE). In the United States, 12 WSU DH lines have been created by androgenesis (Young et al., 1996) while in France 19 DH INRAE lines (called isogenic lines) were produced by gynogenesis (Quillet et al., 2007). The 12 WSU DH lines as well as seven of the INRAE isogenic lines served as basic material for the variant search and SNP selection for the 57 K chip (Palti et al., 2015).

In this study, we describe how we overcame the limitations of duplications in the rainbow trout genome, in order to identify and locate polymorphisms. We describe the subset of detected SNPs that was selected for inclusion on a custom high-density SNP chip. It was used to genotype 463 samples from two different French commercial populations. We test the genotyping success rates, that is, the proportion of SNPs included on the array that are polymorphic and successfully genotyped. We demonstrate the utility of this SNP chip to infer linkage disequilibrium in the genome of this species.

MATERIALS AND METHODS

Use of the USDA Database for Initial SNP Detection

Gao et al. (2018) constituted a first large SNP database (USDA1) by performing high coverage whole genome resequencing (WGS) with 61 unrelated samples, representing a wide range of rainbow trout and steelhead populations. Of the 61 samples, 11 were doubled-haploid lines from Washington State University (WSU), 12 were aquaculture samples from AquaGen (Norway), 38 were from wild and hatchery populations from a wide range of geographic distribution (Califormia, Oregon, Washington and Idaho states in the United States; Canada; Kamtchatka Penninsula in Russia). Overall, 31,441,105 SNPs were identified with 30,302,087 SNPs located on one of the 29 chromosomes of the Swanson reference genome assembly (Omyk_1.0; GenBank, assembly accession GCA_002163495.1) (Pearse et al., 2019).

A second database (USDA2) with 17,889,078 SNPs coming from resequencing of 24 USDA samples was added to the initial USDA1 database. The samples were composed of 12 representatives from the USDA-NCCCWA odd-year class and 12 from the even-year class as previously described (NCBI BioProject PRJNA681179; Liu et al., 2021). The SNP discovery analysis followed the methods of (Gao et al., 2018).

By merging these two databases using BCFtools (Danecek et al., 2021), we constituted a single USDA database that contained 35,732,342 distinct SNPs, with 34,170,401 placed on the 29 chromosomes or mitochondrial chromosome of the Swanson reference genome. SNP filtering was performed to remove non bi-allelic variants and SNPs with MAF <1% using a vcf_filter.py homemade script (**Supplementary File S1**). The final USDA clean database contained 29,024,315 SNPs.

Whole Genome Resequencing of INRAE Isogenic Lines and Use of the INRAE Database for SNP Detection

Genomic DNA was extracted from fin clips of 19 rainbow trout INRAE isogenic lines. Whole-genome paired-end sequencing libraries were prepared and sequenced using the Illumina HiSeq 2000, Hi Seq 3000 or HiSeq X-Ten platforms at a depth of genome coverage ranging from 10X to 32X per sample. The 19 isogenic lines were sequenced in two batches that were processed successively. The first batch contained sequencing data from 12 samples (doubled haploid individuals) coming from 11 isogenic lines. The second batch contained sequencing data from 17 samples (doubled haploid individuals) coming from 17 isogenic lines (9 lines already sequenced in batch 1; and 8 lines not previously sequenced). Overall, 10 out of the 19 isogenic lines were sequenced twice. This resulted in a total of 8,911,630,867 paired reads with a median of 321,575,464 per sample.

Sequence reads from each of the 12 samples from the first batch were mapped to the Swanson rainbow trout reference genome (GenBank assembly accession GCA_002163495.1;

Pearse et al., 2019) using BWA MEM v.0.7.12 (Li, 2013). We then ran Samtools sort [v1.3.1, (Danecek et al., 2021)] to sort the alignment data by chromosome and scaffold locations. Afterwards, PCR duplicates were marked using Picard Tools (v.2.1.1, Broad Institute, 2019) MarkDuplicates. Variant calling was then performed for each sample using GATK (v3.7; al., 2010) HaplotypeCaller McKenna et (options -stand_call_conf 30 -mbq 10), leading to 12 vcf files. A variant reference file containing 1,207,861 high quality SNPs was generated by keeping variants with $QUAL \ge 1,050$ from the vcf files. This file was then used for the recalibration step, GATK BaseRecalibrator and PrintReads. using The recalibrated BAM files were then used as input for the variant calling step using GATK HaplotypeCaller in ERC GVCF mode. The resulting 12 GVCF files were then merged into a single vcf file containing 24,944,575 variants using GATK GenotypeGVCFs. The vcf file was then filtered as follows using GATK VariantFiltration: *DP* < 120; *MQ* < 30.0; *QUAL* < 600; *AN*<12. To filter out putative PSVs (Paralogous Sequence Variants), we filtered out variants with heterozygous genotypes in at least two of the 12 doubled haploid samples. The filtered vcf file from the first batch contained 11,113,836 variants.

The second samples sequence batch were analyzed following the same procedure as for the first batch with few updates. Prior to sequence alignment, sequences have been filtered using trimmomatic 0.36 (Bolger et al., 2014) to remove Illumina Truseq adapters, trim low quality bases, keep trimmed reads with a sufficient length and average quality. These parameters removed 3.8% of the reads, keeping 6,349,173,142 reads over the 17 samples. Alignment software was updated to use BWA MEM v.0.7.15. First calling to create a high quality variants set to recalibrate the BAM files was avoided by directly using the final vcf file from the first batch analysis. These recalibrated BAM have been submitted to GATK Haplotype caller as before to generate GVCF files. To increase confidence in the SNP calling, we also added 2 other SNP callers: Samtools mpileup and FreeBayes 1.1.0 (Garrison and Marth, 2012). GATK calling results were jointly genotyped using GATK GenotypeGVCFs on the 12 GVCF files from the first batch and the 17 newly generated GVCF files. This calling procedure resulted in 3 VCF files, one for each caller. Calling from GATK contained 29 samples (from the 19 isogenic lines, i.e., with 10 lines replicated) and 31,454,943 variants; Freebayes and Mpileup was used only on the second batch and contained 19 samples and 25,805,271 and 30,340,281 variants respectively.

The final step for variant calling was to intersect the 3 calling datasets using VCFtools_0.1.12a (Danecek et al., 2011), to keep only variants called by the 3 callers (genotypes kept were the GATK ones). SNP and INDEL were separated using GATK SelectVariants, and SNP were filtered with GATK VariantFiltration by following the GATK recommendations $(QD < 2.0 \parallel MQ < 40.0 \parallel FS > 60.0 \parallel SOR > 3.0 \parallel MQRankSum < -12.5 \parallel ReadPosRankSum < -8.0)$. This constitutes the INRAE1 variants dataset which includes 14,439,713 SNPs.



Using a vcf_filter.py homemade script to parse VCF file, INRAE1 dataset was filtered to keep only bi-allelic SNP localized on the 29 trout chromosomes or mitochondrial chromosome, fully genotyped for all 29 samples. As 10 isogenic lines were duplicated, we also checked genotype consistency and removed SNP with more than 1 isogenic line genotype discordance. Finally, we kept one sample per isogenic line (with the deepest sequencing) and filtered out SNP with more than 1 heterozygote genotype as they may represent duplicated genome regions. Among the 14,439,713 variants, we kept 10,286,009 SNPs (71.23%).

We merged them using BCFtools with a second dataset INRAE2, containing 14,478,077 SNPs called from 60 samples of a commercial line from "Les Fils de Charles Murgat" (Beaurepaire, France) and whose resequencing was described in Fraslin et al. (2020).

This merged dataset was filtered like the merged USDA dataset, to keep bi-allelic SNP localized on the 29 trout chromosomes of the Swanson reference genome or mitochondrial chromosome, with a MAF >1%. The final INRAE cleaned database contained 16,466,188 SNPs.

Merging the USDA and INRAE SNP Databases and SNP Preselection

A total of 32,372,492 distinct SNPs were selected for consideration for the HD chip, from a combination (BCFtools merge) of the USDA and INRAE databases (https://doi.org/10. 5281/zenodo.6657091).

An overview of the process to detect and select SNPs for inclusion on the array is provided in **Figure 1**.

SNPs were further filtered to be at least 50 base pairs from the closest identified SNP which resulted in a subset of 3,679,547 SNPs.

During vcf files merging, additional alleles may be added on shared variant positions and some variants previously removed from the INRAE dataset (on replicate discordance or high isogenic heterozygosity rate) may be reincluded. Thus, for a first SNP preselection, in addition to filtering SNPs with MAF $\geq 10\%$ in both the USDA and INRAE databases, we applied filters on bi-allelism variant and on a maximum number of 4 heterozygote INRAE isogenic lines.

Assessment included a check for duplicate flanking information suggesting repetitive elements, and an assessment of the complexity of the flanking sequence:

- Unicity of at least one side 35 bp-sequence for each SNP. This was done by blasting (default blastn parameters, Camacho et al., 2009) the 35 bp on the reference assembly genome and by checking that the best match was unique and located on the expected chromosome.
- 2) Trimming of each side 50 bp sequence if it contained more than 3 successive N. Variants were kept if at least the shortest trimmed sequence contained 20 bp and the other 50 bp (trimN.py homemade script, **Supplementary File S2**).

This first high-quality selection represented 633,405 SNPs. Trimmed flanking sequence each side of the SNP was extracted for all SNPs and formatted for Affymetrix (Thermo Fisher Scientific, United States) according to their specifications.

From this first submission to Affymetrix quality control, only 457,086 SNPs were qualified as recommended to be designable for the HD array and among them, only 351,755 were not ambiguous, meaning they were not of the type [G/C] or [T/A] that would require 4 probes instead of only two to distinguish the alleles.

To get sufficient recommended variants and to avoid the selection of markers that will use twice the space used by the others on the HD array, we decided to resubmit a large second set of variants to Affymetrix quality check. The same procedure was applied to produce a second more relaxed preselected set of SNPs by keeping SNPs with a MAF \geq 10% in the INRAE dataset only. This second preselection contained 533,637 additional SNPs. Among that additional set, 134,086 SNPs were specific to the INRAE dataset while the others were also present in the USDA dataset but with MAF below 10%.

We merged the first recommended set of 457,086 SNPs with this additional set of 533,637 SNPs. Then we removed all ambiguous SNPs of type [G/C], [C/G], [T/A] or [A/T]. Finally, densities were adjusted such that in regions with more than 30 SNPs retained per 100 kb by the previous filters, we only kept SNPs with MAF \geq 15% in at least one of the two INRAE or USDA databases.

This procedure resulted in a selection of 815,525 SNPs for the final submission in October 2020 to Affymetrix for assessment of the suitability of the SNPs for inclusion on a custom AXIOM 96HT SNP chip. Of the submitted SNPs, a total of 623,544 SNPs were deemed to be "designable" (recommended or neutral) in either the forward or reverse flanking sequence based on the Affymetrix pconvert score.

Keeping Informative Variants From the Medium-Density Axiom[®] Trout Genotyping Array

The INRAE and USDA research teams were willing to keep in the HD chip design the informative markers from the 57 K chip. Therefore 41,999 SNPs out of its 57,501 SNPs were designable in either forward and reverse directions and were kept for the HD chip design.

At the only exception of 8 specific SNPs, all the markers had a unique position on the Swanson reference genome and MAF > 5% in at least one French or North American population. Among them, 38,826 SNPs were also put on a 200 K chip that was built on 120 resequenced mostly "wild" genomes from over 40 locations from Russia, Alaska Canada down through Washington, Oregon and California (Ben Koop's personal communication).

Selection of SNPs for the HD-Trout SNP Chip

In total 664,531 SNPs corresponding to 701,602 probesets (some SNPs were tiled in both directions as both their forward and reverse flanking sequence was assessed to be neutral) passed the Affymetrix final quality control to be designed on the custom HD Axiom array. Only 40,987 of the 41,999 SNPs from the 57 K chip remained on the HD final design.

Among the selected SNPs, 664,503 were mapped on the 29 chromosomes of the Swanson reference genome (Figure 2), while 28 were positioned on the mitochondrial genome.

Based on the Swanson reference genome mapping, the average (median) SNP density on the chromosomes was 293 (324) SNPs per Mb (**Figure 2**), with SNP density varying from 2 to 774 SNPs per Mb. The average (median) inter-marker distance was 2.9 kb (1.3 kb). Maximum inter-marker distance was 243 kb and only 5.4% of inter-marker distance was over 10 kb (0.02% over 100 kb).

Single Nucleotide Polymorphism Mapping on the Arlee Reference Genome

Recently USDA/ARS (Gao et al., 2021) released a second reference genome assembly (USDA_OmykA_1.1; GenBank assembly accession GCA_013265735.3) for *Oncorhynchus mykiss* as long reads-based *de-novo* assembly for a second WSU DH line, named Arlee line, had been performed. Because Arlee lineage was closer from the INRAE isogenic lines (Palti et al., 2014) than Swanson lineage, it was decided to keep for further analysis only the SNPs that were mapped uniquely on one of the 32 chromosomes of this new reference genome.

Therefore, the 701,602 SNP probe flanking sequences of the HD chip were realigned to the new Arlee reference genome using BLAST (blastn with default task, i.e., megablast, and filtering options -evalue 1e-5 -perc_identity 95 -best_hit_overhang 0.1 -best_hit_score_edge 0.1).

SNP Validation

Given that the objective of our work was to get a powerful genomic tool with a large number of SNPs useful in diverse rainbow trout populations, we included fish from two French commercial lines that were genetically distinct from the lines used from the SNP discovery step.

We used fin samples collected from "Bretagne Truite" (Plouigneau, France) and "Viviers de Sarrance" (Sarrance, France) commercial lines, hereafter named LB and LC lines respectively, that were sampled for the FEAMP project Hypotemp (n° P FEA470019FA1000016). Pieces of caudal fin sampled from 463 fish (288 from LB line and 175 from LC line) were sent to Gentyane genotyping platform (INRAE, Clermont-Ferrand, France) for DNA extraction using the DNAdvance kit from Beckman Coulter following manufacturer instructions and genotyping using the newly constructed HD SNP array.

The first round of quality control was done by ThermoFisher software AxiomAnalysisSuiteTM with threshold values of 97% for SNP call rate and 90% for sample call rate. All the 288 individuals of the LB line passed the preliminary control, while 174 out of the 175 individuals from LC line passed the control quality. Following array hybridization and imaging, genotypes were called using default settings in the Axiom Analysis Suite software and exported from the software in PLINK (Purcell et al., 2007) format.



In addition, we used the WGS information of 20 samples sequenced in Gao et al. (2018)' study (with average genome coverage above ×20) to extract their genotypes for SNPs included in the HD chip and positioned on the Arlee reference genome (Gao et al., 2021; GCA_013265735.3). Those samples came from hatchery (Dworhak, L. Quinault, Quinault, Shamania) and wild (Elwha) populations from the North-West of United States (Four samples for each of the five populations) and were proved to be genetically close to each other and very distant from the Norwegian Aquagen aquaculture population (Gao et al., 2018). The idea was to infer and compare the level of linkage disequilibrium across the HD markers from wild/hatchery American populations and farmed French selected lines.

Allele Frequencies and Linkage Disequilibrium Across Populations

We then used PLINK v1.9 (www.cog-genomics.org/plink2) to calculate allele frequencies, filter SNPs at low MAF or individuals with high identity by descent (IBD) values and derive linkage disequilibrium (LD) measured as the correlation coefficient r2, using the mapping of the SNP probe flanking sequences to the Arlee genome.

Allele frequencies were calculated per population for each SNP. SNPs were then filtered to only those with a MAF \geq 5%, leaving 249,055 variants for American populations, 420,778 SNPs for the LB line, and 423,061 SNPs for the LC line. The set of individuals was also filtered using *"rel-cutoff*

0.12" to exclude one member of each pair of samples with observed genomic relatedness above 0.12, keeping 120 samples across populations, corresponding to 20, 45, and 55 individuals for American populations, LB and LC lines, respectively. Linkage disequilibrium (r2) between all pairs of SNPs on the same chromosome and at physical distances up to 1 Mb was then calculated using the PLINK options "--r2 --ld-window 50000 -ld-window-kb 1001 -ld-window-r2 0.0". The r2 values were binned into 2 kb units and per-bin averages calculated using R (R Core Team, 2019) for all chromosomes. The LD decay over physical distance up to 100 kb was then plotted in R.

RESULTS

SNP Identification and Characterization Based on the Swanson Reference Genome

Density of SNPs varied strongly from one chromosome to another with average SNP density per Mb ranging from 13,200 for Omy26 to 20,132 for Omy22. Across all chromosomes, the average SNP density per Mb was 16,483 SNPs (**Figure 3**). The Mb with the minimum density contained 451 SNPs while the Mb with the highest density contained 31,819 SNPs.

SNP identified in USDA or INRAE databases differed in terms of MAF distribution (**Figure 4**): 70% and 49% of SNPs had a MAF below 15% (40% and 15% had a MAF below 5%, respectively)





while only 9.5% and 18% of SNPs had a MAF above 35% in the USDA and INRAE datasets respectively.

HD Chip

Based on genotyping the 288 LB samples, 65.34% of markers were polymorphic, had individuals with all three genotypes, and passed Affymetrix filtering metrics in the Axiom Analysis Suite software to be categorized as "PolyHigh Resolution" variants. Of those that "failed" to be in that category, 15.35% passed filtering metrics but were monomorphic, 10.71% passed filtering metrics but the minor allele homozygote was missing, and the remainder 8.60% failed due to low call rates or other quality filters. The total number of best recommended markers was 91.81% corresponding to 610,115 SNPs out of the 664,531 genotyped variants.

Based on genotyping the 175 LC samples, 69.91% of markers were polymorphic, had individuals with all three genotypes, and passed Affymetrix filtering metrics in the Axiom Analysis Suite software to be categorized as "PolyHigh Resolution" variants. Of those that "failed" to be in that category, 5.63% passed filtering metrics but were monomorphic, 14.84% passed filtering metrics but the minor allele homozygote was missing, and the remainder 9.62% failed due to low call rates or other quality filters. The total number of best recommended markers was 90.86% corresponding to 603,768 SNPs out of the 664,531 genotyped variants.

Of the 664,531 SNPs which passed the Affymetrix quality filters and were included on the HD chip, 576,118 SNPs mapped uniquely on both reference genomes, and 12,071 SNPs did not map at all on the Arlee reference genome. **Supplementary Data S1** indicates both positions on the Swanson and Arlee reference genomes. Among those 576,118 SNPs, 38,948 SNPs were kept from the initial 57 K chip.

On the Arlee mapping (GCA_013265735.3), the average SNP density on the chromosomes was one SNP per 3.8 kb, or 266 SNPs per Mb. The median inter-marker distance was 1.5 kb with only 7% of the distances between successive



markers being above 10 kb. The largest gap was 4.16 Mb at the end of chromosome Omy6, the second largest gap was 2.94 Mb at the end of chromosome Omy10 and the third largest gap was 2.75 Mb at the end of chromosome Omy13 (**Figure 5**). Only five other gaps were above 2 Mb with values ranging from 2.3 to 2.5 Mb on chromosomes Omy7, Omy10, Omy15, and Omy21.

Finally, PLINK v1.9 software (www.cog-genomics.org/plink2) was used for a final SNP filtering based on keeping for further analysis SNPs with call rate above 95% and a deviation test from Hardy-Weinberg equilibrium (HWE) with a *p*-value < 10e-7 within each population. For LB line, 571,319 markers (474,937 being polymorphic) were kept after removing 1,136 miss genotyped SNPs and 3,663 ones with severe deviation from HWE. For LC line, 569,030 markers (487,940 being polymorphic) remained after removing 2,574 miss genotyped SNPs and 4,592 ones with severe deviation from HWE.

Regarding the American sequenced population, we extracted from the vcf files the genotypes for the 576,118 SNPs that were retained on the HD chip. Only 338,660 of those markers were polymorphic in the American population.

MAF Distribution in the Two French HD Genotyped Populations

Compared to variants called from sequence data, the MAF distribution of the HD selected SNPs was skewed to common alleles (**Figure 6**) with over 70% of SNPs with MAF above 5% in



each of the two populations, and over 20% of SNPs with MAF over 35% in both populations. Among polymorphic SNPs (MAF > 0.001), the average (median) MAF was 24.1% (23.6%) in the LB line and 23.0% (21.5%) in the LC line.

Linkage Disequilibrium Analysis

The median intermarker distance was 2 kb and the corresponding average r2 between neighbouring markers was 0.47, 0.44, and 0.36 in LB, LC, and American population, respectively. As expected, average r2 tended to decrease with increasing



population.

distance between pairs of markers in all populations studied, the most rapid decline being over the first 10 kb (**Figure 7**). Linkage disequilibrium was very high, with r2 reaching 0.42, 0.39, and 0.27 at the average intermarker distance (4 kb) for LB, LC, and American population respectively; at 50 kb distance, r2 average values were 0.32, 0.29, and 0.14 (**Figure 7**). At 500 kb, values were 0.25, 0.21, and 0.18 and values were still 0.22, 0.19, and 0.11 at 1 Mb, respectively for LB, LC, and the American population (**Figure 8**). However, those r2 values may vary strongly from one chromosome to another as shown on **Figure 8** for chromosomes Omy5 and Omy13 with respectively higher and lower linkage disequilibrium observed in comparison to the average values derived for all chromosomes.

DISCUSSION

In this study, based on the resequencing of tens of individuals from a diverse range of populations, we developed a high density (665K) SNP array that will be used for numerous applications, including genomic populations studies, GWAS or genomic selection. In fish, the first very high-density chip, named 930K XHD Ssal array, was developed for Atlantic Salmon using 29 fish from Aquagen lines and was a powerful tool to identify the key role of VGLL3 gene on age at maturity (Barson et al., 2015) or the epithelial cadherin gene as the major determinant of the resistance of Atlantic salmon to IPNV (Moen et al., 2015). A similar approach was used in Atlantic salmon with whole genome re-sequencing of 20 fish from three diverse origins to generate a catalogue of 9.7M SNPs that were then filtered to design a 200K SNP chip (Yáñez et al., 2016). A similar number of 9.6M SNPs were identified for the development of a 700 K SNP chip in catfish (Zeng et al., 2017). Recently, a set of 82 fish were collected from six different locations of China and re-sequenced to identify 9.3M SNPs to design a 600K SNP chip for large yellow croaker (Zhou et al., 2020).

Based on the resequencing of 85 samples by USDA and 79 samples by INRAE, we identified 32,372,492 SNPs that were variants (MAF \geq 1%) in either the USDA or the INRAE sets. More precisely, 29.0 and 16.4 million SNPs were identified in the USDA and INRAE datasets respectively for equivalent number of sequenced individuals. The higher number of SNPs detected in the USDA dataset probably resulted from the larger number of diverse populations included in the USDA dataset. The USDA database included 11 doubled haploid individuals and 50 individuals from 7 commercial, hatchery or wild populations, compared to the INRAE database that included 19 doubled haploid individuals derived from one experimental line and 60 individuals sampled from a single French commercial line. For comparison purposes, the influence of the numbers of sequenced individuals and populations or breeds on the number of identified SNPs can be exemplified in two largescale projects, the 1000 human genomes project and the 1000 bull genomes project. In the human genome, a pilot phase identified ~15 million SNP based on the WGS of 179 individuals from four populations (Altshuler et al., 2010); increasing the number of sequences to 2,504 coming from

26 populations across the world increased considerably the number of identified SNPs to 84.7 million (Auton et al., 2015; Fairley et al., 2020). Similarly, the first phase of the 1000 bull genomes project identified 26.7 million SNPs based on the resequencing of 234 bulls from 3 breeds (Daetwyler et al., 2014); again, the number of SNPs increased to 84 million by sequencing 2,703 individuals from 121 breeds (Hayes and Daetwyler, 2019). Another study in chicken highlights the importance of sequencing a diverse set of individuals to identify a large catalogue of SNPs: WGS of 243 chickens from 24 chicken lines derived from diverse sources lead to the detection of about 139 million putative SNPs (Kranis et al., 2013).

In this study, the average distance between two successive variants was 60 bp, indicating important polymorphism level in the rainbow trout genome. This is consistent with the average SNP rate over all chromosomes of one SNP every 64 bp previously reported by Gao et al. (2018) in the Swanson rainbow trout reference genome. Such short average distance between successive variants was a strong limiting factor to preselect SNPs to design the HD chip. Indeed, an important technical issue in SNP array design is that very high SNP densities can potentially cause allele dropout when genotyping due to interferences between polymorphism at the marker position and at the probe designs that have to be monomorphic sequences flanking the marker candidates. When searching for markers with inter-marker distance over 50 bp that could be considered in the HD array design, we could only retain 3.68M SNPs.

Across all chromosomes, the average SNP density per Mb was 16,483 SNPs, i.e., slightly higher than the ~15,600 SNPs per Mb reported by Gao et al. (2018), although density of SNPs varied strongly from one chromosome to another (from 13,200 for Omy26 to 20,132 for Omy22). Interestingly, the lower SNP densities on Omy26 was also described in Gao et al. (2018) and associated with a higher proportion of SNPs being filtered out as putative paralogous sequence variants (PSV), as this chromosome shares high sequence homology with other chromosome arms in the genome as a result of delayed rediploidization. Stronger variation in average SNPs density among chromosomes has been reported previously in chickens (Kranis et al., 2013) and humans (Zhao et al., 2003), with average value of 78 and 83.3 SNPs per kb across the genome but with some chromosomes having only 3 (on chromosome Z) and 2 (on chromosome Y) SNPs reported per kb respectively.

There was also a heterogeneous distribution of SNPs along the chromosomes, with a minimum density per Mb as low as 451 SNPs, and a maximum of 31,819 SNPs. Areas with less SNP density generally located at the telomeric parts or the centromeric parts (for metacentric chromosomes) of some chromosomes (e.g., Omy13 and Omy14) (**Figure 3**). Such heterogeneous distribution of SNPs has been previously reported in Eukaryotes, with potential explanations including heterogeneous recombination across the genome. It has been reported in a meta-analysis in eukaryotes that "heterogeneity in the distribution of crossover across the genome is a key determinant of heterogeneity in the distribution of genetic variation within and between populations" (Haenel et al., 2018). One broad-scale and general pattern observed within chromosomes is a lower recombination rate around centromeres

(Stapley et al., 2017) and higher rates at the telomeric parts (Sakamoto et al., 2000; Anderson et al., 2012). Because higher recombination rates are observed in telomeric than centromeric regions of chromosomes, a higher number of variants may be expected in the telomeres. However, in general, the telomeres have very long patterns of repeats which generate problems in reads mapping. In the centromeric regions, it is unclear whether or not suppressed recombination is linked to highly repetitive regions (Talbert and Henikoff, 2010). Last but not least, the complexity of the rainbow trout genome with its recent whole genome duplication and partial rediploidization, and patterns of tetrasomic inheritance (Pearse et al., 2019), can potentially explain the difficulties to sequence and assemble some parts of its genome and hence detect SNPs. In a recent paper, Gui et al. (2022) have reported several phenomena (such as massive sequence divergences, extensive chromosome rearrangements, large-scale transposon bursts) occurring during the polyploidization and rediploidization that could explain the difficulties in assembling the complex genomes of Salmonids and other tetraploid fish species. Indeed, rainbow trout has a high content (57.1%) of repetitive sequences (Pearse et al., 2019), similar to the 59.9% reported for Atlantic salmon (Lien et al., 2016).

Taking advantage of the biological characteristics of fish (external fertilization and embryonic development, viability of uniparental progeny), isogenic lines have been generated in some fish species (reviewed in Franěk et al., 2020), by either gynogenesis (Quillet et al., 2007) or androgenesis (Young et al., 1996) in rainbow trout. Both USDA and INRAE datasets included the sequencing of 11 and 19 doubled-haploid individuals respectively from 30 different isogenic lines. This number, quite large and unique in fish, makes it possible to take advantage of both the within-line characteristics (homozygosity, isogenicity) and between-line variability. In particular, rainbow trout isogenic lines are being used for the development of genomic tools: the trout genome is the result of a whole genome duplication event that occurred about 96 Mya ago (Berthelot et al., 2014). Therefore, many genomic regions remain in a pseudo-tetraploid status, which complicates sequence assembly and development of genetic markers because of the difficulty to distinguish true allelic variants from PSVs. Therefore, homozygous individuals were used to produce the first genome sequence and reference transcriptome (Berthelot et al., 2014), subsequent improved genome assemblies (Pearse et al., 2019; Gao et al., 2021), and also to validate the large set of SNPs used in the first 57K SNP chip (Palti et al., 2014, 2015). In the present study, as in Gao et al. (2018), putative PSVs were filtered out by using information from the isogenic lines' genotypes, in order to generate a comprehensive catalogue of reliable SNPs in rainbow trout and then filter out SNPs to be included onto the HD SNP chip.

The 665 K SNP chip was designed based on the Swanson reference genome (Pearse et al., 2019). Only 576K SNPs were uniquely positioned on the Arlee reference genome, which led to a few gaps over 1 Mb based on this reference genome (**Figure 5**) while there was no gap over 250 kb on the Swanson reference genome (**Figure 2**). Genetic and genomic differences between the Swanson and Arlee lines have previously been studied (Palti et al., 2014). It is also known that the two lines differ in their chromosomes' numbers, the Swanson line having 2N = 58 with 29 haploid chromosomes (Phillips and Ráb, 2001) and the Arlee line 2N = 64 with 32 haploid

chromosomes (Ristow et al., 1998). This is not surprising as there are some variable chromosome numbers in rainbow trout populations, associated with Robertsonian centric fusions or fissions, as for instance fission splitting metacentric chromosome 25 observed in Swanson genome into two acrocentric chromosomes in French lines (Guyomard et al., 2012; D'Ambrosio et al., 2019). Depending on the rainbow trout populations, the number of haploid chromosomes (N) varies from 29 to 32 and evidence suggests that the redband trout with 2N = 58 is the most ancestral type (Thorgaard et al., 1983). In the Arlee karyotype the haploid chromosome number is 32 because chromosomes Omy4, Omy14, and Omy25 are divided into six acrocentric chromosomes (Gao et al., 2021). Note that Arlee chromosomes Omy30, Omy31, and Omy32 correspond to the p-arms of, respectively, Omy4, Omy25, and Omy14 on the Swanson genome.

The 664,531 SNPs successfully genotyped on 463 individuals across two French commercial populations represent a valuable tool for ongoing genomic studies on the genomic architecture of traits, the population evolution history and genetic diversity as well as for the assessment of inbreeding and the genetic effects of management practices in farmed populations. The quality of our new HD chip compared very well with other HD chips developed for salmonid complex genomes. Indeed respectively 90.9% and 91.8% of SNPs were validated in LB and LC samples as high quality based on clustering properties, while corresponding values given for Coho salmon array (Barría et al., 2019) and Atlantic salmon (Yáñez et al., 2016) were 82.5 % and 79.6% for 200 K Affymetrix Axiom myDesign Custom Arrays. The HD chip is a powerful genomic tool that allow not only to have on average all along the genome a very high density of markers in comparison to the 57 K chip, but also to significantly reduce the number of large gaps (>1 Mb) in the genome coverage. In particular, the extremely low coverage at the telomeric parts of most of the chromosomes or at the centromeric part of metacentric chromosomes have been drastically reduced and the 2 regions spanning over 10 Mb each without any markers on Omy13 (see Supplementary Figure S1) have been drastically reduced, leaving just a large gap of 2.75 Mb at the end of Omy13 on the Arlee reference genome. This remaining gap is likely due to the fact that the entire chromosome Omy13 shares high sequence homology with other chromosome arms due to delay in re-diploidization (Gao et al., 2018). The next step will be to develop a new medium-density SNP array for rainbow trout keeping the 39K SNPs present on both the HD chip and the initial 57 K chip, but adding about 25 K SNPs of the HD chip to fill the large gaps without any SNP of the 57 K chip. This second version of the medium-density chip will be a very useful tool both for genomic selection and for cost-effective GWAS thanks to imputation to HD genotypes.

In our study, we illustrate the interest of the HD chip based on LD study across three different rainbow trout populations. The analysis of LD plays a central role in GWAS and fine mapping of QTLs as well as in population genetics to build genetic maps, to estimate recombination rates or effective population sizes as the expected value of r^2 is a function of the parameter 4Nec, where c is the recombination rate in Morgan between the markers and N_e is the effective population size (Sved, 1971). The decay and extent of LD at a pairwise distance can be used to determine the evolutionary history of populations (Hayes et al., 2003; Santiago et al., 2020). Lines LB and

LC had the highest LD values in comparison to the American hatchery population (HA), potentially indicating lower effective population sizes in the French selected lines. The lower LD values in the American population may be partly linked to stratification in the sampled population gathered from diverse rivers, but however it helps to quantify the lower bound LD values at short distance that we may expect in hatchery populations. The higher than average LD observed on Omy5 is likely caused by a large chromosomal double-inversion of 55 Mb (Pearse et al., 2019) which prevents recombination in fish.

In rainbow trout farmed populations, the level of strong LD $(r^2 > 0.20)$ spans over 100 kb (D'Ambrosio et al., 2019) to 1 Mb (Vallejo et al., 2018; Vallejo et al., 2020). While a number of studies quantify in salmonids the presence of long-range LD from 50 kb to over 1 Mb either for commercial populations (Kijas et al., 2017; Vallejo et al., 2018; Barría et al., 2019; D'Ambrosio et al., 2019) or wild populations (Kijas et al., 2017), little is known on the LD at very short distances. Barría et al. (2019) indicated a maximum value of 0.21 in a Chilean Coho selected line for marker distance lower than 1 kb and a threshold value of r2 =0.2 reached at approximately 40 kb. In Atlantic salmon, r2 =0.2 was reached at approximately 200 kb in a Tasmanian farmed population coming from a single Canadian river without any further introgression (Kijas et al., 2017). In the Tasmanian salmon population, the average LD value for markers separated by 0-10 kb was 0.54 while the corresponding average LD value was only 0.04 in a Finish wild population (Kijas et al., 2017). Previous LD estimates at short distance in French rainbow trout lines ranged from 0.30 to 0.39 at an average distance of 10 kb based on a small set of markers distant from 0 to 20 kb (D'Ambrosio et al., 2019). No LD estimates at inter-marker distances below 10 kb could be reasonably derived in rainbow trout based on the 57 K chip.

In our study, regardless of the rainbow trout populations, the LD values at very short distances between markers (≤10 kb) were moderate (0.44-0.47 at 2 kb and 0.34-0.38 at 10 kb, respectively for LC and LB) compared to the ones observed at similar distances in cattle breeds (Hozé et al., 2013) where r2 values were around 0.70 at 2 kb and in the range 0.50-0.55 at 10 kb whatever the breeds considered. This may be partly due to higher recombination rate in rainbow trout (1.67 cM/Mb; D'Ambrosio et al., 2019) than in cattle (1.25 cM/Mb; Arias et al., 2009), but it also indicates that the founder populations of rainbow trout farmed lines have presumably larger ancestral effective population sizes than cattle breeds. On the contrary, for marker distances over 100 kb, LD values decrease below 0.20 in cattle breeds, while average LD values are still 0.26-0.30 in LC and LB lines, respectively. This indicates stronger recent bottlenecks and selection rates in rainbow trout lines than in cattle breeds. Similar long-range LD was independently observed in two US commercial rainbow trout populations (Vallejo et al., 2018; Vallejo et al., 2020). The pattern of LD decay in rainbow trout commercial lines appears to be more similar to the one observed in conservation flocks of chicken from South Africa (Khanyile et al., 2015), with very similar values reported both at shorter distances than 10 kb, as well as at 500 kb distance where LD

values range from 0.15 to 0.24 depending on the conservation flocks and values of 0.21-0.25 were derived for LC and LB, respectively. A last factor that may contribute to this long-range LD in rainbow trout is the high crossing-over interference in males observed when plotting the linkage map distance between markers from the male vs. female linkage maps against the physical distance in base pairs. Sakamoto et al. (2000) have reported a 3.25:1 female to male linkage map distance ratio and Gonzalez-Pena et al. (2016) indicates that female/male recombination ratios were above 2.0 in all the 13 chromosomes known to have homologous pairing with at least one other chromosome arm, while in most of the nonduplicated chromosomes the ratio was generally lower. Because such high crossing-over interference in males were observed in families generated from sex-reversed XX males, we hypothesize that there must be a mechanism that is controlling meiosis in the sperm differently than in the eggs through a different regulation of gene expression not related to presence or absence of the sdY gene.

We have demonstrated in this paper a substantial linkage disequilibrium between neighboring markers, suggesting the density of genotyped SNPs is well-designed to accurately tag most areas of the rainbow trout genome. We acknowledge that, by design, the minor allele frequency distribution of genotyped SNPs is skewed to common alleles, and variation has been predominantly sampled from common SNP shared by both French and North American farmed populations. While this may limit some analyses, we believe that the array will be an invaluable genomic resource for ongoing work investigating genetic diversity, genetic architecture of traits and adaptive potential in world-wide rainbow trout populations.

<u>Résultats</u> Annexe 3 : Effets de la consanguinité chromosomique sur les performances de production d'une lignée de truite arc-en-ciel française.

Dans le chapitre 3, nous avons étudié les effets de la consanguinité sur les performances de taille et de reproduction de truites arc-en-ciel françaises. Cette annexe a pour but de compléter l'étude en évaluant les caractères de production subissent également des phénomènes de dépression de consanguinité. Les caractères étudiés ont été le poids à l'abattage (BW, à $\sim 17/18$ mois), la taille (FL), le poids éviscéré (GCW), le poids étêté et éviscéré (HGCW) et la surface du tissu adipeux de la darne (ATA).

Matériel et Méthodes

a) <u>Population</u>

Pour cette étude nous avons utilisé une population de 2740 poissons, réparties en deux générations (1316 issus de la cohorte G9 et 1424 issus de la cohorte G10). Tous les individus ont été génotypés avec la puce moyenne densité Axiom 57k, dans le cadre du Projet SG-Truite no. RFEA47 0016 FA 1000016 et 57k-Truite (No. 2015-0638). Ici c'est l'assemblage de référence Swanson qui a été utilisé, c'est pourquoi nous étudions les effets de la consanguinité sur 30 chromosomes.

Après les tri qualités classique (snp_genotypés > 90% ; call_rate > 97%, MAF > 1% et écart non extrême aux fréquences de l'équilibre d'Hardy-Weinberg avec un seuil de p-value > 10^{-5}), 32 013 SNPs sont conservés pour l'analyse.

b) Estimation de la consanguinité globale et locale

A l'aide de la function 'homozyg' du logiciel Plink v1-09 (avec les mêmes options que celles décrites au chapitre 3), le calcul des ROH a été effectué, ainsi que du coefficient de consanguintié global. Puis, le calcul des coefficients de consanguinité locaux a été effectué pour chaque chromosome de la manière suivante :

 $F_{Omyk,i} = \frac{\sum_{k} Taille(ROH_{k,i})}{LRegion_{k}}$

où $\sum_{k} Taille(ROH_{k,i})$ est la somme des longueurs des ROHs du chromosome k porté par l'individu i . *LRegion_k* est la taille totale de la region considérée.

c) Estimation des effets de la consanguinité globale et locale

Modèle globale à décrire tout d'abord

Pour estimer les effets de la consanguinité locale sur les performances y de production des individus, le modèle GBLUP suivant a été réalisé :

$$y = X\boldsymbol{\beta} + Z\boldsymbol{a} + \sum_{r=1}^{30} b_r \boldsymbol{F}_r + \boldsymbol{e}$$

Où $\boldsymbol{\beta}$ correspond au vecteur de l'effet de la generation; pour les caractères GCW et HGCW une covariables sur le poids (BW) a été prise en compte; pour le caractère ATA, la covariables 'Surface de la Darne' a été prise en compte.

Ensuite nous avons a et e les vecteurs des effets aléatoires des valeurs génétiques additives et des résidus. La matrice génomique G a été construite à l'aide du programme *parallelef90* (Vitezica et al., 2016).

Les coefficients de régression b_r de y sur les vecteurs F_r rendent compte des effets de consanguinité le long du génome (pour cela on considère les 30 chromosomes).

NB: Dans ce modèle, lorsque nous ajoutons l'estimation des effets de dominance (avec les 30 vecteurs F_r rendant compte des effets de la consanguinité le long du génome), notre modèle ne converge pas, il semble que dans ce cas, la structure des données ne permettent pas d'estimer les effets de dominance.

Résultats

Dans la population étudiée les niveaux de consanguinité globaux sont en moyenne de 19% (les valeurs minimale et maximale étant de 1% et 32%). Tout comme dans notre étude sur les effets locaux de la consanguinité chapitre 3, l'estimation des effets chromosomiques ensemble est plus précis et est meilleur modèle (selon les valeurs des AIC dans la **Table Annexe 2.1**).

Si l'on considère l'effet de la consanguinité globale, hormis pour ATA, une dépression de consanguinité entre -0,1% à 1,91% est estimée (**Table Annexe 2.2**). Les effets globaux de la consanguinité ne sont pas significatifs, tout comme la plupart des caractères de reproduction (cf Chapitre 3), c'est pourquoi il nous semble essentiel d'estimer les effets locaux de la consanguinité.

Pour chacun des caractères étudiés, au moins un chromosome parmi les 30, a un effet significatif de la consanguinité (**Figure Annexe 2.1**). Ces effets peuvent être positif ou négatif, ce résultat est très similaire à ce que nous avons pu observer dans le chapitre 3 sur les caractères de reproduction de la truite arc-en-ciel.

Si l'on se place à l'échelle globale, on n'observe pas d'effet significatif de la consanguinité. Qu'en est-il localement ?

A l'échelle du chromosome, nous observons que la consanguinité présente dans au moins un chromosome a un effet significatif sur une des performances de production. Les effets de la consanguinité sur le poids à l'abattage (BW) sont plus important (positifs et négatifs) par rapport aux autres caractères. La consanguinité de quatre chromosomes (omy7, omy12, omy13 et omy25) a un effet significatif sur le poids à l'abattage. D'autres performances comme GCW ou HGCW ont des effets de la consanguinité certes très faibles mais significatifs (omy3, omy12, omy22, omy27 et omy30).

Conclusion

Tout comme pour les caractères de reproduction, des effets significatifs de la consanguinité locale (à l'échelle du chromosome) ont pu être observé pour des caractères de production. En toute logique on pourra s'attendre à identifier d'autres effets significatifs de la consanguinité dans les régions au sein de chaque chromosome. La dépression de consanguinité n'est donc pas uniquement liée aux caractères de reproduction mais peu également toucher les caractères de production des truites.

<u>Résultats Annexe 4 :</u> Effets locaux de la consanguinité sur la survie du stade œillé jusqu'à trois semaines après la première alimentation dans la lignée synthétique INRAE.

Dans le chapitre 2 de cette thèse, nous nous sommes concentrés sur l'identification des verrous reproductifs qui pouvaient influencer la survie des descendants de chaque reproducteur. Nous avons ainsi pu estimer les paramètres génétiques du caractère de survie du stade œillé jusqu'à trois semaines après la première alimentation. La survie n'était affectée ni par le niveau de consanguinité globale des individus, ni par celui de leurs parents. Toutefois, la consanguinité locale peut-elle avoir des effets significatifs sur la survie des individus ? De plus, peut-on relier les régions ne contenant aucuns ROHs (cf Chapitre 4) communes aux quatre populations de truites arc-en-ciel (adultes) avec des effets de la consanguinité locale sur la survie embryonnaire ?

Matériels et Méthodes

a) Les animaux et génotypage

La même population issue de la lignée synthétique INRAE que celle utilisée dans les travaux du chapitre 2 a été considérée, soit 860 embryons/alevins phénotypés et génotypés avec 32 725 SNPs conservés pour l'analyse après contrôle qualité. Ici c'est l'assemblage de référence Arlee qui a été utilisé, c'est pourquoi les analyses ont été effectuées sur la base de 32 chromosomes.

b) Estimation de la consanguinité locale

Sur la base des ROH identifiés dans le chapitre 2, le calcul des coefficients de consanguinité locaux, dans des régions r de 10Mb sur le chromosome k, a été effectué de la manière suivante:

$$F_{Omyk_r,i} = \frac{\sum_{k_r} Taille(ROH_i)}{LRegion_{k_r}}$$

où $\sum_{k_r} Taille(ROH_i)$ est la somme de la longueur des ROHs d'un individu i dans la region k_r. *LRegion_{k_r}* est la longeur totale de la région considérée.
c) Modèle linéaire BLUP - effets de la consanguinité locale

Pour estimer les effets de la consanguinité locale sur la survie des individus du stade œillé jusqu'à trois semaines après la première alimentation, le modèle GBLUP suivant a été utilisé pour décrire la performance y (vivant (prend la valeur 0) ou mort (prend la valeur 100)) :

$$y = X\beta + Za + Wd + Zc + \sum_{r} b_{r}F_{r} + b_{sire}F_{sire} + b_{dam}F_{dam} + e$$

Où β , *a*, *d*, *c* et *e* sont respectivement les vecteurs des effets fixes environnementaux (incubateur), des effets aléatoires des valeurs génétiques additives, des effets de dominance, des effets communs dus à la combinaison mère x incubateur, et les résidus. **X**, **Z** et **W** sont les matrices d'incidence pour β , *a et d*. Les vecteurs *a* et *d* contiennent les valeurs génétiques additives et de dominances des 860 individus phénotypés et génotypés relies par la matrice de relation additive génomique F et la matrice de relation de dominance D. Les matrices génomiques **G** et **D** ont été construite à l'aide du programme *parallelef90* (Vitezica et al., 2016).

Les coefficients de régression b_r de y sur les vecteurs des niveaux de consanguinité locaux F_r rendent compte des effets de consanguinité le long du génome. Pour cela on considère soit les 32 chromosomes, soit les n_k régions qui correspondent à 31 chromosomes entiers + 1 chromosome 'découpé' en régions de 10Mb. Par exemple, si on choisit de 'découper' le chromosome 13 en 5 régions égales, alors $n_k = 31 + 5 = 36$.



Résultats

Les effets de la consanguinité chromosomique sur la survie des individus lorsque le coefficient de consanguinité d'un individu augmente de 0,10 unité (exemple : F = 10% -> 20%), sont présentés en Figure annexe 3.1. Comme démontré dans le chapitre 3, malgré un effet de la consanguinité globale non significatif (cf Chapitre 2), la consanguinité locale peut avoir des effets significatifs, soit négatifs (chromosomes 4, 11, 26, 30, 32), soit positifs (chromosomes 6, 9, 21, 22, 23, 27).

En zoomant sur les larges régions génomiques non-consanguines (c'est-à-dire sans ROHs) partagées des chromosomes 10, 13 et 19 (cf Chapitre 4). On s'aperçoit que pour les régions concernées (r6_omy10 ; r5_omy13 ; r2_omy19) la consanguinité (identifiée au sein de région de 10Mb) ne semble avoir aucun effet significatif sur la survie des individus.

Conclusion

Nous avons pu voir que la consanguinité locale a des effets variables et significatifs le long du génome sur le caractère de survie précoce. De plus si l'on regarde plus précisément les effets de la consanguinité des régions ne contenant pas de ROHs (populations adultes) identifiées dans le Chapitre 4 de cette thèse, on peut voir que la consanguinité ne semble pas avoir d'effet sur la survie embryonnaire.

Toutefois, ici nous ne regardons que la survie précoce, alors que la détection des régions nonconsanguines a été réalisée sur des populations de truites adultes. L'élimination des génotypes homozygotes défavorables (consanguins) de ces différentes régions pourrait survenir soit avant le stade embryonnaire, soit après l'installation du stade trophique (c'est-à-dire après 3 semaines après la première alimentation.
